Another group of schools just missed an "A" by a few points. Projections have Apopka and Clay Springs elementary schools reaching the goal this spring. Principals Lukeshia Miller and Patricia Weisbach are leading their schools to success. Lakeville Elementary and Prairie Lake earned "B" grades which is considered high performing and admirable. This was an improvement for these two schools led by Cynthia Swanson and Dr. Robert Strenth. I was pleased with their gains and continuous improvement model.

Dream Lake and Rock Springs, led by Carole-Ann Clenton-Martin and Nathan Hay, also have potential to move up from their current "C" grades. It is important for children to arrive at school having completed a high quality pre-kindergarten, as students are expected to read and write by year end.

Community groups that offer English as a second language for parents is extremely helpful.

Our schools with nearly 100 percent of their students on free and reduced lunch provide the greatest challenge. Three schools – Lovell, Wheatley, and Zell-

wood – all achieved "C" grades last year. None of these schools are in the group of lowest performing schools that require supervision by the School Transformation Office. Principals Mr. Aguirre, Dr. Atkinson and Mr. Mattucci are very effective. Their campuses are inviting and friendly. Teachers and students are all engaged in learning.

Sometimes, a helping hand is needed with the harsh demands of life. We must promote high expectations while offering additional supports. Success is happening in every school. We need to recognize and praise it.

ional Geographic News headlined a story with, "Mars Melt Hints at Solar, Not Human Cause for Warming, Scientists Say."

And, a press release in February from the Keck Observatory in Hawaii was headed with, "Saturn's Strange Hot Spot."

Another release headline from M.I.T. in 1998 stated, "M.I.T. Researcher finds Evidence of Global Warming on Neptune's Largest Moon." This evidence was gathered from a Voyager space probe fly-by in 1989. (This was six years before the Kyoto Krackpot Conference.)

A report from Space.com in October 2002 states, "Global Warming on Pluto Puzzles Scientists." The article leads with: "Astronomers today said Pluto is un-

dergoing global warming in its thin atmosphere even as it moves further away from the sun on its long odd-shaped orbit."

Bethell saves the "big one" for the last planet on a headline from USA Today of May 2006 – "New Storm on Jupiter Hints at Climate Change." The main thrust states, "The latest images could provide evidence that Jupiter is in the midst of global climate change that can modify temperature by as much as 10 degrees F. on different parts of globe."

In addition to orbiting the sun at various distances, these planets all share characteristics that they don't have with our planet Earth. None of them has any human or animal presence or activity, especially greenhouse gasses from industrial activity or billions of 18

wheelers, jet aircraft, SUVs, furnaces, air conditioners, power plants, skyscrapers, etc., etc. al-Gore, call your office.

The highest temperature ever recorded in May in Central Florida occurred on May 30 (100 degrees) and May 31 (102 degrees) in 1945. June of that year began with 100 degrees that first day of the month – a historical record.

That's three consecutive record days 72 years ago when the population of Orange County was under 100,000, led by Orlando with 42,000 and Winter Park with 7,200. The entire state had less than 2.5 million.

moved totaled at 166,840 cubic yards during the week of October 15, with the smallest amount of yard debris removed totaling at 4,007 cubic yards during the week of December 11. The contractors had removed a total of 900,000 cubic yards of debris as of December 12, with 825,000 being vegetative debris and 75,000 being waste debris. Currently, contractors are closing out to the removal process, where they are finalizing canal and retention pond debris and reducing debris for final disposal, all of which is expected to be completed by January 2018. In addition, documents are currently being prepared for reimbursement from the Federal Emergency Management Agency (FEMA) for the cost of debris removal. The costs of debris removal can be broken down into the following components: vegetation removal; citizen sites; stumps; leaners and hangers; hazardous trees; construction and demolition; and monitoring

services. Vegetation removal can be further broken down into the following categories: debris removal from rights-of-way; debris storage at a temporary debris storage and reduction (TDSR) site; debris reduction; and final disposal of debris.

Out of 270 total gated communities, 125 had submitted service tickets by calling the Orange County 311 Call Center. Public Works reached out to the inquiring communities and did the following: explained the process for debris removal in gated communities; scheduled 54 team visits with homeowner's association (HOA) representatives; estimated debris; and discussed options for removal. Residents in gated communities had the following options for removal of debris: rolling off the debris outside of the community (putting a dumpster outside of the community); obtaining a letter permitting them to dispose of debris at the citizen sites; and making arrangements to put the debris

on the trucks with the contractors. It was reported that nine residents had requested letters, one decided to roll off, and eight had arranged to transfer their debris to the trucks.

Following the hurricanes that hit Florida in 2004, Orange County provided for an absolute funding mechanism for gated communities from several sources, both existing and new: OCU yard waste pick up; HOA insurance, if available; and the addition of the "Storm Debris Removal Account" in the Subdivision Regulations of the county code. At a public hearing on February 24, 2009, the Board of County Commissioners amended the Subdivision Regulations to include the "Storm Debris Removal Account" as part of the county code. The code now reads: "Require the establishment and maintenance of an HOA account for storm debris cleanup and removal, such as clearing downed trees, landscape,
