

small claims case?

Filing fees for small claims actions are set forth in the Florida Statutes and in Orange County ordinances. Fees vary in accordance with the dollar amount of your claim and the type of

action. See County-Civil-Filing-Fees.

What information do I need to file a small claims

The complete names, addresses, phone numbers and business name (if applicable) of both the plaintiff and defendant are required.

Copies of any contracts, notes, leases, receipts or other evidence you have in support of your claim must be furnished to each person you are suing as well as to the court.

What happens after I file my small claims case?

After a small claims case is filed, each person or business you are suing must be served with a Summons/ Notice to Appear in court on the date and time scheduled. This court date will be a mediation/pre-trial conference, and you should be prepared to present your case.

If the dispute cannot be settled at the mediation/pretrial conference, a trial date will be scheduled. You must appear at the trial with all witnesses and documentation of your claim.

Can I have a jury trial for my small claims case?
