pursuit of success as displayed by the immigrants of the late 1800s and early 1900s, and their initial descendants. This obviously comes from his mother, a Scottish immigrant born on the Isle of Lewis off the west coast of Scotland.

Also, his paternal grandparents were German immigrants in 1885, naturalized as U.S. citizens in 1892. His grandmother's name was Elizabeth Christ. She married Frederick Trump in Bavaria, Germany.

After some setbacks in the "Clinton 90s," Trump saw a financial resurrection in the next decade. In 2001, he completed Trump World Tower, a 72-story residential tower across from the U.N. headquarters. Also, he constructed Trump Place, a multi-building development along the Hudson River, and Trump International Hotel and Tower, a 44-story mixed-use hotel and condo tower on Columbus Circle.

Other projects include International Towers-Honolulu; ditto for Chicago, Toronto, Tampa, Fort Lauderdale and Atlanta.

Other ventures include Trump Restaurants, mostly in his buildings, consisting of Trump Buffet, Trump

Catering, Trump Ice Cream Parlor, and several other products and services, all pre-named Trump.

In addition to buying and building many golf courses in the U.S. and worldwide, he had purchased the Doonberg Course in Ireland, renaming it Trump International Golf Links, Ireland. He also constructed one and bought two in Scotland, including Turnberry, a regular fixture in the Open Championship rotation.

In February 2013, Trump, who is a popular figure with the Israeli public, endorsed Prime Minister Benjamin Netanyahu during the 2013 elections. In 2015, Trump was honored with the "Liberty Award" at the "Algemeiner Jewish 100 Gala" in honor of his positive contribution to U.S.-Israeli relations.

One of his daughters, Ivanka, converted to Judaism. Trump stated, "Not only do I have Jewish grandchildren, I have a Jewish daughter, and I'm very honored by that."

And, if he ever needs constitutional advice, His sister Maryanne, is a federal appeals court judge. When I hear commentators, both left and right, who couldn't run a peanut stand at a profit, state that Trump does not have the "experience" necessary for

the presidency, I have to laugh and recall the same comment when Ronald (rhymes with Donald) Reagan was running for governor of California, our most populated state, in 1966.

In many ways, Reagan was somewhat like Trump in diversity, but not anywhere near "The Donald's" management depth. First, he was a radio sportscaster, then a movie actor, then a TV spokesman for General Electric, then governor, and finally one of our greatest presidents. Sing his simple strategy, "We win, they lose." He brought down the Soviet Union without firing a single shot.

R. Emmett Tyrell, publisher of *The American Spectator* put it quite simply in a recent column.

"When Trump spoke last week about 'making America great again,'" Tyrell wrote, "his message was not lost on the audience. It echoed the message of a president who cheered all back to 1984, when he spoke of 'Morning in America.'"


Why is it so gauche to think Trump could enter politics from the world of commerce?
