

# Wekiva girls soccer coach, player expanding team's efforts

The list of what catches the eye in sports doesn't usually include a record of 12 wins, 11 losses, and one tie.

One exception proving the norm is the Wekiva Mustangs girls soccer program. And then a second watershed mark in addition to pushing the record above .500 was advancing to the District 6A-4 championship tournament final. Nine seasons had passed since a winning record or advancing to the final of the district championship tournament was achieved.

Still more work needs to be done for the progression to continue, starting with the Southeast All-American High School Soccer Showcase scheduled for June 11-13. Wekiva women's soccer will be represented by midfielder Areli Patricio and coach Ryan Nash. Patricio will be looking to improve a skill set that produced 26 goals and 16 assists this past season.

"Weightiest issue facing all Wekiva women's sports is a lack of coming from an organized competition background for whatever reason," Nash said.

"Mustang women's athletics is in a unique opportunity. Our athletes are among the most athletic and elite in Orange County/Central Florida. And from the coach's perspective, women's soccer has been built on young athletes who are also very dedicated to competing as part of a team. However, potential in comparison to the stage of the career hasn't been reached because of the late start playing. Some players are still learning the sport of soccer.

"The SAAHSSS is an opportunity to make strides toward improving a number of areas. Most important aspect is the transition though. Tools for a player

earn a scholarship to play at the next level. However, Southeast All-American Sports LLC events are centered on showcasing only high school play in order to bridge the gap with club.

Tyler Pineda is the founder of Southeast All-American Sports LLC.

"Non-club players getting more exposure as far as college recruiting has been a big focus of Tyler," Nash said. "The recruiting grounds for colleges traditionally start with club. High school competition isn't given the same attention sometimes. However, players who play only with high schools aren't necessarily any less talented or capable of playing at the college level."

Three consecutive berths into the Georgia state championship tournament have also been earned by Chestatee High School with Pineda at the helm. In 2018, Chestatee fell in the state championship match.

"Areli is a prime example," Nash said. "Club was given up after about a year and a half. Playing club soccer didn't make sense or behoove Areli when comparing the considerations of the socio-economic situation. By no means does Areli come from a poverty-stricken background or struggles financially. Cost of club participation can be in the thousands of dollars and increasingly expensive even for financially secure families though.

"The format is similar to club, but the nomination process is strictly through high school play and competition.

"Size of the event has grown quite a bit in a few years. Representatives of roughly 60 colleges/universities scheduled to attend is an example of the growth from grassroots. However, more will probably attend."

The players are split into four teams of 14. Patricio is a member of the Stripes teams. The Stars

coaching staff includes Nash.

Various activities outside of games take place on Friday and Saturday. On Sunday, four games will be played at Atlanta Silverbacks. Schedule is Team

Stars vs. Team Stripes and Team East vs Team West. The women's match for each takes place first, followed by the men.

"Standing on the other side as Areli is going to feel strange, but should

make for interesting competition. Perhaps, both of us will improve our skill-set as leaders while watching the other as well.
