first downs facilitated Miami Norland's creation of an 8:40-3:20 advantage in time of possession. And the team without possession of the ball can't score.

"Touchdowns scored on the play after the exchange of possession changed the score," Schwartz said. "However, turning point was the play causing the exchange of possession before the second Vikings' touchdown. Every team makes a handful of momentum changing, impact-on-the-complexion-of-the-contest-at-the-time plays. Winning and losing is decided by the opponent's response. Managing the emotions and remaining focus is a lot easier when riding the momentum, than

not. We didn't only fail to break the momentum. The momentum was then built on and the tone for the second half set by Miami Norland."

On second down of the Mustangs' first possession, linebacker Camron Thomas slashed through the gap between the offensive tackles and tackled Rommel Smith for a three-yard loss. Whatever opportunity Wekiva had to reverse the effect of losing 14 yards on first down due to a high snap went by the boards.

"Nonetheless and again, we gained a lot more facing the Vikings than a team favored against," Schwartz said. "Developing a false sense of security about the overall level of quality and confidence in the specific areas is common when defeating a team

clearly better than.
