No tax would be collected on essential food items, such as bread, milk, or other foods not taxed now.

Prescription drugs would be exempt, as would utilities. The sales tax would generate almost

\$600 million per year, and at least 51 percent of the funds collected would be paid for by tourists and visitors from outside of Orange County.

member was invited to submit a potential name for our new school. They were encouraged to think of the historical and geographical significance of the area or of someone who made an impact on the local area.

Those surveys were received and tabulated by Principal Steinke and the top four choices were revealed this week in another email survey that went out to the school community, asking for a final vote.

As is stated in school board policy, the results will be shared with the superintendent and she will present the top three choices to the School Board at a future meeting where the name will be chosen and voted on by the board.

The top four choices that community members were given this week to vote on were Bay Ridge

School, Citrus Ridge School, Jason Dwelley School, and Kelly Park School. Each of these choices has important significance to the area of the new school and they were well-thought-out choices.

Bay Ridge is important because the new school is geographically located within the community that was known as Bay Ridge in the 1800s. When you look at old historical maps of the area, you will see the names Clay Springs, Lakeville, and Bay Ridge. Clay Springs and Lakeville already have schools named after them in our community.

Citrus Ridge and Kelly Park are obvious choices since many citrus farms were part of our local history and the school is located not far from nearby Kelly Park, the beautiful park that was donated to Orange County in 1927 by Dr.

Howard Kelly.

Jason Dwelley is not only the name of the road that the new school is located on but it is the name of a hometown hero, Petty Officer 2nd Class Jason Dwelley, who passed away in 2004 serving in Operation Iraqi Freedom. Officer Dwelley attended Apopka Elementary and Middle school and graduated from Apopka High School.

All of these are great choices and now the school community will vote on the name they like best. All those results will be shared with the school board when they make the final decision at a future board meeting. The school mascot and colors will also be chosen at that time.

It's an exciting time for our community as we welcome a new school to our area. Lots of great things are ahead for our community!
