their goods could easily be shipped to large markets in New York City. I was awestruck with the number of large, well-maintained Victorian homes. Susan B. Anthony's home predates the Victorian age back to the 1840s and 1850s. It was apparent the glory days of this city were in the past and with the diminution of Kodak and Xerox and manufacturing in general, the city is receding. I did not see any new homes being constructed and, yes, relatively empty roadways. Many children have moved south for new jobs and opportunities.

Rochester and Orlando are in very different states, and neither is comfortable (no pun intended). Transplants love the weather and hustle and bustle in Orange County. Yet, we are not truly handling the great influx well enough. Our county needs better-paying jobs

and higher-tech industries, additional transportation options, preservation of natural spaces, and an intense focus on building social structures to preserve the wonderful culture for which so many of us were attracted. This latter category is what I will focus on for the remaining portion of this column.

Being an amateur history enthusiast, I researched Apopka's history and often attend events at the Museum of the Apopkans and the Orange County History Center.
