the ministry partnered with residents and local groups to address social problems such as illiteracy, lack of access to healthcare, and economic injustices. Along the way, they spearheaded the creation of six separate nonprofits, and literally, thousands of lives were changed for the better.

Today the HOPE Community Center has two locations in Apopka and supports 4 counties within Central Florida and helps over 12,000 people yearly.

After visiting with staff members a few weeks ago, I decided to invite our new (Orange County School Board) Superintendent Dr. Maria Vazquez out to the center to hear about the challenges they face every day.

The visit was moving, emotional and one of the most important things

I have done during my tenure on the board.

We spent over two hours at the HOPE Community center in South Apopka, spending the first hour talking to staff members and the second hour listening to community members sharing their stories.

Dr. Vazquez and I were mesmerized by the stories that were shared and often moved to tears. It's hard for many of us to understand what this population goes through on a daily basis, but understanding is vital if we are going to make changes to ensure they are treated with the dignity and respect that every human being deserves.

One area that is the biggest challenge right now is helping the unaccompanied minors that come to our area from other countries. Currently, HOPE is working with 200 un-

accompanied minors in our area alone and has 100 more on a waiting list.

These children were sent to our country by their desperate parents who had no other option to keep their children alive or safe. It's really important to understand what terrors a parent would have to face in order to be able to let go of their child and send them away alone.

In most of these countries the children come from, boys are forced into militia training at a young age, given guns and taught how to kill. The girls are forced into the sex trade industry.

The only way these parents can keep their children safe is to do the unimaginable and send them on a journey with strangers to another country, often saying goodbye to them for years.

Being separated from

your parents is traumatic enough, but then add on a very long, often dangerous pilgrimage that ends with being locked away in a detention center for months, and these children end up in our community with emotional scars that take tremendous care and time to overcome.

Often our unaccompanied minors are living with strangers when they arrive here and are forced to work in the evenings to make money to send home to pay back the money that

the family owes for the trip to our country. It is a tremendous burden these kids face, and this is why it was important for us to learn about it.

These children have to be handled with care to overcome the trauma they have endured and they have to be met with understanding.

Needless to say, the superintendent and I learned a lot and left with many tangible goals to work on and implement in our local schools to help

ease the transition to our schools for these kids.

I'm hopeful that by sharing this experience, we all can be more sensitive to those around us that talk or look different from us and to remember that everyone has a story that we may not understand.

The team that won the *Corridor of the Year Friendly Contest* was the best socialized. It was interesting to watch them. They successfully utilized text blasts, Facebook page announcements, e-mail communication, and more.

They mounted a dozen or two volunteers to work every Saturday morning and the group grew. Just about every resident saw their neighbors pressure washing, raking, trimming trees, painting walls, and more.

Why doesn't this approach work in my neighborhood, then? I believe this because there are few regular projects or activities. HOA and regular neighborhood leaders must develop multiple opportunities for residents to interact and engage. It is hard work and can be disap-

pointing in the beginning.

And thus, so is the challenge of creating and maintaining a vibrant main street. A common vision of a vibrant main street is one bursting with hometown spirit and civic pride. The strategy in developing a main street is first building social infrastructure which enables and encourages community civility and sociability amidst a relentless onslaught of technological innovations that tend to isolate. Overcoming community isolation and civic disengagement is the biggest challenge of our day. We must overcome the isolation to create the communities we so strongly desire.

Here's a positive story about breaking down barriers of social isolation. Sheeler Road also competed in the corridor contest. Troy Johnson, the president of Silver Oaks HOA, is a young inspiring professional. I'm always amazed how he brilliantly and energetically brings his two young daughters along to events. Troy recently offered a cleanup day, to which just a handful of his residents came. However, I supple-

mented with staff, friends, and two wonderful city commissioners. We had a great time trimming trees, bushes, and mulching. The back entrance looks terrific now. Within a week's time, Troy and his management company then hosted National Night Out. More than 100 of his residents turned out with a lot of help from the City of Apopka. Here's the thing ... I don't ever remember a Southern Apopka neighborhood hosting a citywide event. Success breeds success. I look forward to Troy hosting more events and inviting other Sheeler-area subdivisions to participate. Eventually, I believe nearby neighborhoods will also host events. Again, success breeds success. Your neighborhood leaders must focus more on social events than collecting dues and issuing violations.

I believe together, we can build character neighborhoods, areas, corridors, and main streets. The charge is to build active social networks, which build stronger bonds through community projects and action.
