rate base, which also provides high wage jobs, is due to a "circular economy." For example, the large corporations work together to provide a \$50-million equity fund for black and women-owned start-up companies. They team up to find sustainable solutions to common problems. For example, with 100 million lbs. each year of trash,

a company started a large plastic recycling company. They are investing in computer chip manufacturing, looking at this industry as the railroad yard of the 21st century. Another creative spin-off is the manufacturing of sustainable fuel near the Twin Cities Airport.

The area's corporations make a point to purchase each other's products. How about that? Every company purchases

hand sanitizer and other products from Eco-Lab. They buy Pillsbury flour, and many more examples. Corporate support for other local companies is vital to their success.

One of our speakers used the phrase, Knit together big solutions. They believe in leveraging the region's total assets to improve opportunities for all.

for every struggle we face. If our minds are made up to fight until the end and keep stepping forward while keeping our focus on doing the right thing before us, we are poised to make a knockout to that obstacle. Unfortunately, too many of us tend to lay down sometimes because we face an opponent or an obstacle that seems too formidable to challenge, but Joe faced men without thought of how formidable they were, but thinking only of his strategy, punch, step forward, punch, step forward.

He once had an opponent that told the news reporter, because he weighed less than the Brown Bomber that he would "hit and run" Joe to weariness in the ring, to which Joe replied, "He can run, but he can't hide." He knocked Billy Conn out in the thirteenth round. Not only is Joe Louis the record holder of the title, "Heavyweight Champion of the World" for al-

most a dozen years, but, in my humble opinion, holds the record for being one of the most patriotic American men in the nation.

Joe joined the Army, ready to take his place in the combat forces. When asked why he was enlisting in the segregated Armed Forces Joe replied, "there's a lot of things wrong with America, but Hitler ain't going to fix them." The top brass recognized his ability as a prize fighter to earn money for the war effort, so, he fought many exhibition fights, traveling over 22,000 miles, and was presented the Legion of Merit Award for "incalculable contribution to the general morale," which qualified him for an immediate discharge.

Although Joe was abused by the IRS, all the exhibition fights that brought millions of dollars into the war effort was counted toward Joe's income, even though the war effort had been the recipient of the money. The

IRS had him indebted by \$500,000 to them.

Even after that, the Brown Bomber stated, "We will win because we're on GOD's side." For the first time in the history of the United States of America, a black man did become the hero of our nation, representing us (U.S.) to the whole world.

We need more men and women who are willing to put their own selfish desires aside and share the same attitude: that of faithfulness to the cause of a united people.

Our pledge to our flag states, "one nation, under GOD, indivisible, with liberty and justice for all."

ONE nation! Many cultures represented, but ALL : AMERICANS. May it be said of you and me the same as was said of Joe Louis Barrow.

In a response to someone saying that Joe was a credit to his race, a sports-writer said, "Yes, he was a credit to his race; the *human* race!"
