Apopka issues mandatory restrictions on water use

County's current drought level is moderate to severe

Beginning April 28, the city of Apopka Public Services Department ordered community-wide mandatory restrictions on water usage to ensure there are enough potable and reclaim water sup-

"With an increasingly

faster depletion of the water supply being observed at the City of Apopka Potable and Reclaim Water Plants, the City is entering the mandatory water conservation restrictions listed below," a notice states on the city's web-

Under the restrictions, irrigation activities are allowed before 10 a.m. and after 4 p. m. and are limited to alternate days, according to the notice, citing this infor-

Renner, Ricketson highlight prayer breakfast

Chief's Eileen Ricketson honored with Pillar Award

Obedience and faith in God to use a person to yield positive lasting changes was the message that Paul Renner, former speaker of the Florida House of Representatives, gave to an audience of over 400 people at the Apopka Mayor's Prayer Breakfast.

Gas district upgrading pipelines in Apopka

U.S. DOT grant is funding projects

Projects to address natural gas distribution pipelines in several Apopka neighborhoods are at various stages of completion and progressing well, according to Brent Haywood, Lake Apopka Natural Gas District (LANGD) general manager/CEO.

Haywood updated the board of directors at the district's monthly meeting on April 28, which took place at the LANGD headquarters in Winter Garden.

"I just want to let everybody know the grant is moving along really well, the operations team, engineering

teams, get the designs out, the construction done," Haywood said.

The five Apopka road-

way projects are funded by the U.S. Department of Transportation Pipeline and Hazardous Materials Safety Administration (PHMSA) through the Natural Gas Distribution Infrastructure Safety and Modernization (NG-DISM) grant program. NG-DISM aims to increase public safety, preserve public health and cut down methane emissions from natural gas distribution equipment, according to a past LANGD press release.

The Infrastructure Investment and Jobs Act, which President Joe Biden signed into law in November 2021, set up the grant. Over its first five years, the grant was distributed at \$200 million a year, totaling \$1 billion.

Haywood discussed the Apopka PHMSA grant projects that were under the April 28 general manager's report.

Project one is Gaymar Drive, which the gas district had completed.

Projects two and three are Votaw Road and Abigail Drive, which are sister projects and are at about 95% completion. All LANGD has to do with this project is to transfer the gas line.

Project four is Sadler Road, which is about 70% complete. Project five is Thompson Road,

City drilling new wells

Our Public Works team had a great meeting with the staff from St. Johns River Water Management District (SJRWMD) about drinking water Wellfield Pumping Distribution within the city of Apopka.

As we drill new wells into the lower

aquifer to replace old wells that were in the middle aquifer, we want to make sure that the wells are placed strategically to reduce the impact on both Rock Springs and Wekiva Springs.

Drilling wells into the lower aquifer helps to lower the impact on our springs as the majority of their water comes from the middle aquifer. These lower aquifer wells do cost considerably more to drill and will also require ozone treatment to remove the hydrogen sulfide (H2S), which gives water the rotten egg smell.

Now is the perfect time to strategically place the wells to have the least impact on our springs and replace the outdated wells that are currently ac-

Our Consumptive Use Permit (CUP) with SJRWMD allows the city to withdraw 16 million gallons a day

Apopka Mayor from the ground for the residents and businesses here in Apopka. We are currently withdrawing 10.7 million gallons a day, which gives us about an additional 5 million more gallons of water that we can pump from the wells,



the new wells to the end user. It is critical that we not only place the drinking water wells in the most strategic areas but that we work hard to fix our Golden Gem reclaimed water facility to give us more options for water resources.

In working with our partners in Altamonte Springs, Sunshine Water, and SJRWMD, along with our potential partners in Winter Garden and Ocoee, we have the opportunity for a regional water supply that will benefit not only our residents but our springs.



Transportation study aims to evaluate NW county needs

I'm excited about the public involvement portion of the upcoming county comprehensive transportation study of northwest Orange County. In fact, the study is referred to as NOWOCATS or Northwest Orange County Comprehensive Area Transportation Study.

There will be two major community meetings involving four areas of northwest Orange County. More than 50,000 people will be invited. An additional offering will be online viewing. The first meeting will be scheduled for September. The final meeting, after receiving public input, will be held in November.

This effort began two years ago after I successfully got county staff to meet with the city of Apopka transportation staff. They had several difficult discussions. The county's position is that with the incredibly high cost of roadway capacity expansion, both parties must pay their fair share of expansion. So, determining funding responsibilities by which entity approves growth will be a large scope of

This study has taken a year to "scope" out the services needed, areas to be studied, and to complete the vendor procurement process. The vendor the county selected is VHB, or Vanasse Hangen Brustlin, Inc. Project cost analysis and prioritizations will be determined. Staff preliminarily indicated intersection improvements are recommended as the first projects to be undertaken to bring much needed relief.

from his personal story to illustrate his keynote message, from serving in the military on active duty for nearly 23 years, including in Operation Desert Storm, to becoming a prosecutor and business owner to entering politics.

When Renner ran for a House seat the first time. he lost. He ran a second time for the Florida House and won by a landslide in 2015.

As speaker of the Florida House, Renner supervised at least 500 employees, crafted two balanced state budgets totaling \$100 billion and established the agenda for legislative sessions. After serving eight years in the House, he was term limited in 2024.

"I'll tell you, in hindsight, had I won that first race, I would not be standing here in front of you, certainly not as a former Speaker of the House," Renner said. "Losing that race [the first time] was actually, politically, the best thing that ever happened. Our timing is not God's timing, but God's

timing is always perfect."

The National Day of Prayer falls on the first Thursday of every May. In 1775, before the United States was formed, the Continental Congress called for a national day of prayer and fasting.

After that, other leaders like presidents George Washington and Abraham Lincoln periodically called for a National Day of Prayer to recognize God's role in the United States in important times in the nation's history.

In 1952 President Harry Truman, through Congress, codified the National Day of Prayer as an annual celebration. In 1988, Ronald Reagan designated the first Thursday in May as the National Day of Prayer.

Pillar Award

ACMA President Pat McGuffin announced the Pillar Award would go to Eileen Ricketson for her 45-plus years of outstanding community service.

As wife of late The Apopka Chief/The Planter publisher John Ricketson, Eileen poured all of her efforts into operating the newspapers through various tasks such as subscriptions and legal notices. She also managed the family's Apopka Office Supply store.

"She may worked long hours but would always have time to put a smile on her face or give you a hug and encourage you during your day," McGuffin said before announcing Ricketson as the award recipient. "You know, we all have days that are crazy, and to have somebody care enough to stop what they're doing and just smile and talk with you that was part of what our recipient did."

In February, Eileen sold both newspapers to Mainstreet Daily News, a subsidiary of Orlandobased MARC Media.

Eileen is the third member of the Chief to receive the Pillar Award, which began in 2006. Her husband John received it that year with then-Mayor John Land, followed by Marketing Director Jackie

Trefcer in 2017.

Eileen received a standing ovation from the audience, which she thanked for their support over the years.

"I want to say that if it were not for the goodness of all of you, I would not have the goodness to share with you," she said.

"I appreciate what you've taught me and showed me and the love that you have shared, and I'm so very grateful that we've had the opportunity to get to know you and to thank you for what you have done for those around you. Thank you so ever so much. God bless you."

mation from St. Johns River Water Management District. Any irrigation activities are limited to 15 minutes per zone.

Addresses ending in odd numbers are allowed to water on Wednesday and Saturday; addresses ending in even numbers, Thursday and Sunday. Non-residential irrigation is allowed to water on Tuesday and Friday.

The city is requesting both residential and commercial customers to not put in new sod until the water restrictions are lifted.

Consequences of violating the restrictions are written warning for the first violation; \$50 fine for second violation; \$100 fine for third violation; and \$500 fine for subsequent violations. Each day that any violation exists is considered a separate offense.

The city of Apopka public notice states that the current drought level is D1 (moderate) to D2 (severe). That means that Orange County has a 53.69% moderate drought, while 38.28% of the county has severe drought, according to Drought.gov.

As of May 1, there is no date for when the water restriction will get lifted, but only "until we get some rain," Mayor Bryan Nelson said in a Thursday interview.

Nelson said he didn't know how successful the water restriction has been so far.

"We just hope everybody abides by the restriction," he said.

Nelson explained that one problem the city of Apopka has is that Altamonte Springs, from which Apopka typically receives a couple of million gallons of water a day, has provided "zero" reclaimed water for over a month now. Therefore, the city of Apopka had to reluctantly supplement its reclaimed water with well water.

The recent drought caused a fire last weekend at the Don Lowe Field on Keene Road, which burned 50 acres, Nelson said.

The Remote Control Association of Central Florida Flying Club conducts aircraft flying events at the Don Lowe Field. On its website, the club announced that the Orange County fire marshal put out a temporary decree as a result of the fire, which a model airplane crash caused.

The decree prohibits operation of turbine-powered model aircrafts and driving vehicles with catalytic converters over the field's grassy sections.

"These restrictions will remain in effect until the current high-risk, dry conditions subside," the website states.



Programs, technology help seniors navigate loss of keys

Most adults outlive ability to drive by 7–10 years

In this car-centric society, what do you do when you can no longer drive?

It's important to think about, and most people don't, according to Beth Gibson, a certified driver rehabilitation specialist at the University of Florida's SmartDriver Rehab. More often, Americans are focused on issues such as planning for retirement, making changes at home to age in place, or considering a senior living a senior community.

"People think about those things, but they don't think about the potential changes for being independently mobile and able to drive for themselves," Gibson said. "Most of us will outlive our ability to drive, and it's not necessarily just because we've gotten older. It is more related to changes in visual and cognitive function that may be related to a disease."

The Florida Department of Transportation, in its guide to "Safe Mobility for Life," notes that Americans are driving longer and putting more miles on their vehicles. But the research shows that most people won't always be behind the wheel.

"Older adults can expect to outline their ability to drive

safely by seven to 10 years," according to AAA and FDOT.

More than 20% of Florida's population is over age 65, and by 2030 will account for more than 24% of the state's residents — meaning that one in four licensed drivers will be elderly.

Florida has the secondhighest number of registered vehicles in the United States, with 7,763,328 as of 2022, according to Statista, a global data and business intelligence platform. California is first with 13,796,109.

"Driving is so important," Gibson said. "Most places you live in our country are not set up well enough with public transportation. If you can't drive a car, you can't get around by yourself."

That dynamic can create new and significant logistical challenges.

"You are severely limited — economically in terms of getting to work or school and

socially in terms of being able to go out and be involved in things," Gibson said.

Some seniors have found ways to cope when it is no longer safe for them to drive. Gaby Gross, 91, and Martha Bergmann, 83, are both residents at The Atrium in Gainesville, and they know what Gibson is talking about.

"When I moved here two years ago, I left my car behind," said Bergmann. "I stopped driving because I crashed my car."

Gross said she stopped driving about five years ago when she ran a red light and had an accident.

"The car wasn't totaled, and I wasn't hurt," she said. "But I didn't want someone to tell me to stop driving. I wanted to make the decision myself."

The two women use the "Freedom in Motion" program offered by Elder Care of Alachua County through the Gainesville Senior Recreation-

al Center. It subsidizes Uber rides for seniors who apply for the program. Gross and Bergmann take advantage of the service, which offers both oneway trips and round-trips to participating seniors for a \$0 to \$5 copay within city limits.

"With the growing need for transportation services among older adults in our community, we are always seeking additional sponsors to help expand this vital program," said Nicholas Hauzer, Senior Recreation Center and Volunteer Services manager. "Each contribution allows us to provide more rides and ensure that more seniors can stay connected and engaged in their daily lives."

Go Go Grandparents is a rides program available throughout the United States, including Apopka. It uses a private pay model that provides screened and monitored services from Uber, Door Dash, Instacart, Lyft and Uber.

tor's appointments, dialysis appointments and other medical and non-medical transportation needs," Ball said.

For those who can still drive, Gibson says there is a lot older drivers can do to stay on the road more safely — especially by paying attention to their visual needs and limita-

"Ninety percent of the information we gather that helps us make decisions with driving comes from vision," Gibson said. "Then, we interpret that information, and based on what we see, we decide what we need to do."

Gibson suggests keeping up with annual eye exams and staying aware of how medications may affect your driving skills. She also points out how important it is to keep your windshields and headlights clean, and if you have a disabled tag, to remove it when you are driving so it doesn't block your view.

If you have a newer car with more safety features, you can get to know it better. One helpful website is "My Car Does What?"—which is put out by the National Safety Council (NSC) and explains the new technologies that make cars safer, how they work, and when they work.

Driving is not a walk in the park, but these new tools are helping seniors stay mobile safely, with or without a car.

Granny just puts everything right on top of the potatoes and mixes the salad with her hands. I suggest you try my method until you've made it, as she has, for over 75 years!

We loved her very much. She did leave us her recipe for a spectacular broccoli and cauliflower salad along with many beautiful memories. CHICKEN MEDITERRANEAN

Recipe from Southern Living All-Time Favorites

1/2 pound skinned and boned chicken breasts, cut into cubes 4 garlic cloves, minced

2 tablespoons olive oil 1 (14-1/2 ounce) can diced tomatoes, und-

1/4 cup kalamata olives, pitted and chopped

1/2 teaspoon dried parsley flakes 1/2 teaspoon dried basil

1/2 teaspoon dried oregano

1/3 cup crumbled feta cheese 4 ounces penne pasta, cooked

Combine first three ingredients in a zip-top plastic freezer bag. Seal and chill two hours. Cook chicken mixture in a large skillet over medium-high heat for eight minutes or until chicken is done; remove from skillet. Add tomatoes and next four ingredients to skillet. Reduce heat, and simmer, stirring often for seven minutes. Return chicken to skillet. Sprinkle with feta cheese, and remove from heat. Cover and let stand five minutes. Serve immediately over hot cooked pasta. Makes two servings. Note: To serve four, use one (14-1/2 ounce) can diced tomatoes and double all other ingredients. Cook chicken mixture eight to ten minutes or until done; remove from skillet. Add tomatoes and next four ingredients to skillet. Reduce heat, and simmer, stirring often, seven to eight minutes.

ITALIAN BRACIOLE

Recipe from Florida Federation of Garden Clubs Inc., Paths of Sunshine

6 cubed beef steaks

1/2 cup chopped onion

1/4 cup chili sauce

1/2 cup beef broth

1 (4-ounce) can sliced mushrooms

2 tablespoons chopped bell pepper 2 tablespoons sliced pimiento-stuffed ol-

1 teaspoon sugar

1 teaspoon Worcestershire sauce

1/4 teaspoon oregano

1/8 teaspoon garlic powder

1/8 teaspoon pepper Hot cooked spaghetti

1/2 cup cold water

3 tablespoons flour

Season cubed steaks. Spread onion on

steaks and roll. Secure with toothpicks. Place seams down in 10 x 6 x 2 baking dish. Combine chili sauce, broth, mushrooms, pepper, olives, sugar, Worcestershire sauce, oregano, garlic and pepper. Pour over beef rolls. Bake 350 degrees about 1-1/4 hours. Arrange meat rolls atop spaghetti on serving platter. Keep warm. Pour pan juices in measuring cup, skim off fat. Add enough water to make 1-1/2 cups liquid. Blend flour with cold water. Add to meat juices and cook until desired consistency. Spoon sauce over meat and pasta. Serves 6.

COUNTRY FRIED CABBAGE

Recipe from Paragon Products, Inc.,

The Original Country Cookbook 1 small head green cabbage, shredded

3 tablespoons (or more) bacon fat 2 teaspoons red pepper flakes

Salt to taste Wash cabbage and shred by cutting into

quarters, then making thin slices across the cut sides of the cabbage. Discard the core and any tough ribs. Heat bacon fat in iron Dutch oven, put in the cabbage, and stir until it is all glistening. Lower the heat, add pepper flakes, and continue cooking and turning until it is barely tender.

GRANNY'S POTATO SALAD

Recipe from Southern Style, by Jane Bradley 3-1/2 pounds (about 8 large) red skinned potatoes

2 teaspoons salt

6 hard boiled eggs, chopped finely

1 jar (6 ounces) pimento, chopped finely, liquid reserved

1 large onion (about 8 ounces), chopped finely

1 teaspoon sugar

1-1/2 teaspoons salt

1/2 teaspoon black pepper 3 tablespoons (apple) cider vinegar

1 cup mayonnaise

Hard boiled egg, celery leaves, bell pepper, or paprika for garnish

1) Peel potatoes and cut into bite-sized cubes. 2) Place in a pan of cold water, add salt and bring to a boil. Reduce heat and simmer potatoes for 12 to 15 minutes until tender. 3) In the meantime, using a medium mixing bowl, combine hard boiled eggs, pimento, and its liquid, onion, sugar, salt, pepper, vinegar and mayonnaise. Stir well to blend and set aside. 4) When potatoes are tender, pour into a colander and let drain for a minute or two. Place potatoes into a large bowl and cover with

dressing. 5) Using a rubber spatula so that you won't mash the potatoes, begin to combine, folding until the potatoes are completely covered with the dressing. 6) Cover and cool to room temperature. 7) Stir salad and taste a bit, adjusting the seasonings if necessary. 8) Spoon into a serving bowl and garnish as you like with paprika, celery leaves, sliced bell pepper, or sliced boil egg. Yield: About 2 quarts, or 5-1/4 pounds, or 10 to 12 servings.

NEOMA KNOX'S

BROCCOLI AND CAULIFLOWER SALAD, Recipe from New Vision Community Church's Feeding the Flock

1 head cauliflower

1 bunch broccoli 5 strips crisp bacon

1/2 cup medium size red onion

1/2 cup golden raisins Dressing:

1 cup mayonnaise

1/2 cup sugar

1 tablespoon apple cider vinegar

Break and cut broccoli and cauliflower into bite-sized pieces. Broccoli stems may be used if peeled to soft center. (Hint: large pieces are easy to strip.) Break bacon into small pieces. Slice the onion into rings. Mix all the ingredients together.

Dressing: Combine mayonnaise, sugar and vinegar; pour over the salad and mix well. Refrigerate in air-tight container. Chill at least four hours; tip container to spread dressing evenly throughout.

emotion after the awards dinner, MacWithey recounted how he aims be a role model whether as a softball coach or as an engineering teacher who advises the high school robotics club.

Previously in the newspaper business, MacWithey switched careers in the late 1990s when the dawn of the internet posed as a threat to print media. He chose high school teacher as his new profession because he saw young people lacked a role model who could guide them in the right direction with honesty.

"When I took over the engineering program as well at Apopka High School, I had one goal, and that was to bridge the divide of how foreign countries are overtaking us," MacWithey said. "I made a commitment that we are going to create more engineers at Apopka High School than any school in the state of Florida, and I do believe we do that."

MacWithey emphasized the importance of the engineering profession.

"I kind of make fun of,

sometimes, the medical profession," he later said. "They're great, but you know what they use to diagnose you? The things invented by engineers. So without engineers, we are at a definite [decline] in our country. It's gone down the tubes if we don't make this better in this country. So that's kind of what I try to do every day."

MacWithey said people have asked him about retiring at his current age of 68 years, yet he has resolved to continue providing guidance and opportunities to students. He credited his success in his mission to his students' positive feedback and continued contact with them even after graduating high school. Alumni even return to help him host robotics events.

"As I said before, I believe in the students that come back, the amount of them that I still have contact with after they graduate high school," MacWithey said. "I had one [alumnus] two months ago. He said, 'You've got to come to my wedding. And he said he had just met another girl at

the University of North Florida, and they were going to get married, and they're both engineers. ... All you hear is negative stories. There's too many negative stories in terms of public education, that there's got to be positive stories."

The eight other Service to Mankind award honorees hailed from all walks of life and were also recognized for their contributions to the community: Janice Dafeldecker, David Durre, Linda Lee, Police Officer Emmanuel Sosa, Othellus Swift, Pam Welker, Dr. Linus Adah Wodi and Bishop Johnnie Wright.

For each of the last five years, the Foliage Sertoma Club of Apopka has searched for and honored local individuals who exemplified dedication to community service, thus epitomizing the club's mission of "meet[ing] the needs of communities through volunteer service."

A statement from the Foliage Sertoma Club called Mac-Withey "a contradiction in talents" due to his certifications and experience as an engineer-

ing teacher and his career as a fast-pitch softball coach of an elite high school program.

"He has proudly impacted the lives of thousands of advanced students and hundreds of softball student athletes who have earned collegiate scholarships through his leadership," the club statement said.

MacWithey joined the Apopka High School softball team as an assistant coach in 1983 and became the head coach in 1995. Over his 42 years of coaching at Apopka High School, he has amassed over 940 wins and a plethora of metro and district titles in the FHSAA.

Roger Franklin Williams, radio host and Sertoma Club member, was the one who submitted MacWithey's name as a nominee.

"The bonus that earns Mike the respect of his students and their parents is his degree as a Blue Darter from Apopka High School," Williams said in a statement. "Apopka is his hometown. That makes all the team and robotics achievements for the students and the

He will also get to ride in the Foliage Sertoma Club's annual Apopka Christmas Parade.

The Apopka softball team started its district title journey this week with a 4–3 win over the Sanford Seminoles in the second round of the 7A District 3 Tournament. With the win, the Blue Darters advanced to the dis-

trict championship, where they faced off against No. 9 Lake Brantley after press time Thursday.

Apopka vs. Sanford

Oddly enough, Apopka's final regular season game was against the Sanford Seminoles just days before they met in the district tournament. In its first matchup last week, Apopka won in decisive fashion with a 12–7 victory. This week, the Seminoles weren't going to let the Blue Darters get off so easy.

The game was scoreless for the first four innings as the Blue Darters and the Seminoles contained each other. But in the fifth inning, the Seminoles put up two runs to open the scoring and take the lead 2–0.

In those first four innings, Apopka's pitcher was Mia Aeschilman. She was relieved in the fifth by Ava Millspaugh after Sanford had scored two runs facing

Millspaugh easily finished the fifth inning, giving up no more runs, and sent the Blue Darters to the plate for the bottom of the inning. Apopka answered with a run of their own in the bottom of the fifth, thanks to a Skyla Durand solo home run.

Apopka couldn't make anything else happen at the plate in the fifth, but after shutting down the Seminoles, the Blue Darters grabbed the lead in the sixth. A flyball single from Riley Ford and a hard ground ball single from Braylyn Pirillo sent in the two runs, giving the Blue Darters a 3-2 lead heading into the final inning.

Sanford tied the game up in the top of the seventh with a fielder's choice. Now Apopka needed one more run to take the game without heading into extra innings. They got it.

Alicia Lopez's sacrifice bunt sent in the game-winning run, as fundamentals and willpower again won out for the Apopka softball team.

Apopka was solid in the field, with a .941 fielding percentage. The Blue Darters collected 21 putouts, 11 as-

Apopka flag football flies through playoffs

This week the Apopka flag football team overpowered the Mandarin Mustangs, 27–0, in the second round of the state championship tournament.

Last week, Apopka advanced to the Regional Semifinals of the 4A 2025 FH-SAA Girls Flag Football State Championship Tournament after shutting out West Port, 41–0, in the quarterfinal round.

Mater told me that even though they didn't have time to specifically game plan for West Orange, he was not worried about the team's preparation.



Unfortunately for the Mustangs, that would end their offensive output in the game. The next three batters struck out, and Oviedo's offense came to the plate ready to roar. The Lions put up five runs to take the lead in the bottom of the first inning.

The Lions put up two more runs in the second inning, five more in the third, and another five in the fourth. Oviedo took the win 17–3, run-ruling and knocking the Mustangs out of the tournament and the playoffs.

Wekiva's biggest problem in this game was their inability to get anything going at the plate after the home run, which was the team's only hit. The offense finished with a batting average of .077, going 0-for-12 with 11 strikeouts the rest of the way

Defensively, Wekiva did fairly well, finishing with a .882 fielding percentage as a team. The Mustangs collected 10 putouts, five assists and two errors.

Camilla Delgado and Arianna Garcia were on the mound for Wekiva in the loss. Garcia started on the mound for Wekiva and, in three innings, gave up 16 hits, 14 runs (13 earned), one walk, and tallied one strikeout with 81 pitches. Delgado came in to relieve Garcia at the bottom of the fourth, throwing just 12 pitches before the game was called. Delgado gave up two hits, three earned runs and one walk.

With the win over Wekiva, the Lions advanced to the district championship, where they were set to face Lake Howell on Thursday.

A look back at the 2025 season

son, the Mustangs finished with a team ERA of 18.82, compared to the national average of 7.02. Wekiva had just two pitchers, Garcia and Delgado, with Garcia throwing over 80% of the team's innings.

Garcia finished the season with a 16.86 ERA while giving up 136 hits, 156 runs (110 earned), 40 walks, five home runs and striking out 40 batters. She allowed an on-base percentage of .524.

Delgado was Wekiva's secondary pitcher, allowing 28 runs (26 earned) in six in-

Wekiva finished with a team fielding percentage of .806, well below the national average of .886, according to MaxPreps. Wekiva, which made 53 errors on the season, needed to be near-perfect on defense this season to compensate for their lack of depth on the mound.

Wekiva's offense was the strongest aspect of the team's performance this year. The Mustangs finished the season with a team batting average of .297, compared to the national average

of .327. Wekiva scored 110 runs on 71 hits and amassed 87 RBIs, 18 doubles, 10 triples and eight home runs.

What was most impressive about Wekiva's atbats was the number of runs scored for the number of hits they got. The national average for hits was 123, while it was 115 for runs scored. Wekiva put up 110 runs on just 71 hits, showing the team took advantage of its opportunities. That's an average of 1.54 runs per hit at the plate, compared to the national average, which is .93



pass effectively and made their way into the end zone with ease through the air. After converting the extra point, Apopka was up 13-0 as the first quarter ended.

Mandarin got possession back at the start of the second quarter, but Apopka's Bria Parsons snagged another pick for the Blue Darters as they once again halted the Mustangs' drive.

Late in the second quarter, Apopka took the ball and drove all the way to the red zone with ease before finding the back of the endzone. The Blue Darters were up 20-0 after a successful extra point as the first half ended.

In the second half, Apopka kept up its defensive showcase, shutting down more than one Mustang red zone drive and scoring another touchdown to close out the 27-0 win.

Francis facilitated every touchdown for the Blue Darters, whether through the air or on the ground. She was also a key defensive element in the shutout on defense.

Coming into the game, Francis was second in the nation in rushing this season with 1,733 yards, averaging 157.5 a game over 11 games. She also has collected 1,527 passing yards for an average of 138.8 yards per game.

"She's our heart on both sides," Wilson said. "She runs our offense, she runs our defense, and she contributes on both ends with picks and big plays. So she's a field general."

Apopka outscored the West Port Wolves 14–0 in the first quarter and did not slow down, running away with a 41–0 win.

The Blue Darters scored two second-quarter touchdowns to take a 28-0 into the locker room, but they did not take their foot off the gas after the break. Apopka scored seven points in the third quarter and six in the second to win the game 41–0.

Apopka showed no weaknesses in this game, with their offense and defense in perfect rhythm.

The stout Apopka defense collected 27 tackles, one sack and one interception. Asia Jones, Francis, Sariyah Spain and Nashielys Vega each made five tackles to lead the defensive effort. Spain also logged one sack for a loss of seven yards.

Apopka's Mikayla Wiggins collected the sole interception for Apopka but only got two yards before her flag was pulled.

Apopka vs. Spruce Creek

With the win over Mandarin, Apopka advanced to the regional final round of the state championship. The Blue Darters were set to face Spruce Creek High School (Port Orange) on Thursday after press time.

The Spruce Creek Hawks were an undefeated program sporting an 18-0 record ranked 25th in the state and the nation coming into the game. They are an extremely balanced team that has collected 3,208 passing yards and 2,518 rushing yards in 18 games.

They are also very strong on defense, only allowing 3.55 points per game this season. The Hawks are averaging 5.4 sacks per game and 2.4 interceptions.

With a win over Spruce Creek, Apopka's next game would be on May 9 in Tampa at the Advent Health Training Center in Tampa, where one of the other three regional finalists will await.

Wilson said being two wins away from the state title game is very exciting.

"It feels amazing," Wilson said. "We haven't won


