

Bracy Davis wins Senate District 15 primary election

State representative to face Montague on Sept. 2

Florida Senate District 15 primary voters chose state Rep. LaVon Bracy Davis as the Democratic candidate for the upcoming special general election in a landslide victory Tuesday night.

"I am humbled and hon-

ored to have earned the trust and support of the people of Senate District 15," Bracy Davis said in a statement provided to The Apopka Chief. "Tonight, we won decisively not just with votes, but with a vision. The voters have made it clear: they want bold, principled leadership that lifts up our communities, builds on our shared progress, and delivers results."

With all 102 precincts reporting, Bracy Davis garnered 5,533 votes, good for

almost 43% of the vote in a four-way race. Coretta Anthony-Smith finished a distant second with 28.31% of the vote, followed by former U.S. Congressman Alan Grayson (16.72%) and Randolph Bracy III (12.02%), who is the brother of Bracy

"I'm happy that we had this opportunity to offer the voters a real choice and to provide hope for a better tomorrow," Grayson said in a statement to the Chief.

Bracy Davis is the daughter of two prominent civil rights activists and currently resides in Ocoee with her husband. After receiving her law degree from Florida A&M University College of Law, Bracy Davis worked as a senior attorney at the Florida Department of Children and Families.

As state representative, she advocated for juvenile justice reform and acquired

Rankin retiring after 44 years

Local banker reflects on long career

common through everything David Rankin does—from his vocation as a banker to his several roles in community service has been that one gets out of something what one puts into

In addition to his 44-year banking profession, Rankin has been active in the Apopka community for decades. He was a founding director of the John H. Land Apopka Community Trust, which was started in the late mayor's honor and gives scholarship money to youth programs. He sat on the trust board for 10 years before stepping down in 2024, but still plays a role in the trust's annual fundraiser, the John H. Land Legacy

Rankin also served with the Apopka Area Chamber of Commerce for 25 years, including as board member, treasurer and president; a Rotary Club member for over 30 years, including serving on the board and as president; and a Foliage Sertoma Club member.

"I had a football coach many years ago, and he said, 'Everybody hates football practice," Rankin said. "He said 'but you get out of

it only what you put into it.' Jimmy Hewitt. That goes with anything. I've always subscribed to that."

Rankin, 67, is retiring on June 30 as executive vice president of two One Florida Bank branches, one located on East Third Street in Apopka, and the other one in south Orlando.

Over the years, Rankin worked at several banks. Those include Barnett Bank, which is now Bank of America across the street from One Florida Bank, and United American Bank, owned by Orlando Magic co-founder

In 2019, with banker and former City Commissioner Bill Arrowsmith, Rankin launched the two One Florida Bank branches. After 50 years in banking, Arrowsmith retired in 2024.

"We were competitors for years," Rankin said. "We said if we get the opportunity, we need to join forces. And it's worked out very, very well. The bank is doing extremely well."

While One Florida is thriving, Rankin has decided it's time to wrap up his career due in part to health con-

"We've had a lot of fun, but I've been doing this for 44 years, and it's time," he said. "I've had a couple health issues, and it's kind of caused me to pause and reflect. My wife's been retired for almost two years. We just said maybe this is God's way of saying it's time for you to cool your heels a little bit."

During his career, Rankin has enjoyed working with people and developing



West Orange Trail improvements represent community-wide efforts

I have spent significant time the last few years coordinating and inspiring improvements along the West Orange Trail through Apopka. It has been a journey to striving to make the trail through District 2 the envy of Central



portion of the West Orange Trail shade, beauty, mature trees, community park, food options, winding scenic portions, art installations, and a bridge and "pass."

So, what was the impediment to this trail section being activated sooner?

We didn't have cleanliness and safety. I rode all last year early on Sunday mornings before church to only find myself and poor souls sleeping. I don't mind if anyone uses the trail, in fact I want everyone feeling comfortable. I particularly love seeing children and fam-

cure funding for the Welch Road Trail extension, I formed a group called the People of Southern Apopka. This group has been responsible for cleaning up portions of the trail, Apopka Blvd., Sheeler Rd., Old Apopka Rd., and Clarcona through South Apopka.

They meet once a month, on the fourth Tuesday at Brixton Landing at 7 p.m. They host informational speakers and offer monthly clean-ups or community events. The People of Wekiwa Springs sent some wonderful ladies to facilitate the organizational side of painting the Apopka "Pass."

Most of the improvements are completed by volunteers with

the county supporting their initiatives by repairing sidewalks, trimming trees, and erecting road safety

Orange County Parks and Recreation contributed a tremendous amount of work along the trail. Staff regularly trims trees,

resurfaced the pavement and rebuilt the structural and aesthetic aspects of the West Orange Trail Bridge. Even last week, Dunkin' contributed by completely remodeling the inside and outside of their facility.

The Apopka Run Club is offering multi-evening and morning runs both north and south of the bridge from the Propagate Coffee House on 5th Street. They are also planting trees this month near the Forrest Avenue Baptist Church. I truly enjoy seeing the pictures of the Run Club as they pass through

The Apopka football team In addition to my advocacy (Coach Marcus Neeson) and Stuwith MetroPLAN Orlando to se- dent Government Association (Tracy Hough) sent students to assist. Recently they painted the Apopka Pass at the north end. I'm hoping Apopka High School athletes will run along the trail during daily conditioning activities. Activation is key to overall improve-

There is much more to be done to fully activate the West Orange Trail from Keene Road north to Lester Road. Nevertheless, I hope to see you using the trail, joining me on a project, or even coming up with a project of your own.

City begins pumping down lakes

The city is happy to report that the pumping down of the Piedmont-Wekiwa chain of lakes has begun after clearing one final hurdle.

Preliminary plans had water flowing directly from Blue Lake to Lake Piedmont using a stormwater pipe under Wekiwa-Piedmont Road, but this would require over a foot of water to be added to Lake Page before the drainage well could take on additional water.

With help from St. Johns River Water Management District (SJR-WMD), we quickly secured the additional permit from Department of Environmental Protection (DEP) to pump water directly from the ditch into the drainage well, but we needed to add one more pump to do it.

We needed to make sure the Orange County 100-foot storm-drain under Piedmont Wekiwa was clean to allow maximum water flow, which required our stormwater crew to blow out all the obstructions in the underground culvert.

We also needed to make sure that the vegetation in the ditch taking water from Blue Lake to the culvert was cleaned out as well. Our team at Apopka Public Services was permitted to dam up the stormwater ditch next to the Christ International Church and pump water directly out of ditch coming from Blue Lake and into the drainage well on Lake Page. This will save us over a foot of additional capacity in Lake Page for the

The SJRWMD has allowed the city to pump down Border Lake

from the current elevation of 76.74 ft. to 75 ft., Lake Jackson from 80.7 ft. to 79.5 ft., Lake McDade from 80.61 ft. to 79.5 ft., Lake Piedmont from 80.13 ft. to 79.5 ft. and Blue Lake from 77.32 to 76.5 ft. These lake drawdowns will give us plenty of capacity as the summer rains begin. Each of the five pumps will be monitored daily.

I would like to give a HUGE SHOUT-OUT to our engineering team, Apopka's water and wastewater crew, the stormwater team, Orange County Public Works, SJRW-MD and DEP for helping us to resolve this crisis. Each partner played an important role in making sure we got to the finish line. We can now focus on the long-term solution to move excess water from these lake basins and add that to our reclaimed water inventory. I have already had contact with DOT and Mayor Demings about our collective roles in solving the long-term flooding in the Border Lake-Lake Cortez basin.

First rule of the road: If you're not driving, good luck surviving

It is doubtful that anybody who has ever seen a track meet might call what I do "running." Or even "jogging." Maybe "slogging" would be the word for it.

My guess, just from what little eye contact I can make, is that the people who share the road with me would simply call it a "dadblamed nuisance."

This particular day I was on Sugarloaf Road in Hendersonville, N.C., a country lane about wide enough for two cars from ditch to ditch, or maybe most of one big pickup truck and a little over half a

The vehicles alone have enough trouble with each other. Nowhere in anybody's traffic plans was room left for one old man who is doing something that might one time have been called running.

The law supposedly favors pedestrians, but I've been doing this since I was in the Army over 50 years ago, and I have yet to meet a motorist who is aware that I have the right of way. Sometimes I wonder why I keep this up.

I have been told that I look like someone who is hurrying to the restroom, so it is apparent that I am not out to impress anybody. I'm certainly not making myself popular with local motorists.

The standard justification is that I am exercising because it is



good for my health, but I don't think that holds up to close scruti-

I breathe enough exhaust fumes to qualify as a heavy smoker, and there's not a part of my body that I haven't injured. My Achilles tendon causes the doctor at the VA hospital to make exasperated noises, and my meniscus one time did whatever it is that a meniscus does to cause it to swell up and hurt, and I had to hop 3 miles home in a hail-

Another time in Kansas City a rabbit darted across my path and I tried to jump over it, which left me with a sprained wrist, a torn hamstring and some blood on my baseball cap.

Poison ivy, dog bites, bee stings and a tree branch in the eye have been other health benefits. I have donated blood to sidewalks around the country while scraping off enough knee and elbow skin to

build a whole new idiot. I guess I could claim it is edu-

cational. A few thousand miles of hoofing along in running shoes on the same pavement used by cars and trucks has taught me how much I really matter to other people.

I have come to realize that my life is worth about four miles an hour of speed. That's how much the average driver will slow down in an effort to not kill the average pedestrian. Any more than that would be an inconvenience well beyond the value of anybody who gets in the

This can be depressing, but sometimes there is at least a little bit of grim humor involved. I just happened to be the third occupant of this little road when a car and a pickup truck passed going in opposite directions. The car was on my side kicking up gravel and dust. I tried to get over but there wasn't much room on the roadside. A rearview mirror came by at about 50 miles per hour, just a few inches from my face. The driver showed no sign of noticing me.

I could just make out the words on the bumper sticker as it sped

ALL LIVES MATTER.

Left unsaid was the message he delivered with his driving: EX-CEPT YOURS, IF YOU GET IN MY WAY.

millions in arts funding. Bracy Davis will run against Republican Willie Montague on Sep. 2 in the general special election.

"I also dedicate this victory to my father, Rev. Dr. Randolph Bracy, Jr., a man whose life was a testament to faith, perseverance, and purpose," Bracy Davis said. "Though he is no longer physically with me, I feel his presence in every step I take and every decision I make. His example continues to guide me, and tonight's victory is as much his as it is mine."

Anthony-Smith and Grayson had previously shared their visions for the district at a <u>forum</u> held in Apopka, although the Bracy siblings did not attend.

The governor announced the special election after Sen. Geraldine Thompson <u>died</u> from knee surgery complications on Feb. 13. Following three decades of service in the Orange County education system, Thompson served in both

the Florida House of Representatives and the Florida Senate. She also authored Black America: Orlando, Florida, establishing herself as a historian.

"I recognize that I am standing on the shoulders of the greats who came before me—

especially my mentor, the late Sen. Geraldine F. Thompson," Bracy Davis said. "I promise to carry forward her legacy with integrity, courage, and a deep commitment to justice."

The western side of Florida Senate District 15 covers Apopka, Lockhart, Clarcona and Ocoee, with Florida's Turnpike serving as its southwest border. I-4 serves as the eastern border, and it intersects with Florida's Turnpike just north of the district's southeastern border.

Bracy Davis announced in April her resignation, effective Sept. 1, from her House District 40 seat to run for the open Senate seat. Her legislative aide RaShon Young won Tuesday's Democratic primary to fill her current seat in the

House. Young credits Bracy Davis as his mentor.

"RaShon has been in the trenches with me from day one," Bracy Davis said on Young's campaign site. "He knows the district, he knows the issues, and he knows the people. I wholeheartedly and proudly endorse him to be my successor."

Young ran against former state Rep. Travaris McCurdy, who had served as legislative aide to both Thompson and Bracy. McCurdy posted a statement on Instagram after the loss.

"While tonight's results weren't what we hoped for, I remain proud of the campaign we built, the conversations we had, and the vision we put forward for District 40," McCurdy said. "Your belief in a better future fuels me to keep fighting, in the community, through advocacy, and wherever I'm called to serve next."

Orange County will hold the special general election for both races on Sept. 2 from 7 a.m. to 7 p.m.

"To everyone who knocked a door, made a call, said a prayer, or cast a vote: thank you," Bracy Davis said. "We ran a campaign rooted in truth, compassion, and service, and the people responded. I look forward to running this same caliber of race for the general election in September."

Bracy and Young did not immediately respond to requests for comment.

long-term cemetery fund investments in low-fee equity and cash funds.

On June 18, Morgan Stanley financial advisors Trisha Mingo and Glenn Scott presented the City Council with an overview of the city's investment portfolio and advised how to manage it.

After giving an overview of the interest rate trends and economic forecast, Scott recommended the IPS modification to allow for investments in low-fee, passive, broadly based equity funds and lowyield cash funds. This would create a diversified portfolio that balances equity and cash exposure, ensuring long-term capital appreciation.

Scott said it was "probably a good idea" to move the \$10 million out of Synovus and invest it in only treasuries.

"I don't think there's any reason to be going out and doing any ... highly rated corporate securities," Scott said. "Stay safe. Stay liquid, keep it simple. Keep it safe just as we go into these uncertain times."

The city's 2025 first quarter portfolio has \$136 million in cash, \$24 million in money market funds and \$64 million in fixed income securities, with a book yield of 4.298%, according to Mingo.

The breakdown of investment buckets is as follows: 61% in demand deposits at Seacoast and Synovus banks, 26% in U.S. govern-

ment treasuries, 10% in local government investments (State Board of Administration, or SBA), 2% in corporate notes, and 1% in money market funds.

Because Synovus exceeded the 50% threshold per the investment policy, \$10 million must be moved out of that bank. Mingo presented three options for where the \$10 million should be moved to: Seacoast Bank, which is yielding 3.45% as of the end of May;

the SBA, which was yielding 4.48%; or new securities that could be found for the city to invest in.

"Normally, we will do two \$5 million investments for the city, but we just need to go ahead and get that money moved out of there to get back in alignment with the IPS (investment policy statement)," Mingo said.

During council discussion, Scott recommended that commissioners give his firm

discretion to decide based on the rapidly changing economic environment. He asked for two weeks to select which bank to transfer the \$10 million to and whether it should be all at once or split up.

Commissioner Nick Nesta said he was comfortable with the proposed investment strategy and asked how much was earmarked in the cemetery fund. City finance director Blanche Sherman said about \$130,000.

governor then signed into law and co-sponsored nine other successful bills. This week. he shared his written reflections on the session in response to questions from The Apopka Chief, including following up on the predictions he made in February.

This interview has been edited for clarity and length.

Q: In an earlier interview with the Chief, you predicted that the legislative session would prioritize immigration, insurance, and fiscal policy. How were those priorities handled?

Bankson: Though these were all a part of the overall focus, the main priority seemed to be fiscal policy and the tax environment overall, with a bit of battling as to how to get it accomplished. The end result was a balanced budget and a \$1.3 billion reduction in taxes. We were also able to replenish the popular My Florida Home funds as the state and homeowners continue to recover from the past storm damage and harden homes against future

I was pleased that my bill to repeal the tax on the purchase of precious metal bullion under \$500 was included in the tax package. This will especially benefit those on the lower end of the economic spectrum to be able to begin building their future economic stability.

I'm also thrilled to announce that we were able to completely end the business rent tax, which will be a real benefit to small businesses.

The budget is, of course, still subject to the governor's

it is approved, the budget will go into effect on July 1.

Q: You also mentioned that House Speaker Daniel Perez asked representatives to use the word "budget" instead of "appropriations." Do you believe that slight change in language made a difference?

Bankson: Yes, I do, not only because of the imagery it creates to think like the average Floridian must with their own budget, but it was his constant theme. He stressed both parties taking ownership of spending patterns and remembering that the economy best flourishes when in the hands of the citizens. We had a couple years of increased spending due to CO-VID money flowing in, but if we continued on that course, we would burden future legislatures, ourselves and our children with difficult challenges. I am pleased with his responsible with the future as well as meet the needs of to-

Q: Your top priorities this session were education and workforce. What did their respective committees accomplish this session?

Bankson: I am pleased that we were able to raise teacher salaries for the third straight year—actually the fourth under the governorand continue to face the challenges of funding education overall while preserving the wildly popular school choice agenda. Following up with last year's bill to deregulate the public schools, we continued to focus on ways to better the whole picture of education in Florida, again turning the focus to the student and empowering parents to make the best choice for their child.

There were some bills that had promise that didn't

but we were able to pass the Apprenticeship and Preapprenticeship Program Funding bill (HB 681 Melo/DiCeglie), which reduces bureaucracy to prevent administrative costs from draining resources while aiming to strengthen Florida's skilled workforce. The bill will provide individuals with invaluable hands-on training while preparing them for successful careers.

Another great bill was the Aerospace Industry bill (SB 1516 Wright/Kendall), which the governor signed into law at the Paris Air Show. This bill establishes the intentional aerospace innovation fund (IAIF) administered by Space Florida. IAIF will accelerate global aerospace innovation by funding collaborative research and development projects, workforce development initiatives and commercialization efforts.

He also signed the trans-

portation bill in Paris, which was a bill I co-sponsored (SB 1662 Collins/Abbott/Bankson). This bill included the vertiports legislation I've championed for the last couple of years, finally making it into law and encouraging the further development of industry and jobs in an emerging market.

Q: How did your work on the Apopka asbestos pipe replacement turn out this session?

Bankson: I am thrilled to report that we were able to get this to the governor's desk with an amount of \$1,057,500 in local funding toward the project. This was a challenge, but I made it a top priority of mine and have sent a followup letter to the governor asking for his support to keep this in the budget.

I'll also mention I was able to get \$1,750,000 in the budget for the Winter Garden Crest Ave. Wastewater Treatment Facility, which affects our beloved Lake Apopka. Special thanks to Senator [Keith] Truenow for his support in getting both of these projects through on the Senate side.

Q: How will the city of Apopka improve as a result of this session?

Bankson: As a state representative, I now serve not only Apopka, but much of western Orange County and part of western Seminole County as well. With approximately 185,000 constituents, my thinking must be broadbased. However, my heart is still home here in Apopka. I believe all that we have done will benefit all of the district and individuals in particular.

I was pleased to get fund-

ing for Camp Thunderbird, which serves our developmentally challenged community. The STEPS facility in Apopka was also included in the budget, providing much needed funding for women's residential integrated treatment services.


I was also able to get funding included for Ocoee Fire Station 38, which borders our city and serves our residents on the southern side.

The varied tax holidays will also benefit us, from the permanent back-to-school tax holiday for the entire month of August to the new hunting, fishing and camping sales tax holiday from Sept. 8-Dec. 31. We've also permanently eliminated sales tax on disaster preparedness supplies.

We also included a \$35 million tax credit program to spur private capital and job growth in Florida's rural communities, as farming is such an important part of our local economy.

We also have made allowance for local governments to reduce or repeal certain local discretionary sales surtax by a two-thirds vote of the body and require local government to propitiate the use of local CST [communications services tax] revenue for the timely processing of right-of-way permit applications for utilities.

Finally, we created the Home Away from Home Tax Credit to incentivize donations to help house families of critically ill children receive the care they need, as well as providing property tax relief for leased spaces used by high-quality, gold seal-certified childcare facilities.

relationships with customers, working with three generations of customers from same families. He praised his Apopka bank staff as outstanding.

"They're the best I've ever encountered," he said. "And I don't say that with any hesitation."

Being a banker comes with its challenges too, especially with what he called a "tough" regulatory environment and evolving technology. As he spoke with The Apopka Chief, Rankin was waiting for someone to arrive at his office to fix his lockeddown computer.

ty banker is, it's just very rewarding, seeing people that you've helped out and watching them and their businesses succeed," Rankin said.

Rankin recounted a customer he first had in the 1990s, to whom he loaned \$25,000 to start a business and whose father co-signed the loan. Now that business makes over \$2 million, and the customer keeps over \$1 million on deposit with Rankin's bank.

An advice Rankin would give to young bankers are the importance of hard work and finding solutions rather than excuses.

"There are two kinds of people in this world ... those that find a way, and those that find an excuse," Rankin said. "I've always been one of those that says, 'Don't tell me I can't do something, because I will find a way.' But hard work ... With this industry and being a community banker, you get out of it what you put into it. So, people that give it a halfway effort, you won't make it, but you won't make it in anything."

Born in Danville, Kentucky, Rankin moved to Sebring, Florida, in 1966, before settling in Apopka in 1985. He married his wife Gini in 1985 and they have one child, Andrew. Their son is a graduate of the University of Central Florida and served in the Marine Corps. He currently lives in Colorado and recently became engaged.

Amaris Diaz, One Florida Bank Apopka branch vice president and manager, has known Rankin for over 20 years and described him as a mentor. She praised him as someone who is authentic, brutally honest, and has a

strong work ethic. "My banking career has taken a turn for the better," she said. "If it weren't for him, I would have left bank-

ing years ago." Rankin now lives in rural Lake County, but still often eats out with people from Apopka.

"Just because I'm retired doesn't mean I don't want to see my friends or change my routine," Rankin said. "If I can help in anyway, something in Apopka, call me. I'll be happy to do it."




St. Johns District continues work on \$204M water projects

Wekiva River is home to many state springs

The St. Johns River Water Management District (SJRWMD) continues to focus on the Wekiva River in Apopka and its surrounding area as part of the agency's various science-based initiatives to help safeguard Central Florida's water future.

According to an SJRW-MD press release, the district continues to establish and update Minimum Flows and Levels (MFLs), which are science-based thresholds created to protect serious harm

Seven existing MFLs in Central Florida are being reevaluated. A new one is proposed for the Little Wekiva River to boost protection of smaller springs like Palm, Sanlando and Starbuck.

With the Central Florida

population now at 3.4 million and counting, the district is helping to create comprehensive water supply plans that would help maintain Central Florida resources' sustainability decades into the fu-

Such efforts are part of the Central Florida Water Initiative (CFWI), a collaborative partnership between the St. Johns River, South Florida and Southwest Florida water management districts, the Florida Department of Environmental Protection, the Florida Department of Agriculture and Consumer Services, local governments, utilities and other stakeholders.

To date, the SJRWMD

has put \$35.7 million in CF-WI-area projects that collectively total \$204.5 million in value.

"Ensuring a sustainable water future requires fore-sight, innovation and strong partnerships," SJRWMD assistant executive director Mary Ellen Winkler said in a statement. "By working together and planning ahead, we're building a resilient water supply not just for today, but for the next generation."

The Wekiva River — designated as both a National and Florida Scenic and Wild River — and its surrounding region is home to many Outstanding Florida Springs, which spring systems that are granted protection and spe-

cial recognition under the Florida Springs and Aquifer Protection Act.

The SJRWMD collaborates with local agricultural operations like Cherrylake in Lake County, which has completed six cost-share projects to increase irrigation efficiency, conserve water and improve water quality.

In addition, the district keeps investing in water conservation programs and groundwater recharge projects that expand existing supplies and protect natural systems including Florida's springs.





Davison transfers to Ocoee for senior season

Three-year starter wants to improve his scouting opportunities

After weeks of rumors and speculation, The Apopka Chief confirmed this week that Tyson Davison, Apopka football's starting quarterback for the last three seasons, will be playing for the Ocoee Knights for his senior

season

The confirmation comes from multiple sources, including the Davison family and Jett Davison, the current Ocoee High School offensive coordinator and former Apopka High School offensive coordinator. Coach Davison and Wendell Davison, Tyson's father, told the Chief that Tyson would play for the Ocoee Knights football squad this fall.

Both sources confirmed that Tyson has been practicing with the Knights for the past few weeks but has been waiting to make an official announcement until he was enrolled at Ocoee High School.

"I am excited for this new opportunity and a chance to compete with this new group of guys," Tyson Davison said in a phone interview.

In a separate phone interview, Tyson's father said college recruiting was one of the biggest reasons Tyson decided to step away from the Blue Darter football team. As a senior, Tyson is in the middle of one of the most critical six-month periods in his ath-

letic career. It's all or nothing right now as he tries to get an offer from a Power Four school.

His father also said that Tyson is working hard to graduate by December so that he can start training with his college team in the spring.

Tyson's father said college recruiters told him they need to see certain things out of Tyson this year, which they have not seen in his film at Apopka. He needs to start the season off hot and on a

Jhenelle Francis redefines meaning of student-athlete

Francis claims 4.0 unweighted GPA, national ranking in flag football

Jhenelle Francis is a recent graduate of Apopka High School who was a keystone in the success of both the girls basketball and flag football teams. But Francis was more than just an exemplary athlete — she was a top student and standout member of the Apopka community.

Flag Football

Francis is ranked nationally in multiple flag football stats and was awarded the Orlando Sentinel's Flag Football Player of the Year. She was ranked 113th in passing yards (1,527 yards), third in rushing yards (1,733 yards), 29th in total points (137), 31st in total touchdowns (20), and 32nd in total yards (3,300 yards).

Francis was the No. 1 option on offense, both on the ground and through the air, in her first year as Apopka's starting quarterback. She compiled 1,527 of the team's 1,582 passing yards and all 14 passing touchdowns. She also tallied 1,733 yards of the team's total 1,780 rushing yards and all 20 rushing touchdowns.

Every point scored by the Apopka flag football offense this season came from either Francis' arm or feet.

"I enjoyed playing quarterback because it was so much more difficult," Francis said. "I've never been put in a situation like that where I had to throw the ball and make

decisions on that side of the ball. I'm just usually the one catching it."

Francis led her team to a monumental season, during which they competed for the 4A FHSAA Girls Flag Football Region 1 championship. The team piled up 11 wins and only one loss before entering the postseason, leading Apopka to a No. 1 seed in the district tournament.

After winning district, Francis led Apopka to wins over West Port and Mandarin, 41–0 and 27–0, respectively. But in the regional championship, the Blue Darters faced an undefeated Spruce Creek squad that would go on to beat Apopka,

Francis said flag football has been a big part of her life since she was a young athlete, but she never saw it becoming such a popular sport.

"I remember in middle school when I first started playing, I honestly didn't even know it was a thing," Francis said. "I just tried out to try out, and now, seeing that there are younger girls than me playing, it just means so much to me."

Basketball

Francis is not just a star on the football field, though. She has been on the varsity girls basketball team since the 2022–2023 season.

Francis said basketball was never really her first love — it was more of a chip on her shoulder.

"Most people looked at

Athletic director provides coaching, complex updates

Apopka to start interview process for new baseball coach in July

Apopka High School Athletic Director Aaron Crawford says the search for a new baseball coach is progressing, although more slowly than the rapid search to fill the school's open football coach position.

In early June, Apopka's former coach, Bobby Brewer, stepped down after six seasons at the helm of the program. After compiling a 91–48 record, a 2022 regional semifinal appearance, and three district championship game appearances, Brewer cited a loss of joy as his reasoning for stepping down.

"You got to have fun doing this," Brewer said.
"It's just to the point where things ain't like they used to be."

Crawford told The

Apopka Chief last week that the school had just begun the process of searching for a new baseball coach. He said that he and Principal Lyle Heinz have many quality candidates.

Crawford said the interview process would start in July. Crawford said his tentative goal is to have someone in place for baseball by the end of July so he can start in time for fall ball.

"We have received resumes from several qualified candidates for the head baseball position," Crawford told The Chief this week. "Our goal is to thoroughly review them at the start of July and have a coach in place in time for the fall season, which starts on the Tuesday after Labor Day. We feel that the position is an attractive one, especially with the unique history of the program, combined with what we feel is one of the best communities in Central Florida to support it."

Hello Folks,

The fishin' isn't too bad even with all this heat, and folks are gettin' on the water real early and takin' advantage of the mornin' bite. You will do best with noisy topwater baits to get their attention. It's one of the most excitin' bites there is when that ole big bass blows up on your

Once the sun gets up you will have to move to deeper and cooler water. Try and find some submerged hydrilla and eel-grass beds, or shellbeds. Folks are catchin' some nice bass in the Harris Chain by fishin' these three areas. Also, docks are good durin' this time of the year.

We have a new moon this week, so that should get the fish to bitin' in most of the lakes in our area. Folks are still catchin' plenty of panfish in most of the lakes.

The Kissimmee Chain is still producin' some nice stringers of panfish. Red worms and grass-shrimp have been workin' the best.

The bass are still bitin' real good in West Lake Toho. Folks are takin' 4-hour trips and catchin' some nice bass on shiners. The Head Waters is still

fishin' good for bass. Folks are gettin' on the water real early and catchin' some bass on shiners as well. The bass fishin' on the

Butler Chain is about the chain. same. Folks are gettin' on the water early and catchin' some

keeper size bass.

Most all the lakes are fishin' good, with Lake Butler and Lake Tibet producin' some nice bass. Most of the bass are bein' caught on lipless crank-baits, plastic worms, and slow sinkin Senko type baits. You can also catch some bass on the chain by usin' a top-water bait at first light.

Once that ole sun gets up, you need to fish the submerged hydrilla and pepper grass patches throughout the

On Wednesday nights there is a local bunch of guys

who fish a 3-bass tournament on Johns Lake. They call it the Wednesday Night Shootout. Last week the team of Gary Batchelor and Lou Gibbs won with 3 bass that hit the scales at 12.50 pounds. They also had a big bass that weighed in at 7.85 pounds. So if you want to get out of the heat durin' the day, try fishin' at night.

If you have been on Lake George lately you will see the efforts of the FWC efforts to restore fish and wildlife habitat on Lake George. The FWC started this program back in 2020. They planted

over 110 acres of eel-grass in the lake. The lake had lost alot of it's eel-grass due to hurricane Irma.

Please be careful if you're fishin' along the shoreline and make sure you see the fencedin areas where the eel-grass is growin'. They have reflective tape on top of the poles for night-time navigation.

Well, that's it for this week. I hope you get a chance to do some fishin' and have a great week.

roll, as most teams will have made recruiting decisions by the end of the season.

With a young and inexperienced team left in the wake of other transfers and the departure of head coach Jeff Rolson, Tyson had to make some tough decisions, Wendell Davison said.

Tyson has been and always wanted to be a Blue Darter, according to his father, and bleeds blue and white. He said Tyson was a part of the program before he was even on the high school

"Nobody was more Apopka than Tyson," Wendell Davison said. "I remember he was 6 years old; he cried like a baby when they lost the state title game in the Citrus bowl. And he promised he would bring the title to the city, and he almost did his freshman year."

For six years, Tyson has worked alongside Rolson in the program, starting as a ball boy in 2019, three years before his freshman season.

"It was a decision that was a hard one, and one that Tyson made himself... one that he didn't want to make, Wendell Davison said. "It was very difficult for him to make that decision. He brought it to me and talked to the coaches about it. And it's still something I don't think he wanted to do, but he felt like he had

Tyson's father emphasized that no one from Ocoee High School ever reached out to him or Tyson to ask him to come be a Knight. Tyson

made this decision independently after weighing all his options and prioritizing his future.

Tyson and his father agreed that the Apopka football program and its coaching staff deserve praise for their efforts. Still, they acknowledged the need for a different environment. Tyson's father said he appreciates and respects Rolson and his coaching staff more than anyone

"Honestly, if you look at his record, Coach Rolson has done more with less than anybody in the state," Tyson's father said. "Just look at what he's done. He's gone to the state title three times, and each of the three times he went to the state title game, he's done it against these power teams." But the landscape of high

school sports is changing. The transfer portal and the formulation of stacked programs have put Apopka football in a tight spot. Apopka football has always been about homegrown Apopka kids who work harder than anyone else to put a winning team on the field. Tyson's father said that's not enough to compete with these power teams anymore, as we have seen these past few sea-

This summer has been busy for Tyson as he has visited different colleges and universities and worked out with their football programs. He recently returned from visits to the University of West Virginia and Arkansas.

"A lot of people are not aware that he's a high GPA kid, and that's all thanks to Apopka," Wendell Davison said. "They put him in this position. He's been educated in Apopka his whole life. That's a very big deal to him and one of the reasons he's so proud of being a Blue Darter."

Over the last two seapassing yards, eight passing touchdowns, seven interceptions, and a completion rate of 47.6%. He also racked up 1,399 rushing yards and seven rushing touchdowns.

The biggest lessons I learned from Apopka were that hard work and discipline are essential to being a student-athlete and part of building character while representing your team, school, city, and yourself."

Apopka and Ocoee are set to face off in their annual season opener at Ocoee on Friday, Aug. 22. Apopka has won all three matchups since the two schools started opening their seasons against each other. Tyson said he is looking forward to a hard fought game and knows that Ocoee and Apopka will treat this game like a playoff game.

"We're not going to look back," Tyson's father said. "He's going to give the same effort to the Ocoee Knights. So, it's going to be different coming out of a different tunnel and seeing Apopka across the field from him. But that game on August 22 will be charged up, so everybody get your ticket loaded."



me as more like a track athlete," she said. "Once I heard that people were doubting me and doubting my basketball skills, I made sure that I focused on that and proved them wrong."

In the 2023-2024 season, she averaged 4.5 points, three rebounds, two assists and 2.7 steals per game. This season, Francis averaged 11.5 points, 2.2 rebounds and 4.9 steals per game.

The team had a less-thanspectacular run, finishing with a 9-13 record, but Francis had a great season. She had a season-high of 23 points against Osceola in mid-January and three games with 20 or more points.

A standout student

Francis is an elite athlete, but when paired with a 4.0 unweighted GPA, a 5.6 weighted GPA, an AP Scholar Distinc-

tion, being the vice president of Beta Club, historian of Mu-Alpha-Theta, Senior Class Council vice president, as well as being a member of a plethora of other clubs focused on creating a better community,

including the Apopka Youth Council, her resume becomes truly remarkable.

Balancing responsibilities as an athlete and an AP and dual-enrolled student was hard for Francis, but she at-

tacked it head-on.

"I'm someone that really likes to be challenged," Francis said. "So I make sure I demonstrate that throughout my coursework and my workload. I really enjoy taking AP

and dual enrollment classes, so I make sure that I have a schedule that's jam-packed with those because they really interest me."

Francis has not made her final decisions about the next steps in her academic and athletic journey as of late June. Her love for flag football makes her want to keep playing, and her dedication to her academics makes her want to attend a top university, but there are no Division I flag football programs. If she wants to continue to play, she might have to sacrifice where she wants to attend school.

"It's hard because it's such a unique choice that you have to make, especially with flag football," Francis said. "I am stuck between two career paths after graduation, and I still have no idea what college I want to attend."

No matter what the next step in Francis' journey is, she has cemented her legacy at Apopka High School. Her impact on the field, the court, the classroom, and the community has set a standard for what it means to be a student-athlete.

the school and the athletic department still need to establish a new time frame for finishing the new baseball and softball complexes before proceeding with the coaching search.

The new Apopka baseball and softball complexes were supposed to be finished and operational by the start of the 2025 season, but that didn't go as planned for Apopka High School.

By the start of the season, both field and complexes were far from being completed, leading to Apopka baseball and softball teams playing on the road for the

first half of their seasons. The softball team played its first 10 games of the season on the road, posting a stellar 8–2 record. The baseball team played 14 straight road games to start the season and compiled an 8–6 record.

By March, Apopka baseball and softball had yet to play a home game. Apopka High School and the Orange County Public Schools acting chief facilities officer, Rory Salimbene, stated that the facilities were still unfit for oc-

Beyond delayed construction issues, players, parents, and fans of the baseball team

raised other concerns. Problems with design and construction consistency, a lack of safety features like foul netting, and the removal of a viewing window in the concession stand left those in the Apopka baseball community unhappy.

By late March, Apopka baseball and softball were allowed to use their fields, but they were far from finished products. Also, at the end of March, OCPS and Apopka High School said they would take the summer to fix all the remaining problems with both

of the Apopka softball team was very happy with how their field and complex turned out even after the delay. He said that now that the facility is so amazing, the quality of play needs to be improved as well.

"We challenge our players to put a product and team on the field that matches the quality of the facility," head coach Mike MacWithey said after their first home win of the 2025 season. "We've done our part (in building the complex); you need to do your part on the field. It's your responsibility to do that



Police Alumni Association. She says, "I use Minute Rice. These ingredients can be adjusted according to taste. I use more pepper and onion and a small jar of pimento. All can be adjusted, more or less according to your individual taste."

Southwestern Corn Bake comes from Pot-Pourri of Zellwood. This particular recipe was the 1st Prize Winner of NOCIA's 1981 Zellwood Sweet Corn Festival. The recipe calls for fresh-cut corn, of course!

From the book, Field to Feast, we have a wonderful fresh salad using baby greens, strawberries and lime vinaigrette. The recipe comes from Gary Wishnatzki, third generation owner of Wish Farms, who is the grandson of Russian immigrant Harris Wishnatzki, a fruit and vegetable pushcart peddler in 1920s New York City. 
