## Plan board okays Paulucci Acres with 1,000-plus homes

New development to span 618 acres

The Apopka Planning Commission recommended approval of two future land use maps for Paulucci Acres, which is poised to bring more than 1,000-plus homes to a development in the heart of Apopka.

The Planning Commis-

sion voted on the maps, one for a proposed residential use and the other for proposed commercial use, as separate action items at its Tuesday

Ordinance No. 3125 is for the residential future land use amendment of 39 acres from county low density to city residential low suburban for Paulucci Acres.

The 39-acre property is located on the east side of Vick Road, approximately a quarter of a mile north of

the Vick Road/West Lester Road intersection. The parcel is owned by Paulucci Acres LLC.

Ordinance No. 3126 is for future land use amendment of about 5.78 acres located on the south side of Ponkan Road and west of Jason Dwelley Parkway. The future land use amendment is from residential low suburban to commercial.

The applicant on record is Daniel O'Keefe, partner with the law firm Shutts &

On Aug. 6, the Apopka City Council unanimously greenlit annexing 39 acres for Paulucci Acres into the city proper. At the same meeting, the council approved a resolution that would vacate a 1.52-acre right-of-way for the planned development. The right-of-way was platted but never improved and is located north of Woodside Ridge Drive and Misty Glen

## Apopka World War II veteran celebrates 100th birthday

Mayor proclaimed Aug. 7 Carl Philip Johnson Jr. Day

Apopka World War II veteran Carl "Phil" Philip Johnson Jr. celebrated his 100th birthday on Thursday, Aug. 7, at Solaris Healthcare Forest Lake. Balloons, a birthday banner, and special guests gathered around Johnson's bedside as Johnson watched his upstairs birthday party via Zoom.

"I feel just like I did yesterday," Johnson said.

Johnson was born on Aug. 7, 1925, in Chicago, Ill., according to a proclamation from Mayor Bryan Nelson. After attending South Shore High School, he studied at the University of Illinois.

Johnson entered the U.S. Navy in November 1943 at Farragut Naval Station in Idaho, according to Johnson's statement in the United States Navy Memorial Navy Log. After completing boot camp and Navy Electrician's School, Johnson served on the USS Saratoga

(CV-3) starting in June 1944. According to the United States Navy Memorial website, Johnson started his naval career carrying supplies. But

a typing class he had taken in high school gave him the ability to advance.

"I was lousy at [the typing class], but I took it because it was all girls," John-

At the end of the semester, his teacher asked to speak with him.

"She said, 'Philip, I'll

give you a C if you promise not to take Typing II," Johnson said. "So I kept my

word." Johnson's role as Machinist Mate, Third Class, granted him relative safety until Feb. 21, 1945, when kamikaze planes attacked the

USS Saratoga. "I was below decks when

a squadron of Japanese suicide planes attacked the USS Saratoga," Johnson said in the Navy Log. "Some of them got through — five direct Kamikaze hits and seven direct bomb hits. Obviously, I survived, as did 'Old Sara,' but 123 shipmates did not and

## **Ballot error affects** almost 89K Orange **County voters**

Special election ballots displayed wrong name

The Orange County Supervisor of Elections Office admitted a printing error it made on the sample ballot it mailed out for the upcoming special election in Senate District 15 and House District 40, affecting 88,972 voters.

For voters in House District 40, the sample ballot mailed to voters incorrectly listed Travaris Mc-Curdy as the Democratic candidate in the House District 40 race, when the correct and certified Democratic candidate is RaShon Young, the Supervisor of Elections Office said in an Aug. 9 news release.

Young gained 55.44% of voter support in the Democratic special primary

election on June 24.

This error only appears on sample ballots mailed to voters who have not asked for a vote-by-mail ballot, according to the elections office. All vote-by-mail ballots that were dispatched to voters are correct and accurately reflect the certified candidates for the election.

Voters casting their ballots by mail will not see this error, nor will in-person voters see it when casting ballots at an early voting site or their designated polling place on Election

"The Orange County Supervisor of Elections office takes full responsibility for this mistake," Blake Summerlin, a spokesperson for the supervisor's office, said in a news release distributed over the weekend. "We have tracked the error and found it originated in our office during artwork

## New fire station long time coming

Back in the brand AdventHealth Hospital Apopka-Ocoee Road was no longer in need of the construction trailer on the rear of the property. With the growth in the southwest quadrant of the city, it was a great place to

begin serving the area with a new fire er end of Harmon Road. station.

We took over the old double-wide trailer, added a fire truck and ambulance with a crew, and we were off and lowering the response time for the residents in that area.

In 2021, with the cooperation from the Central Florida Expressway Authority (CFX) and AdventHealth, we were able to do a three-way land swap giving Apopka the needed land to build Fire Station 6. In that same year, then Sen. Randolph Bracy and then Rep. Kamia Brown were able to secure an appropriation of \$1 million dollars from the state Legislature to help with the construction of Fire Station 6.

The city also began to design and build the Harmon Road extension, giving better access to CFX's Maitland making this project possible. This new Boulevard (414) and helping to reduce the time needed to get to Fire Station 6 as well as AdventHealth Hospital.

Last year, AdventHealth began the build-out of the fifth floor of the hospital and needed to remove the temporary trailer to be able to add additional

parking for the increased bed count. Our Fire Department team moved our temporary fire station a half-mile down Harmon Road with our firefighter's living quarters in the adjacent apartment complex.

Although not ideal, it gave us time to complete the new station on the oth-

Last Friday, we celebrated the grand opening of the new fire station, an 8,000-square-foot building that will accommodate up to 21 fulltime personnel over three shifts, and three emergency response vehicles, including a quint, an ambulance, and an EMS captain.

This state-of-the-art facility will serve the residents of southwest Apopka, and we are proud to add this new life-saving amenity to the area. We would also like to thank CFX and AdventHealth for their partnerships, which enabled us to complete this project for the benefit of the community as a whole.

We also wish to thank all the city staff members who played a part in station played a part in Apopka being re-certified as an ISO 1 Fire Department, which less than 1% of all fire departments across the country obtain.

We are proud of all of our first responders and the life-saving work that they accomplish.

## **Orange County heading toward** redistricting vote next month

Think back to 2024. In Orange County, voters approved a measure to add two new county commission seats to Orange County government when asked the question on that November's ballot. The commission will become a nine-member board with eight commissioners and one county mayor.

Since January of this year, the county's redistricting process has been in full swing. The Redistricting Advisory Committee is charged with establishing the new district boundaries and incorporating the two additional districts. To that end, committee members have pored over maps with input from many citizens.

In September, the committee will submit a non-binding recommendation to the Orange County Board of County Commissioners for review. The process centers on creating maps **County Commissioner** District 2



which distribute population equally among all districts. This Geographic Information System (GIS mapping) creates maps and analyzes real-time impacts of boundary changes on key factors like demographics. You can see the maps that have been suggested for use so far.

You can also attend the next Redistricting Advisory Committee meeting taking place 6–9 p.m. on Monday, Aug. 18, at the Orange County Administration Center, BCC Chambers, 201 S. Rosalind Ave. in Orlando. On Wednesday, Sept. 3, at the regular Board of County Commissioners' meeting, I along with my colleagues will be asked to adopt a proposed redistricting plan.

Orange County has placed a high priority on community input and public engagement. Citizens can expect to be able to participate in public meetings regarding mid-decennial redistricting and to also have access to a webtool that permits them to try creating the eight commission district boundaries. You can try your hand at creating a map.

Main Street Apopka commissioned and planned the Downtown Mural. Apopka Murals, a local art program that aims to beautify downtown with public art, helped Main Street Apopka select the site and installation timeframe.

The murals in the downtown area illustrate Main Street Apopka's focus on breathing new life into the historic area using Main Street America's four-point approach: design, promotion, economic vitality and organization.

"This artwork was care-

fully curated to be a vibrant, enthusiastic expression of many significant characteristics within our local community," an Aug. 12 email from Main Street Apopka said.

A self-taught artist, Bonnick has been creating professional murals and art across the state for the last two years. He has painted murals all over Central Florida, from Orlando and Daytona/New Smyrna to Windermere and Longwood.

Organizers believe commissioning local artists like Bonnick and publicly honoring their contributions boosts interest in Apopka and draws attention to local businesses.

"Our hope is for this mu-

ral to attract local attention to the area and its many artistic works and to become an iconic photo spot for daytrippers visiting the springs, drawing them into our historic downtown area and showcasing our restaurants, cafes, and local scene of our small businesses," the Main Street Apopka release said.

## State turns down 2025 Orange County comprehensive plan

Some parts of plan conflict with new law, letter from state says

The Florida Department of Commerce turned down Orange County's 25-year comprehensive plan, saying the plan conflicts with a newly passed state law regarding emergency management and disaster recovery in the state,

especially after hurricanes.

In spite of this obstacle, Orange County will keep applying Vision 2050 and Orange Code, both of which the Board of County Commissioners officially adopted on June 3.

Vision 2050 shows the blueprint for Orange County's growth over the next 30 years. Orange Code sets up the development guidelines necessary to make this blueprint a reality.

"The existing Comprehensive Plan and Zoning Code

will continue to apply to all Chapter 2025–190 of the Florland use, zoning, and development matters until further notice," the Orange County's Vision 2050 and Orange Code website states.

In a July 28 letter to Orange County Mayor Jerry L. Demings, the Florida Department of Commerce declared that after reviewing Vision 2050, the county's comprehensive plan is "null and void" because some parts go against Senate Bill 180. Gov. Ron DeSantis signed the bill into law last June and it is now

ida Statutes.

Among its requirements, the law prevents local governments within 100 miles of a hurricane's path or areas under federal disaster declarations from proposing or adopting moratoriums on reconstruction or redevelopment of any hurricane-damaged property. The law's restrictions are in place until Oct. 1, 2027.

Orange County submitted amendments to Vision 2050 to the state on June 12 and, after reviewing the doc-

ument, the commerce department concluded that the document doesn't follow the new state law.

ed amendment is more restrictive or burdensome [than state law], making it null and void," the Department of Commerce letter states.

"Orange County's adopt-

The Orange County website laid out its next course of action in response to the state's decision.

"Orange County staff intends to meet with representatives from the Florida Department of Commerce to gain a clearer understanding of their concerns and to receive guidance on appropriate next steps," the Vision 2050 website states. "We are also preparing for future engagement with the Board of County Commissioners to discuss the matter and seek direction."

Orange County said on its website it will share more information as soon as it becomes available: "We're committed to transparency and will keep the public updated throughout this process."


Florida Congressman Daniel "Dan" Webster (R-

Clermont) addressed the One Big Beautiful Bill Act during a Lunch and Learn hosted by the Apopka Area Chamber of Commerce on Wednesday, Aug. 13.

President Donald Trump signed The One Big Beautiful Bill into law on July 4. According to the White House, the law funds the Golden Dome missile defense system, strengthens Medicaid, and more. But many parties found the law upsetting.

"Fiscal conservatives hated the massive spending and budget trickery," TIME senior correspondent Philip Elliott said. "Centrists despised the deep cuts to programs for the poor and elderly."

According to Webster, the bill also benefits small businesses, including several members of the chamber. Webster said before Trump signed the law, small businesses could not expense company assets in the first year. Now, they can save more money.

"If you're in business and you buy a truck for \$30,000, you can write off all \$30,000 in this tax year," Webster said.

The bill also makes tips and overtime pay tax-exempt, Webster said. He also mentioned the usefulness of the child tax credit, which will provide \$65,000 more per year to the Webster family.

"I've got 24 grandkids," Webster said. "Maybe they'll spend it on their granddaddy."

Ultimately, Webster sees the law as a step in the right direction.

"It does something for everyone," Webster said. "It helps everyone. It gives people an extended chance to hope."

Florida's Congressional District 11 includes western Orange County, including Apopka, and extends north to The Villages and south to the edge of Lakeland.

After spending over 90 minutes in a workshop, there was no agreement between the city and residents over a solution to mitigating the flood waters in the Clear Water Lake area, which impacts four local communities.

The Monday workshop at Apopka City Hall was a continued conversation of the July 16 presentation about the options presented at Clear Water Lake.

At the July 16 City Avian Pointe Community

Council meeting, residents from nearby Clear Water Lake subdivisions said they weren't informed beforehand that a presentation on the options would be made at the July 16 meeting. This prompted the city to schedule the Aug. 11 workshop to revisit the options and address homeowners' concerns.

Between growing development and heavy rainfall especially caused by hurricanes, flooding has been a persistent problem at Clear Water Lake, located off S.R. 414. The lake is private and owned by an individual named Sandra Gay Lust and three associations: Clear Lake Estates, Clear Lake Landing and the

"We [at] Clear Lake Estates [are] suffering because of greed all the way around the lake," Venus Griffith, a 19-year Clear Lake Estates resident, said. "I love my neighbors, because they're right across the street from me, right across the lake and everything. But we are suffering."

Similar to the July 16 meeting, Vladimir Simonovski, city engineer and public works director, presented three long-term solution options the city is exploring for controlling the floodwater at Clear Water Lake.

Option 1 is to recycle surface water as an irrigation source. Option 2, which

would cost \$1 million, is to pump surface water to Northshore Reclaim Water Treatment Plan. Option 3, which cost \$200,000 the last time it was done, is to repeat the temporary pumping whenever needed.

Simonovski said Option 1 is the best alternative solution because it imposes less stress on the city's reclaimed water system and the Clear Lake Landing homeowners association, which owns Clear Water Lake.

The St. Johns River Water Management District (SJRWMD) and the Florida Department of Environmental Protection (FDEP) approved Option 1.

Balmoral Group started

the project design in April 2024 for \$68,900. In January, the design was finished and permitted with the SJR-WMD consumptive use permit, which allows surface water withdrawal for irrigation down to an elevation of 63 feet.

The normal water level is at an elevation of 65 feet. The Clear Water Lake elevation was 69.30 feet on July 1, 69.75 feet on July 16, and 69.58 on Aug. 8, according to Simonovski.

Construction cost of the Clear Lake Water irrigation project is estimated to be \$456,000: \$397,200 for construction plus \$59,600 as a 15% contingency. This would result in approximately \$3,000 per household at Clear Lake Landing, according to Simonovski.

To date, the Avian Pointe community contributed \$60,000 to the irrigation project for support services, and the city may contribute another \$60,000, leaving the homeowners association with an approximate cost of \$336,000. Divided by 142 units in Clear Lake Landing, that leaves about \$2,400 per household. The city's current expense is \$263,000.

Workshop participants discussed holding another workshop next month to further discuss Clear Water Lake, but they did not finalize a date.

creation for the printing process."

The office is quickly fixing the error by mailing a "Notice of Printing Error" to all affected voters, along with a corrected sample ballot, Summerlin said.

Affected voters should expect the corrected sample ballot to be delivered prior to early voting, which begins on Aug. 23.

The Florida Senate District 15 was vacated when Sen. Geraldine Thompson died on Feb. 13 due to complications from knee replacement surgery. She was an educator in the Orange County education system for nearly three decades before serving in the state House of Representatives and the state Senate. She won her last elected position as state senator in 2024.

State Rep. LaVon Bracy Davis won the Democratic primary on June 24, garnering 5,533 votes, good for almost 43% of the vote in a four-way race. All 102 precincts had reported that night. She will run against Republican Willie Montague in the general special election on Sept. 2.

To run for the Senate seat, Bracy Davis announced her resignation last April as the House District 40 representative, effective Sept. 1. Her legislative aide, Young,

ran against former state Rep. McCurdy and won the June 24 Democratic primary to fill the District 40 seat. McCurdy had served as legislative aide to both Thompson and former state Sen. Randolph Bracy, the brother of Bracy Davis.

The western side of state Senate District 15 encompasses Apopka, Lockhart, Clarcona and Ocoee. The Florida Turnpike outlines the district's southwestern border. I-4 outlines the eastern border, and it crosses the Florida Turnpike just north of the district's southeastern border.

## Wyld Oaks: 2 miles of roadways built, all utilities finished

Vertical construction to begin by early 2026

Over 18 months since its January 2024 groundbreaking, the Wyld Oaks development has seen much progress and is on budget, according to Wyld Oaks founder Joseph Beninati.

Beninati addressed professionals, community leaders and entrepreneurs on Wednesday, Aug. 13, at the Apopka City Center Hilton Garden Inn at an Apopka Area Chamber of Commerce

event. After giving the update and hosting a Q&A, Benina-

Nearly two miles of roadways have been built, and all utilities are completed, including potable water, wastewater and stormwater, Beninati said.

"We don't have any debt on the property," he said. "We don't have any investors in the property, so nobody is telling us what to do and go fast, go slow. We have the ability to be stewards of Wyld Oaks for generations, and that is our intent at this point."

Future plans include vertical construction by early 2026, with 700 multi-family homes and a town center with

ti invited attendees to the site a new Main Street. Multifamily homes will be built in phases, with the first phase starting in the first quarter of 2026. The project includes plans for up to 6,000 units, depending on the height restrictions.

> Α major healthcare agreement and a local convenience store, Wyld Provisions, are also in the works.

> The project aims for local integration, focusing on bringing in local operators over national chains for retail space, Beninati said.

Husband and wife Jim and Eileen Diamond, a consultant and a realtor, respectively, attended the chamber event. They live down the

street from Wyld Oaks off Plymouth Sorrento Road.

"I'm really excited because we are also golf cart owners, so the idea of coming from our neighborhood and being able to go to a restaurant or a store or something is really exciting," Eileen Diamond said, adding that there are currently no gas stations in the Wyld Oaks area.

Beninati answered Jim Diamond's questions, such as the project timeline, Diamond said. He said he and Eileen had followed other local developments similar to Wyld Oaks that made some progress but came to a halt. They wanted to find out if Wyld Oaks might meet a sim-

"This was just unimproved land [before Wyld Oaks] and we've seen the trucks drive by," Jim said. "It's great to see all the roads in and the infrastructure already finished."

Charles Chambers, past chamber chair and proprietor of FastSigns Apopka, visited the Wyld Oaks site up to four times prior to Aug. 8, including before any infrastructure was developed.

"It's going to be a great community," he said. "What they got so far and what it's going to be, it sounds perfect. We're actually looking to move from where we live to here."

fire apparatus featuring a 78foot aerial ladder that provides both firefighting and emergency medical response capabilities.

Fire Station 6 has a gym that includes workout equipment donated by AdventHealth.

Seven people, including four firefighters, one engineer, one lieutenant and one EMS captain, will staff Station 6, according to an AFD press re-

"But it is the courage, professionalism and compassion that will define Fire Station Six and what it represents for generations to come," Apopka Fire Chief Wil Sanchez said in his remark.

Former state Sen. Randolph Bracy and former state Rep. Kamia Brown helped the city of Apopka secure state funding of \$1 million from the 2021 Legislature to build Fire Station 6.

"This fire station is a testament to people coming together for a common purpose," Bracy said, adding that when he first met Mayor Bryan Nelson, Nelson was a House representative. As Apopka mayor, Nelson has worked diligently to get funding for fire station 6.

"It took a couple of years, but we got it done," Bracy said. "My point is that people from different backgrounds, different political parties, different belief systems, can still come together for a common purpose for our community, and that's what we did."

House District 39 Rep. Doug Bankson, an Apopka pastor and former city commissioner, praised the firefighters.

"These are our first responders," he said. "These are the ones that run into danger for us. There's a Bible verse that says 'the greatest among you will serve them all,' and I can't think of anything that more demonstrates that in our community than our firefighters."

Fire Station 6's temporary location first opened in December 2017 in a trailer, at the same time when AdventHealth opened its relocated Apopka hospital off S.R. 429, from its old Park Avenue campus.

Fire Station 6 serves the city's southwestern region, including AdventHealth and the Northwest Distribution Center; the communities of Emerson Park, Breckenridge, Apopka Woods, Magnolia Park Estates and Marden Ridge Apartments; along with toll roads 429, 414 and 451.


In 2023, the \$4.1-million Harmon Road extension opened to ensure improved access to AdventHealth Apopka from the east as well as to fire and ambulance vehicles.

In 2024, the AdventHealth Apopka expansion, which included creating additional parking spaces, had the temporary Fire Station 6 move to another site, the Harmon on the Lake apartment complex on Harmon Road, until the permanent Fire Station 6 finished construction.



about the same number were wounded."

Johnson climbed down the ladder from the starboard air intakes, scraping his arm, but his best friend died in the attack, according to the United States Navy Memorial website.

The U.S. Navy charged Johnson on June 20, 1946, at the Great Lakes Naval Station in Illinois. Johnson received the Asiatic Pacific Campaign Medal and the World War II Victory Medal for his service.

Johnson then worked for AT&T until retiring at 57. But Johnson did not know what to do with himself in retirement.

"I was wondering, 'What

the hell am I going to do at 57?" Johnson said. "The

Johnson also enjoys drinking Hendrick's Gin, a spirit infused with rose and cucumber. His longtime friend Steve Ruebelman identified the gin as the secret to Johnson's long life.

"After nine years, we've managed to go through 45

bottles," Ruebelman said. "Literally one drink a day. It's all we have."

Ruebelman saved each gin bottle he and Johnson shared over the years. He plans to turn the bottles into lamps to share with Johnson's family.

"I'm going to have some fun with them," Ruebelman said.

Johnson is proud of his military service. He has several hats, including "USS Saratoga CV-3" and "Kamikaze WWII Survivor" baseball caps. Although he believes America "is going downhill," he said he would fight for his country all over again if given the chance.





They can smoke on their own time, but they can't come to work impaired. As you might guess, a new marijuana smoker may be naïve to the strength of new marijuana strains. They may blur the lines between how much ingestion will make them impaired.

California does not allow any non-psycho active metabolites of Marijuana testing to be utilized. This means that every individual in California must utilize oral fluids if they plan to test for Marijuana. The only exception to this California rule is for those in the construction industry which can continue to utilize urine or hair for their drug testing needs.

Oregan also has a new rule that mimics California's rule except it only pertains to pre-employment

Nevada has a rule that forces employers to accommodate Medical Marijuana users:

- Medical needs of an employee who engages in medical use of marijuana to be accommodated by the employer, except for certain positions and unless to do so would endanger others' safety.
- (NRS 453A.800) "Except as otherwise provided .. an employer is required to modify the job or working conditions of a person who engages in the medical use of marijuana that are based upon the reasonable business purposes of the employer but the employer must attempt to make reasonable accommodations for the medical needs of an employee who engages in the medical



Paulucci Acres would encompass about 618 acres of up to 1,052 residential units and two commercial parcels that will total about 10 acres, according to documents from Shutts & Bowen that are included in the Planning Commission's Aug. 12 agenda packet.

About 145 acres of Paulucci Acres would be dedicated to a city park, according to Elesa R. Sowell, a partner with Shutts & Bowen in Orlando. The park would be constructed more in the beginning of the Paulucci Acres development.

"We've been working with city staff and the applicant in terms of understanding what makes sense and what would work best, but we understand the city would like the park as soon as possible," she told the Planning Commis-

Pulte and Shutts & Bowen held a private community meeting concerning the Paulucci Acres project on Aug. 4 at the Apopka Community Center. It was well attended by both citizens and city officials.

The City Council will have a first reading of both future land use maps on Sept. 3 and a second reading and adoption on Sept. 17.



## City weighs additional property for new mountain bike park

Park may be constructed on Ocoee Apopka Road

The Apopka City Council voted unanimously to move ahead with the appraisal of properties considered for a potential land swap or acquisition that, were it to happen, would more than double the size of a proposed mountain bike park.

The city wants to build the mountain bike park on an estimated 14.6-acre city-owned property located at 1102 Ocoee Apopka Road, which the city acquired from Orange County. The city budget includes \$500,000 from the proposed fiscal year 2026 for this project.

"[The land] provides topography and natural elements conducive to development into a mountain bike park," interim

city administrator Radley Williams said at the Aug. 6 City Council meeting.

City staff has met with representatives of the Ridge Self-Storage LLC, which owns an estimated 12.2-acre parcel to the west of the 14.6-acre parcel. The land swap possibility is with the city-owned Harmon Road parcel at 2139 Harmon Road. Adding the Ridge Self-Storage parcel would raise the park size to about 27 acres, according to the Aug. 6 City Council staff report.

What's more, Apopka Centerline Development, of which the Ridge Self-Storage is a part, has expressed interest in giving more acreage to the west of the park, thus boosting the total park acreage to about 38.1 acres, the City Council staff report stated.

Groups such as the Southern Off-Road Bicycle Association (SORBA) and the Apopka Centerline Development LLC (The Ridge) have expressed interest in supporting the project, Williams said.

Bike tourism is a popular activity that "brings significant economic drive for any region," said Sue van Bernum, president of SORBA Orlando.

Van Bernum highlighted the mountain bike skills park at the Markham Woods trail system in Lake Mary. SORBA Orlando proposed the concept to Seminole County in 2018. The park later opened in April 2023.

SORBA maintains eight local trails, including one in Mount Dora. Van Bernum highlighted the importance of adaptive trails for people with disabilities and the lack of similar parks in the state.

"We don't have any type of park like this, and I don't want to say just in Central Florida, but in Florida, I can't think of any," van Bernum said. "This would have a huge impact. It would definitely put Apopka on the map. People will come."

The proposed FY26 budget includes a contingency project balance of over \$2 million for future park development, according to Williams, who later clarified that any property acquisition the city makes for the park can be done with impact fees.

During public comment, residents suggested linking smaller parks with a city-wide cycle trail and ensuring adequate parking, restroom facilities, and barriers for accessibility.

A concept plan of Apopka's mountain bike park was given at the City Council's Feb. 5 regular meeting.

Discussion about the land swap took place at the July 2 City Council meeting and the July 7 fiscal year 2025 budget workshop, where the City Council requested information on future land use and zoning.

## Apopka rejects county agreement over Golden Gem Road section transfer

Section extension would increase project cost by \$2.8M

Due to financial constraints and Orange County's lack of funding commitment, the Apopka City Council voted unanimously at its Aug. 6 meeting not to accept an interlocal agreement with the county over the transfer of a section of Golden Gem Road.

The road section in question stretches from Capital Reef Way to Kelly Park Road and has become an important route since the S.R. 429/Kelly Park Interchange opened in 2018. According to a City Council staff report from Aug. 6, the city of Apopka wants to take control of this portion of Golden Gem Road to address its

poor condition and manage the increasing traffic from new developments.

Orange County had requested changes to the original agreement. The estimated cost for the original roadway segment was about \$12 million, according to city planner Jean Sanchez, who presented the agenda item at the meeting.

Under the proposed agreement, the city would take the northern segment, while the county would retain the southern portion. However, Orange County proposed extending its section of the road by another 1,300 feet, which would increase the project's cost by \$2.8 million, for a new total of nearly \$15 million.

Orange County also declined to help pay for the reconstruction, despite the city's request for a cost-sharing partnership, according to the City Council report.

Golden Gem Road is "functionally classified" road, meaning it is designed to connect larger road networks and handle higher traffic volumes. Because of this, its transfer to the city must be done through a formal agreement, and the city is not obligated to take on the responsibility, Sanchez explained.

Built before 2000, Golden Gem Road is in need of a full reconstruction that would include new stormwater systems, according to the city staff report. The city has already secured funding from development partners to begin the design, which is now 60% complete, to prevent delays for future developments and ensure the road improvements meet city standards.

According to the city staff report, city representatives met with Orange County representatives in May to request that the county transfer \$750,000 in resurfacing funds to help with the costs, but the county declined.



## Apopka preschooler nominated for Youth Athlete of the Year

Four-year-old River Farmer cheers in the face of DiGeorge syndrome

To some, cheerleading is an amusing supplement to football games. But for 4-year-old Braelynn River Farmer, cheerleading is the way to overcome her disability — and possibly the ticket to \$25,000.

The Youth Athlete of the Year competition, a collaborative project of the charity DTCare and Sports Illustrated, named Farmer as a candidate after a friend of Farmer's mother nominated her. Farmer cheerleads for Apopka Royals Cheer and studies at Clay Springs Elementary School, all while fighting Di-George syndrome.

According to the Mayo Clinic website, DiGeorge syndrome, or 22q11.2 deletion syndrome, occurs when part of chromosome 22 is missing.

"Medical problems commonly related to 22q11.2 deletion syndrome include heart problems, lowered immunity, a cleft palate, complications from low levels of calcium, various eye issues and autoimmune disorders," the website said. "Complications also include hearing loss, skeletal differences, kidney and genital differences, and delayed development with behavioral and emotional problems."

As a result of DiGeorge syndrome, Farmer has a submucous cleft palate and may develop schizophrenia, ep-

ilepsy, or autism in the future. However, what Farmer's mother Tiffany Clark most noticed at her daughter's birth in 2020 was Farm-

"She was born with club feet," Clark said. "Both her feet were turned in and upward. They literally looked like 9 iron golf clubs."

Because of her club feet, Farmer's legs had to be in casts from her thighs all the

way down starting at just one gery, Farmer needed to wear braces. "When they told me that she was going to have to wear braces, the first thing that popped in my head was Forrest Gump, but these were like little booties," Clark said. "There was a metal bar that connected on the bottom of the shoe, and it kept her feet angled out. She had to wear those and sleep in those every night." DiGeorge syndrome has

also left Farmer nonverbal, although she is working hard to learn how to speak. Farmer's difficulty in speaking led Clark to call her daughter by her middle name instead of her first.

"With her being in speech therapy, and them trying to teach her how to pronounce letters and all that, I honestly thought it would be easier for her to learn how to say 'River' first than 'Braelynn," Clark said.

Despite her inability to speak many words, Farmer still found a way to communicate her dream of cheerleading. Clark said she realized her daughter's desire in 2023, when Farmer watched Zombies. The Disney movie musical franchise tells the story of a zombie football player and a half-human, half-alien cheerleader.

"When they are dancing and doing the stunts and everything, she's pointing at the TV, and she's trying to do the dances," Clark said. "When they throw the cheerleaders up in the air, she jumps in the air and tries to land on the floor."

Having cheered for Apopka Pop Warner Cheer and Dance and the Apopka Blue Darters, Clark was more than happy to help Farmer find a cheerleading program. Apopka Royals Cheer stood out to her as the most affordable and disability-friendly

"They were the only ones out there that were willing to do the whole kids with disabilities thing, which I absolutely love," Clark said. "It's become one big family."

Farmer cheers for two squads in Apopka Royals Cheer. The Tiny Tiaras is a Tiny Performance Advanced Level 1 team for children 6 and under. The program teaches children floor stunts, rolls and cartwheels.

Crown Jewels, the other squad Farmer cheers in, is Apopka Royals Cheer's disability friendly team. Crown Jewels focuses on "fine motor skills, friendships, and self-esteem," according to the website

Farmer's older brother, 8-year-old Brantley Farmer, cheered in both squads alongside his sister last year, since his ADHD qualifies him for the Crown Jewels.

"It was great," Brantley said. "I did it just for joy, to give people joy."

Crown Jewels has given Brantley something to work on together with his sister.

"Sometimes, in my room, I have my bed and we do a stunt that I have to lift her off in," he said. "But if she falls down, good thing she can fall down on my bed."

River Farmer is a flyer on the Crown Jewels, which means "she gets to do the stunts and everything like that, because she's the littlest one on that squad," Clark said. On the Tiny Tiaras, River is bigger than several of the kids, so she is a base for the cheer pyramid.

River Farmer has had to wear braces or casts for most of her life, but in June she was able to remove her braces, helping ease her dai-

ly routine as the cheer season returns.

"Kids that are born with club feet have to wear these braces at least until the age of 5, just for that precaution of the feet turning back in," Clark said.

When the doctor stretched River Farmer's feet, he told Clark that River had good motion and allowed her to take the braces off early.

River Farmer has also been able to incorporate sign language into her routine. Last season, the other children had to say "A-R-C" for "Apopka Royals Cheer," but Farmer was not able to spell it out loud with them. She spelled "A-R-C" in sign language instead.

"Once the audience saw what she was doing up on stage, the whole audience started doing the sign language with her," Clark said. "It was the most adorable thing I've ever seen in my life."

River Farmer's story caught the attention of one of Clark's friends, who nominated Farmer for the competition.

"One of my friends saw this ad on Facebook — it was for Youth Athlete of the Year with Sports Illustrated magazine — and she asked if I would be okay with them putting River's name in it,"

Clark said. "So they went ahead and they nominated her, and she got chosen."

If selected as the winner, Farmer will receive \$25,000, appear in a 3BRAND advertisement in Sports Illustrated magazine, and receive the Youth Athlete of the Year title. But Clark ultimately hopes for something more meaningful to happen.

"I'm a single mom, and it's hard out there," Clark said. "[The] \$25,000 would be great. But my main concern is not a lot of people know about DiGeorge syndrome. That's my main goal in getting the information out, because she looks just like a normal kid."

No matter the competi-

tion's outcome, Clark said that cheerleading has given Farmer the courage and motivation to learn how to speak.

"She wasn't even trying [to speak] before we started," Clark said. "Now that she's around kids her own age and sees them doing the cheer, she's actually trying. The words may not come out — it just may come out as sounds — but she's trying, and I'll take the trying over getting an actual word out any day."

According to Clark, River Farmer feels like a superstar with the nomination. She's also excited to attend the Descendants/Zombies: Worlds Collide Tour" for her birthday next month, honoring the movies that gave her the dream of cheerleading.

"She's a trooper," Clark said. "She doesn't let anything stop her. She knows what she wants, and she's going for it."

## From breakfast casserole to cherry torte: recipes to savor all day

Ree Drummond of The Pioneer Woman. com has some wonderful recipes, including one called Sausage Breakfast Casserole. This

one is an "easy make-ahead breakfast casserole."

Century House Tavern in Woodstock, Georgia, is famous for their collard greens as produced by Daniel Porubiansky in large batches of 15 pounds at a time. We found this recipe in the Atlanta Journal Constitution. I looked up 14 tablespoons and it is 0.875 cup. I plan to use a scant cup of butter instead of measuring out 14 tablespoons!

If you like peas, Emily Meggett has a recipe for you in her book, Gullah Geechee Home Cooking. She says, "Many people are familiar with blackeyed peas, but not crowder peas. While crowder peas come from the same family as black-eyed peas, crowder peas are slightly bigger, and they don't have that notorious black eye. Because crowder peas are hard to find outside of the Lowcountry, you can use black-eyed peas or cowpeas for this recipe. Whichever you choose, make sure to wash your peas thoroughly to remove dirt and stones, and purchase the best ham hocks you can, as they give a salty and meaty flavor that you just can't resist."

For Mrs. Meggett's Chocolate Cream Pie, she says, "The chocolate lovers in your life will adore this pie. This light filling benefits from a night in the fridge, which will allow the filling to fully firm up. The whipped cream topping adds another layer of sweetness; it also helps to balance some of the chocolaty taste."

For dessert, try Darlene Brammeier's Cherry Torte. It appears to be fairly straightforward; she won't make us do any backflips. Thanks to Northside Baptist Church for their cookbook where we found Darlene's recipe.

#### SAUSAGE BREAKFAST CASSEROLE

Recipe from ThePioneerWoman.com **Butter or nonstick spray** 1 pound breakfast sausage, such as

**Jimmy Dean** 4 scallions, chopped, white and green parts divided

1 red bell pepper, chopped 10 eggs 1-1/4 cup heavy cream

1 tablespoon Dijon mustard 2 teaspoons hot sauce, optional 1-1/2 teaspoon salt

1 teaspoon black pepper

2 cups shredded sharp cheddar cheese, divided (8-ounce portions) 1 30-ounce package frozen shredded hash browns, thawed

1) Grease 9 x 13-inch (or other 3-quart) baking dish with butter or nonstick spray. Preheat oven to 350 degrees. 2) Heat a large skillet over medium-high heat. Add the sausage and break up into small pieces with a wooden spoon. Cook the meat until no pink pieces remain, about 6-8 minutes. Add the red bell pepper and white and light-green parts of the scallions, and cook 3 more minutes. Transfer to a plate to let cool slightly. 3) Meanwhile, in a large bowl, whisk together the eggs, heavy cream, mustard, hot sauce, salt, black pepper and about onehalf of the remaining green parts of the scallions (save the rest to sprinkle on top of the casserole once baked.) Gently fold 1-1/2 cups of cheese, the hash-browns, and the sausage mixture into the egg mixture. Transfer all to the baking dish and smooth into an even layer. 4) Cover with aluminum foil and bake for 50 minutes. Remove the foil, and top with the remaining 1/2-cup of cheese. Increase the oven temperature to 400 degrees and finish baking until the center of the casserole is set (not jiggly) and the top is slightly golden, 10-15 more minutes. Let rest 10 minutes, top with the remaining green parts of the scallions, then serve.

#### **DANIEL PORUBIANSKY'S COLLARD GREENS** CENTURY HOUSE TAVERN,

WOODSTOCK, GEORGIA Authored by C. W. Cameron in the Atlanta Journal Constitution

14 tablespoons unsalted butter 1/2 pound smoked bacon, cut into 1/4inch wide strips

1 medium yellow onion, diced 3 pounds collard greens, stems removed, washed, cut into bite-size

3 tablespoons sherry vinegar, plus more if needed

2-1/4 cups chicken stock, plus more if 6 tablespoons maple syrup

6 shakes Tabasco Salt

In a large saucepan, melt butter over medium-high heat. Add bacon and onions and cook until onions are translucent. Slowly add collards, stirring between each addition until collard greens soften and more can be added. When all collard greens are in the pot, add vinegar and cook until liquid reduces by half. Add chicken stock and maple syrup and cook, stirring occasionally, for 5 minutes. Add Tabasco and lightly season with salt. Simmer over medium heat 1 hour, continuing to stir occasionally. Taste and add vinegar, maple syrup or salt as needed. If collards are not tender, continue cooking, adding water as needed. Once collards are tender, they can be served immediately, or refrigerated for up to 4 days. Makes 6

#### **EMILY MEGGETT'S CROWDER PEAS, BLACK-EYED PEAS, OR COWPEAS**

Recipe from Gullah Geechee Home Cooking by Emily Meggett

2 14-ounce smoked ham hocks sliced into 1-inch pieces

1 quart fresh or dried crowder peas, black-eyed peas, or cowpeas 1-1/2 tablespoons salt, plus more if

1-1/2 teaspoons pepper, plus more if needed

1) In a large, heavy-bottomed pot, combine 3 quarts water and ham hock chunks. Cook over medium-low heat for about 45 minutes. 2) While the ham hocks are cooking, wash the peas thoroughly, removing any dirt or stones. About 30 minutes into cooking the ham hocks, add the peas to the pot, bring to a boil, and boil for about 5 minutes. Reduce the heat to medium and cover the pot. If using fresh peas cook for about 1-1/2 hours. If using dried peas, cook for 2 to 2-1/2 hours. 3) Season with salt and pepper to taste.

Notes: The liquid in the finished pot of peas should be a gravy consistency, not

When working with peas/beans, canned peas/beans require the least amount of cooking time, about 15 minutes, followed by green or frozen peas/beans, which require 45 minutes. Fresh-from-the-garden peas need 1-1/2 hours.

Dried peas/beans require the longest cooking time, 2 to 2-1/2 hours. Bring them to a boil, then reduce to medium heat and simmer until done. Add water and cook longer as needed.

#### **CREAM PIE** Recipe from Gullah Geechee Home

**EMILY MEGGETT'S CHOCOLATE** 

Cooking by Emily Meggett

3 ounces Baker's unsweetened chocolate

1 cup plus 2 tablespoons sugar 1/4 cup all-purpose flour 1/2 teaspoon salt

2-1/2 cups milk, whole or 2%

4 large egg yolks, lightly beaten

2 tablespoons unsalted butter 1 teaspoon vanilla extract

1 baked (9-inch) pie crust Sweetened whipped cream

1) Melt the chocolate in the top of a double boiler over simmering water. 2) In a mixing bowl, whisk 1 cup of the sugar, the flour, and salt together with 1/2 cup of the milk until smooth. Add the egg yolks and the remaining 2 cups milk. Add this mixture to the melted chocolate, whisking well. 3) Stir constantly and cook over medium heat until thick and smooth, about 10 minutes. 
