Apopka, St. Johns District extend Golden Gem agreement

Project is for \$14.5M improvement project including pump station

The Apopka City Council voted unanimously to extend a memorandum of agreement (MOA) with the St. Johns River Water Management District (SJRWMD) for the sixth time. The extension gives the city more time to work on a \$14.5-million improvement project for the reclaimed water facility at the 103-acre Golden Gem Road property.

The action came during a special joint meeting between the City Council and the SJRWMD on Monday. The resulting extension pushes the deadline on the project to May 20, 2026.

The SJRWMD acquired the Golden Gem Road property in May 2009 and transferred it to the city via a quit claim deed. The condition was that the city focus on designing, permitting, and building a reclaimed water storage and aquifer recharge project. One 300-million-gallon reclaimed water pond currently exists at the property, where a sinkhole formed in January 2024 and which the city has been working on restoring.

The project's \$14.5-million budget includes a \$12.5-million allocation for

the pump station and \$2 million to replace a damaged liner at the reclaimed water facility. The project aims to provide 49 million gallons of reclaimed water, with potential for future expansion. It is also focused on meeting regional water needs, with contributions from the cities of Altamonte Springs and Mount Dora.



City Council approves first reading of utility meter fines

Ordinance intended to deter tampering By Teresa Sargeant Reporter

The Apopka City Council voted 4-1 Wednesday to approve an ordinance that establishes fines for unauthorized tampering of utility meters. Commissioner Nick Nesta voted in opposition.

If the City Council has a second reading and adopts the ordinance, it would establish the following fines for the violation: first offense, \$250; second offense, \$500; third offense, cut off of services.

The fines are meant to deter potential violation of the system equipment and to recover the cost incurred to repair the meter, according to Blanche Sherman, city finance director.

Sherman also explained that the city's Public Works

Bankson, Bracy Davis address council

Both tout accomplishments in legislative session

State Sen.-elect LaVon Bracy Davis, D-District 15, and Rep. Doug Bankson, R-District 39, recounted their achievements in this year's legislative session and reaffirmed their commitment to represent Apopka in Tallahassee during the City Council meeting Wednes-

Both lawmakers recapped the session, which set the record as the longest in the state's history at 105

days, according to Bracy Davis. The 2024 regular session began on March 5 and ended on June 7. A session typically lasts 60 days.

Bracy Davis admitted her disappointment over the latest session's focus on what she called culture wars and engineered controversies. She said her top priority this past session was cost of living issues, from groceries to property insurance, for constituents.

She touted successes like securing funds for the Orlando Museum of Art and



Downtown shows Best of Apopka

As 5th Street, between Park Avenue and Central Avenue, shows very positive growth in restaurant openings with Propagate, Hall's on 5th, Just Like Momma's and 3 Odd Guys, I would like to give you the background on how we got to this very exciting hotspot.

Our first restaurant to open was 3 Odd Guys, which took multiple meetings with staff to convince them that downtown Apopka was the right place to be. Soon thereafter, we added Propagate to downtown with the unique porch, which covers our stormwater pond for the Community Center.

At that point, we were able to get legislation passed to make it easier for both restaurants to be able to sell spirits as well as beer and wine for customers who frequented both restaurants in the Community Redevelopment District. The savings were over \$250,000 for each business and continues to generate more business for downtown.

Just Like Momma's was the next to sign a lease, adding anothApopka Mayor



er food choice for folks visiting downtown.

Because 5th Street is in the CRA, all the commercial businesses are able to secure grants from the city to make improvements to their buildings — both inside and out — giving them more visibility and generating more revenue while reducing outof-pocket capital costs.

Then the latest deal was the purchase of Hall's Feed Store, the second oldest business in Apopka, which has become a one-ofa-kind food hall with top-notch vendors selling food and drinks inside the upgraded Hall's foot-

The quality of the food is highlighted in the results of the Chief's Best of Apopka awards, which is peppered with honors for these downtown eateries.

For the last year and a half, the 5th Street Merchants in partnership with the CRA have been hosting a Friday Night Market with 40-plus vendors selling their wares right on 5th Street. The landlord at the southwest corner of Park and Main has also made major improvements to a building that is over 60 years old, giving options to office and retail businesses to open or expand.

We are proud of the partnership between the property owners, the Apopka CRA and the city of Apopka and the impact they have made on improving downtown with multiple murals representing our rich heritage. We are even expanding small businesses opening in the CRA with True Coffee only a block away on Sta-

What a difference a couple of years make when we work together for the common good.

Orange County lighting up Apopka

The Accelerated Transportation Safety Plan (ATSP) salvaged some important infrastructure projects after the loss of the transportation referendum in 2022. The ATSP bonded out \$100 million for increased bus service (Access Lynx), sidewalks, roadway safety improvements, and new LED street light-

lighting improvements made in eastern Apopka were substantial. The county spent nearly \$18,000 for new LED street lighting down Votaw Road. The county upgraded Wekiva Springs and Thompson roads from incandescent lighting to LED about five years ago. More than \$37,000 was spent on new Welch Road lighting with more planned for the eastern side.

The southern side of Apopka has been blessed with significant lighting improvements. South Apopka was upgraded to LED first. In 2019, the county added LED street lighting to Piedmont Wekiva Road and Apopka Blvd. This past year \$225,000 was spent adding LED lights to Sheeler Ave.

West Keene Road had 17 lights added at a cost of \$67,000. And Binion Road — this is the granddaddy of lighting improvements — added 140 lights cost**County Commissioner** District 2

ing nearly \$900,000.

Moving on to widening intersections or entire roadways, please remember, transportation funding was voted down. Widening Plymouth Sorrento Road, for example, would likely cost around \$100 million. The problem is not that county staff doesn't see the congestion; it is about having available resources.

Finally, let's talk about North Apopka. LED lights were added on Mt. Plymouth and Rock Springs roads in 2019. Next, I was able to secure federal dollars for the city and county to create a "complete street" project on Rock Springs Road from Welch to Lester. You will begin to see construction in 2026.

Three LED streetlights were added on Ponkan, but this is not nearly enough. We must keep advocating for more. I had three lights added on W. Highland St. The People of North Apopka (PONA) group has done terrific work cleaning up Old Plymouth.

For those of you unfamiliar with my Corridor of the Year Contest, judging is Nov. 1. Edgewater Drive and Orange Blossom Trail through Lockhart, Clarcona through South Apopka, Lee Road, and Highland through Old Plymouth are competing for the trophy. Teams pick up trash, work with property owners, stain fences, erect placemaking art, trim trees, and follow law enforcement safety standards, known as CPTED. If you wish to join the PONA team, we will be out on Highland Street 8-11 a. m. on Oct. 11. We meet at Dayspring Church.

Finally, the county is completing designs for new LED street lighting along the entire length of Plymouth Sorrento Road. Providing the Duke line teams do not need to attend to hurricane damage, the lights will be installed this fall or winter!

Roadway safety is dependent on many factors, one being the quality of street lighting. Too many people lose their lives on dark roadways. Orange County is diligently attending to your safety with the aggressive ATSP program for new LED street lighting.

Orange County joins in lawsuit over Senate Bill 180's legality

25 cities, counties claim law hampers local ability to manage own growth

Orange County government is one of 25 municipalities and counties statewide that has filed a lawsuit challenging the legality of Senate Bill (SB) 180, which the plaintiffs say hinders local government control over the communities' development regulations.

Weiss Serota Helfman Cole + Bierman (WSHC+B) filed the

complaint Monday in the Second Judicial Circuit Court in Leon County, the law firm announced in a press release.

The lawsuit is about protecting local governments' right to regulate their own municipalities and counties in accordance with their needs, according to Jamie A. Cole, WSHC+B firm partner who is also the lead attorney representing the plain-

"This case isn't just about stoic legal principles, it's about protecting home rule authority," Cole said in a statement. "Every city and county has unique needs, and local leaders are best positioned to make decisions about growth, safety, and resilience. SB 180 is the largest intrusion into local home rule authority since the adoption of the Florida Constitution in 1968."

SB 180 was passed during the 2025 legislative session and is aimed at helping people throughout the state rebuild after hurricanes. A late amendment widened the bill's scope, voiding land-use regulations and comprehensive plans adopted from Aug. 1, 2024, to Oct. 1, 2027.

The plaintiffs in the suit say the amendment takes away the constitutional right of cities and counties to regulate growth and development. They are asking the court to declare SB 180 unconstitutional and block its enforcement so local governments could re-establish their authority to manage their local landuse and planning and therefore growth and development.

"SB 180 violates the Florida Constitution and Florida law because it contains more than 'one subject and matter properly connected therewith,' has a defective ballot title, is a general law that classifies counties and municipalities on a basis not reasonably related to the subject of the law, constitutes an improper unfunded mandate on the Local Governments, conflicts with Florida's Community Planning Act, and intrudes on Home Rule Powers," the lawsuit states.

The named defendants in the lawsuit are J. Alex Kelly,

state secretary of commerce; Kevin Guthrie, executive director for the Florida Division of Emergency Management; Wilton Simpson, state commissioner of agriculture; Jim Zingale, executive director of the Florida Department of Revenue; and Blaise Ingoglia, state chief financial officer. All the defendants are being sued in their official capacity as state administrators.

WSHC+B partners Chad S. Friedman, Susan L. Trevarthen, and Richard B. Rosengarten and associate Aaron L. Graubert are assisting Cole in representing the plaintiffs.

The town of Windermere is the only Orange County municipality that is a plaintiff in the

director and city engineer, the MOA requires several items to receive its sixth amendment. These include a consumptive use permit modification application, hydrologic and liner material evaluation, and monthly status meetings.

The city's engineering firm, Tetra Tech, is serving as a consultant, working on tasks such as the reclaimed water operating and water balance model analysis and the design of a reclaimed water reservoir storage.

Commissioner Nick Nesta recommended that if the sixth amendment is approved and the May 2026 deadline approaches, the city should hold a workshop to explore what the next project phase would look like under the MOA's seventh

amendment.

Simonovski said the seventh amendment will relate to extending the project with what's included in the \$14.5 million task for the liner repair and building the pump station,

which will likely be underway at the time.

"Of course, as a separate condition, that will be our goal for the district to consider to have a separate condition for the repair of the larger liner of [the] larger pond, because that will require a little bit more time," Simonovski said.

Albert McKimmie, Golden Gem Road resident, raised concerns about the project's compliance with Florida statutes and the need for due diligence in removing and testing existing liners.

He told the City Council he sent all members documents — including those from the city — regarding the Golden Gem Road property and offered to speak to any City Council member about the documents.

"I'm going to tell you tonight, the city is not in compliance with Florida statues as it currently stands at that pond," he said.

Dr. Phyllis Olmstead, an Apopka resident speaking in her capacity as District 3 Supervisor of the Orange County Soil and Water Conservation Districts, expressed concern about the fill material placed in the pond and its potential impact on the aquifer and drinking water.

Like McKimmie, Olmstead emphasized the need for careful and diligent repair of the pond to prevent future issues.

"I beg of us, in this continuing time that we're working on this to repair it, that we do so diligently with inspections and carefully repair it and remove any bad materials that were [placed] there," she said. She stressed the importance of protecting the area from another collapse, particularly because it is "precious above our aquifer."

Since the original MOA's execution, both parties have approved five amendments to extend the project completion deadline:

First amendment (April 9, 2014): Extended deadline to May 27, 2019.

Second amendment (June

5, 2019): Extended deadline to May 27, 2022. Third amendment (May

23, 2022): Extended deadline to September 30, 2023. Fourth amendment (February 14, 2023): Extended

Fifth amendment (March 31, 2025): Extended deadline to September 30, 2025.

Samaritan Village, a safe place for women survivors of human trafficking, and her commitment to various issues, including voting rights and "returning citizens," or people who are released from incarceration.

"In closing, I'll say this to you, my promise to you, to the commissioners and also to the citizens of Apopka, that I bring Apopka with me to Tallahassee," Bracy Davis said. "When I was elected to Tallahassee, Apopka goes with me, so I say your name on the House floor and now on the Senate floor. Your families, your neighborhood, your hopes deserve more than rhetoric. They deserve results."

Bracy Davis was elected senator in a Sept. 2 special election over Republican Willie J. Montague, succeeding Sen. Geraldine Thompson, who died in February at age 76. At the time, Bracy Davis was the House District 40 representative, which she had served in from her election in 2022 until her resignation on Sept. 1.

She won the June 24 Democratic primary, defeating four opponents including her brother former state Sen. Randolph Bracy.

Her former chief of staff RaShon Young ran for her old seat. He defeated Republican

Tuan Le in the Sept. 2 special election. He accompanied Bracy Davis to the Oct. 1 Apopka City Council meeting.

Bracy Davis will be sworn into her new office on Tuesday, Oct. 8, in the Senate Chamber in Tallahassee.

Bankson discussed five

of the 12 bills he either sponsored or prime co-sponsored that were signed into law this year: to recognize gold and silver as legal tender (House Bill [HB] 999), the tax exemption of sales of bullion (HB6021), the tag flipping/offense involving motor vehicles (HB253), hospitals testing patients for fentanyl (HB1195), and

transportation bill that creates an institute, updates the structure of the Florida Department

of Transportation, and updates rules for project funding, seaports and airports (HB1397).

Bankson also spoke about the importance of protecting Lake Apopka and the progress made in restoring its water quality, and, for the next legislative session, his intent to continue working on property tax reform.

"Bottom line is we're working very hard," Bankson said. "We're working together to get things done. I'm really excited about what we've done, and I'm ready to roll up the sleeves and get to work. We are going next week, starting again."

Bankson is currently serv-

ing his second term. He was elected to his first term as House District 39 representative in 2022 and re-elected in 2024. He is an Apopka resident, founder/pastor for Victory Church on South Park Avenue and previously served as city commissioner.

House District 39 encompasses parts of Orange, Seminole and Lake counties, including the cities of Winter Garden, Ocoee and Apopka, the communities of Mount Plymouth and Zellwood, and a part of western Seminole County.

Senate District 15 includes northwest Orange County, including Apopka.

address as 1819 Piedmont Wekiwa Blvd., which is another name for Armando Borjas Jr. Way.

Apopka 3 LLC purchased the 5.58-acre Armando Borjas Jr. Way tract from Gail M. Taylor and ACH Associates for \$1.7 million in 2021, according to Orange County Property Appraiser records.

Although Freshfields Farm Apopka is proposed as under the threshold of 25,000 sq. ft. and therefore doesn't require a public hearing, the project would undergo both major development plan and construction site plan processes.

"We gave [the develop-

ment team] the discretion that they can undergo those two processes together," Sanchez told the DRC. "So, we will treat this as both plans."

The major development plan process entails a review of the overall project layout to make sure aspects such as building placement and proposed land use comply with the city's zoning codes and comprehensive plan.

The construction site plan process is a more detailed, technical review of the architectural and engineering renderings to check for compliance with city technical specifications before a building permit can be issued.

Dane Frey, civil engineer with Bowman Consulting Group, said that they received a copy of the comments from the city. The team reviewed them and had no objections to the housekeeping items, but there are requests to clarify the amount of parking, Frey said.

"We do intend to provide a study for a similar store that justifies the need for additional parking above code minimum, and the other items, we have no issues addressing those," he said.

Bike/Walk Central Florida's ninth annual BIKE5 will welcome bike riders to explore Central Florida cities to promote safety and accessibility and raise awareness for a wider need for a multi-modal transportation network that emphasizes these qualities.

Riders will have two options to choose from: guided group ride with a ride leader or self-guided ride.

The goal of BIKE5 is different from other cycling events because it isn't about speed or competition.

"BIKE5 isn't your typical cycling event," Anna Strasshofer, events manager at Bike/Walk Central Florida, said in a press release. "It's not about racing or setting records. It's about experiencing our cities at a casual pace, connecting with fellow riders in small groups, and learning how we can all

WATER METER FINES

Department determines meter tampering through work orders and informs the finance department for billing.

Nesta objected to the ordinance due to the fairness in enforcement, the lack of data showing meter tampering is a significant problem, questions about the burden of proof, and skepticism that the ordinance would lower water rates as intended.

Sherman clarified that turning off valves during emergencies is not considered tampering.

Commissioner Alexander H. Smith asked if developers will be fined for moving meters, to which Sherman said that developers will be fined similarly to customers.

City attorney Cliff Shepard explained that the ordinance is legally defensible and applies fines for meter tampering equally to developers and customers. Also, he said that violations are typically attached to the property, not just the individual, and the ordinance's main goal is to deter tampering rather than generate revenue.

"If it's code enforcement, the magistrate in your case, because sometimes it's a code board that makes a determination based on the credibility of the witness in the evidence," Shepard said. "And it goes from there."

The second reading and adoption of the ordinance will be done at a later date.





Coach says team energy makes difference

The Apopka Blue Darters wrapped up a busy stretch of volleyball Tuesday night, playing their third match in five days. After opening with a dominant win over Jones, Apopka came up short against Forest Lake Academy and Seminole, dropping both home matches in straight sets.

Seminole 3, Apopka 0

The Blue Darters were back on their home court Tuesday night for a key district matchup against Seminole but again found themselves on the wrong end of a sweep. Despite stretches of sharp play and long rallies, Apopka couldn't finish out a set, falling 25-19, 25-20, 25-21.

Head coach Brian Mater said he saw progress, particularly in motivation and effort.

"I actually was pretty blessed tonight," Mater said. "I brought one of our [boys] varsity players to help bring

West Orange steamrolls Apopka, 51–0

Warriors air raid too strong for the Blue Darter defense

The Apopka-West Orange football rivalry dates back nearly half a century, with playoff battles and nailbiting finishes cementing its place as one of West Orange County's marquee matchups. Just last year, West Orange needed a late score to edge the Blue Darters, 20-19, in the regional quarterfinals.

Friday night brought a much different result. Behind a blistering air attack and a suffocating defense, the Warriors rolled to a 51–0 victory, one of the most lopsided outcomes in the rivalry's history.

West Orange wasted no time getting down to business. After forcing Apopka into a quick four-and-out, the Warriors took advantage of back-to-back encroachment penalties and got right to work. On the third play of the drive, quarterback AJ Chung Yuto Kawamura found across the middle. Kawamura turned upfield and sprinted 57 yards for the game's opening touchdown just over three minutes in.

Apopka attempted to respond, pushing to its own 40yard line before being stuffed off a handoff on a fourthand-1 run. That set up another short field, and running back Jayden Ammons ripped a 22-yard carry to spark the Warriors. Two plays later, Chung floated an 11-yard pass to Edison Delgado in the end zone for a 14-0 lead with three minutes left in the first

rivals, recovering a surprise onside kick to steal the possession from the Darters. Though Apopka's defense managed a sack from Kemp to stall the drive, Ryan Mc-Ginnis drilled a 23-yard field goal to extend the lead to 17–





Cranberries, cheese biscuits, and more—recipes to round out any meal

Taste of Home has some doozies when it comes to family meals. We found Orange-Glazed Pork Loin for you, and it looks deli-



cious. A reviewer declared she hasn't fixed pork any other way since she found this recipe many years ago, adding they don't care for thyme, so she just leaves it out. But they love the ginger, salt, and garlic rub, and she rates the orange glaze as "amazing." It is advised to prepare a half pound of uncooked pork loin per person. A pork tenderloin is different from a pork loin in that the pork loin is larger and has a fat cap, whereas the pork tenderloin is a leaner, longer, skinny cut. FYI, internal temperatures Fahrenheit (as measured on an instant-read thermometer) for pork doneness: medium: 145 to 150 degrees; medium-well: 150 to 155 degrees; and well-done: 160 to 165 degrees. Many people prefer their pork well done.

Susan Nielsen's recipe for venison looks delicious. She calls it "Tasty Deer Roast." We thank New Vision Community Church for sharing their interesting and informative cookbook, Feeding the Flock.

From the book titled Savannah Style, we have a lovely and pretty simple Oyster Stew recipe. If you can find freshly shucked oysters, they are the best. If not, look for shucked oysters packed in water in your grocery store's seafood section.

Mrs. Harrison Smith shares a different slant on biscuits with her Crisp Cheese Biscuits. She leaves with us this caution: "Don't let them get too brown." We found this recipe in Plains Pot Pourri.

Joyce Lampp's Cranberry Salad is a winner! It's sweet and tangy and crunchy. It is very, very good, and it goes well with all kinds of meat including ham, and turkey, or chicken.

From Flora & Ella's Restaurant in Labelle, we have a recipe for Fresh Coconut Cake that we found in Joyce LaFray Young's

book titled Country Cookin'. She devotes this book to "Famous Recipes from Famous Places." A note at end of the recipe says, "If you can keep little fingers out of the cake until it's set, it's worth the wait."

ORANGE-GLAZED PORK LOIN

By Susan Bronson Recipe from Tasteofhome.com

Ingredients: 1 teaspoon salt

1 garlic clove, minced

2 to 3 fresh thyme sprigs or 1/4 teaspoon dried thyme

1/4 teaspoon ground ginger 1/4 teaspoon pepper

1 boneless pork loin roast, 5 pounds Glaze:

1 cup orange juice

1/4 cup packed brown sugar 1 tablespoon Dijon mustard

1/3 cup cold water 1 tablespoon cornstarch

1) Preheat oven to 350 degrees Fahrenheit. Combine the first five ingredients; rub over roast. Let stand 10 minutes before slicing. Reheat reserved glaze; serve with roast.




