

# Lee Road wins 2025 Corridor of the year

Pam Welker named Citizen of the Year

Local volunteer groups were recognized on Nov. 20 for their efforts in cleaning up and beautifying streets and areas throughout Orange County District 2, including Apopka, at what would be the final year of the Corridor of the Year contest.

Contest awards were given out at the Wekiva High School Media Center, where Lee Road, maintained by Lee Road Safe Neighborhoods, won the title.

This year's competition went up and down Old Dixie Highway, Clarcona Road, U.S. Highway 441, Edgewater Drive and Lee Road.

District 2 Commissioner Christine Moore initiated Corridor of the Year in 2021, a yearly community improvement program in which volunteer groups called corridor teams work to enhance specific roads or areas in District 2, focusing on cleanliness, beautification and safety. Each team is led by a "corridor chief."

"The challenges were significantly different, and it was incredibly different with all of these businesses," Moore said. "We had fewer residential properties, and

it really presented us with some new challenges."

Participants knew that with their diligence in Corridor of the Year, property values would go up and crime rates would go down, Moore said.

Contest standards are properly maintained sidewalks and curbs, trimmed trees and bushes, adherence to road safety and septic standards, clean and well-maintained fences free of limbs and weeds, trash removed from visible areas, and garbage cans neatly stowed on the side of the house.

Bonus points could be earned for new murals in the corridor, fence cup art, stained or artistically decorated fences, and wrapped or painted utility or post office boxes, and improvements to moldy/dirty structures.

Keith Landry, Spectrum News 13 multimedia journalist, was a co-presenter and guest speaker. He emphasized the impact of making a positive difference at the local level and praised the volunteers and Moore for their efforts in improving local communities for everyone.

"You may not think that Congress is particularly effective right now. And you may not think that your state government is the very best we've ever had right now, but I am here to tell you that

# Transportation tax may return in 2026

Either the failed Orange County transportation sales tax, which voters rejected in 2022, or an infrastructure tax might make its way onto the ballot in November 2026, Mayor Bryan Nelson said during his report at the Nov. 19 City Council meeting.

In a meeting between Orange County Mayor Jerry L. Demings and municipal mayors including Nelson, Demings said he was considering putting either tax proposal up for voters' approval, according to Nel-

son. No action was taken at the meeting.

Demings was out of town this week for the Thanksgiving holiday, so he was unavailable for an interview, according to Amanda Dukes, Orange County spokesperson. However, she confirmed the mayors did have a meeting in which Demings gave an informational overview of potential paths forward to fund needed transportation improve-

"The options discussed included a Charter County Transportation Tax, a Charter County Infrastructure Tax, or not pursuing either option," the spokesperson

# Commissioners team up to give 500 turkeys

Need increased due to SNAP cuts

Headed by Apopka commissioners Alexander H. Smith and Nadia Anderson, local organizations came together Tuesday to distribute enough turkeys to feed 500 families and other foods.

Vehicles picked up the food at the Thanksgiving turkey drive at the Billie Dean Community Center. Some people even walked to the drive to pick up bags of turkeys and sides such as candied yam, stuffing, rice, fresh produce, macaroni and cheese and desserts.

Sponsors included Care Plus Health Plans, Humana, the Leach Firm and Lake Apopka Natural Gas District. Volunteers from New Hope Missionary Baptist Church in Apopka — where Smith is the pastor — assisted in sorting and distributing food.

The federal government shutdown, which lasted from Oct. 1 through Nov. 12, caused people to lose their Supplemental Nutrition Assistance Program (SNAP) benefits, which heightened turkeys, because we only had according to Smith.

"The need has grown," Smith said. "So we're just trying to meet the needs of the community to make sure that nobody goes hungry during this Thanksgiving season."

For the last three years, Smith had organized a food drive with Lake Apopka Natural Gas District and Leach Law Firm. Anderson organized a separate Thanksgiving food drive last year.

"Last year we ran out of

further need in the communi- 150," Smith said. "By comty. Some people haven't got- bining our efforts, we were ten their benefits back yet, able to provide more turkey and make a bigger impact."

The drive would welcome new partners who seek to help make a larger community impact, Smith said.

Hernando McQueen, an Apopka resident, received a turkey and enough food for at least 10 people. He said he hasn't visited other food drives or pantries and learned about the church's Tuesday food drive from a friend who called him.

"I feel very grateful," McQueen said.

The Apopka Chief's new holiday drive, Light the Way, arrived in Apopka Monday, benefiting Loaves & Fishes and Matthew's Hope.

Baptiste Dentistry for Kids and Baptiste Orthodontics are the title sponsors of the drive and are joined by several other local businesses that are serving as location sponsors.

"We have great relationships in the community from more than 100 years of history, so I think what distinguishes it is our ability as The Apopka Chief — with the help of The Shepherd — to rally the community in a way that's unlike anybody else in Apopka," Apopka Chief media advisor and drive organizer Gigi Cohen said.

Cohen said she borrowed the idea of an Apopka holiday drive from the Chief's sister radio stations in Melbourne and Gainesville.

"They do toy drives every year, and it generates a lot of community inter-

est," Cohen said. "I thought, 'Well, we could do something like that in Apopka, but we need more than toys." Loaves & Fishes, a

Christian nonprofit established in 1984, requests "gifts for low- and no-income neighbors," including toys, non-perishable food and grocery store gift cards.

"I really feel like all of our donors are miracles from heaven," Loaves & Fishes director Lory Reeves said during an interview on The Shepherd's Mike Gilland Show. "They donate and they give so effortlessly of their hard-earned money and their donations."

Matthew's Hope, a char-

ity for the homeless named after Matthew 25:35-40, requests children's toys and gift cards for older children, as well as cold weather clothing and blankets.

"Twenty-five to 30 people die every year in Central Florida from the cold," Matthew's Hope president Shelley Bradford said during the same episode of The Mike Gilland Show. "People don't understand how deep our cold is because of the humidity and the wetness in our air."

# Myriad Apopka parks upgrades underway

I would like to give you the latest updates on design and construction at our parks and recreation facilities across the city of Apopka. We have accomplished a lot in the last year, and more is being planned for the near future.

The plans for a tennis/ pickleball facility located just south of Fire Station 5

at the Northwest Recreation Complex are now 90% complete. The courts are designed, parking and stormwater plans are under final review, and the next step is to bid out for the construction of the parking

The Kit Land Nelson Park gazebo replacement structure is complete, and the next steps are to construct the platform stage and brick façade.

The design contract for the \$13.1 million tourist development tax project at the Northwest Recreation Complex — which includes four new softball fields — has been awarded to CPH, an award-winning architecture and engineering firm. We

anticipate that we can go to construction at the beginning of the new year.

The TDT Apopka Amphitheater upgrades are at 30% plan design, which will include new bathrooms, a ticket booth, more ADA parking and designated pads for food trucks.

Also at Northwest, we are at 90% design for six new soccer fields in the northwest quadrant of the complex. Our next step is final review for the design of irrigation and drainage. These fields should come online in the fall of 2026.

At Camp Wewa, the old wooden deck at the main food hall has been removed and replaced with new concrete patio space. Our next steps there include new landscaping and furniture.

As you can see, our parks and recteam along with our facilities and finance departments have been busy adding desired parks and rec amenities that we can all be proud of.

Orange Lodge No. #36 F. & A.M., the oldest Masonic Lodge in Central Florida, has been meeting in the same building longer than any other lodge in the state. In the early days, members met on the dates of a full moon so that those who had to ride or even walk for miles at night could better find their way. Thus it was designated as a 'moon lodge.' Chartered in 1856, the lodge building was used in the early days as a church and as the community's first school. Part of the building also housed Apopka's first store. The community, which evolved on the site, was known simply as 'The Lodge' until it was renamed Apopka in the 1870s.

## Community cleanup cultivates solutions

Earlier in November with assistance from Clerk of Court Tiffany Moore Russell's volunteers and the L.A.N.E.S. young ladies — we picked up trash at the intersection of Old Dixie Highway and N. Maine Avenue. This area has been troubled for decades. These issues include severe blight, traffic and safety concerns, poor quality housing, and illegal dumping.

I'm always amazed by how much I learn by walking and picking up trash. Infrastructure concerns became more apparent. Homeless county services and sheriff enforcement are needed.

FDOT needs to work on a solution for the frequentlyflooding Hawthorne Pond. The owners of the two corner lots need to fence in their properties and post "no trespassing" signage.

The city and county jurisdictions are terribly inefficient along Old Dixie. I'm proposing a swap of county and city roadway segments from Plymouth Sorrento Road all the way to Park Avenue.

Those interested in helping should join my new "people group" People of Northern Apopka (PONA) Monthly

meetings will invite city and county staff members. The inaugural PONA monthly meeting will take place Tuesday, Jan. 13. Special guests will include code enforcement officers and staff members from the county homeless services department.

Here are some solutions that developed after the clean-

The community should regularly pick up trash

The property owners must fence in vacant land and post "no trespassing" signs

The N. Maine residents must properly dispose of trash and stop parking on the right of way

The county should add speed humps on N. Maine, develop a crosswalk, and install intersection signalization

The city should install

streetlights from Boy Scout Road to Hawthorne Avenue

Homeless Services must send teams regularly to offer

Now with a plan developed, my staff and I will turn in the above requests. Once a few of the infrastructure improvements are completed, I will write to the property owners and renters to do their part.

I already organized a few gentlemen to trim up the trees, mow down weeds, and remove debris. This will be a challenge to maintain until the infrastructure improvements are made. In fact, as the men were finished cleaning up dead tree limbs and palm fronds, a person arrived and dumped more tires. I hope you give it a good year to see solid improvement.

I have been doing this kind of work for about five years now. If you need to see end results, check out previous Corridor of the Year entries, such as Sheeler Road, Clarcona Road south of GH Washington, Wekiva Springs Road, Votaw Road, and Old Dixie Highway near Dayspring Church.

# Some visions of sugar plums still dance in my head



Nope, just Christmas season in my fourth-grade classroom. There's a lot I don't miss about teaching, but if I had a chance to relive those weeks between Thanksgiving and Christmas, I would do it in a heartbeat.

That was when we put on our holiday play, titled "A Classmas Carol" and we had us a Dickens of a time.

You can guess the plot. Mean, Scrooge-like teacher is visited by ghosts of his past, sees the error of his ways, reforms and has a happy ending. Simple enough until the show takes on a life



For instance, we opened with Sir Nigel Fussypants and Dame Prunella Amplebottom seated in front of a fireplace. They introduce the show, discuss it, disagree, and go from "Nigel, darling" and "Pruny old pal" to trading insults, ending with "you pompous Eurotrash nitwit" and "you frog-faced hillbilly!" This is the last Corridor of the Year contest for Moore, who has stepped down as District 2 commissioner to run for mayor of Apopka. She plans to remain in her seat until April 27, 2026. If elected mayor, she would be sworn in on April 28, 2026, she said.

The People of Northern Apopka won the People's Choice Award and the Barn Burner Award for their work on Old Dixie Highway, from Errol Parkway to Plymouth Sorrento Road.

"I feel like it's not about us, though, just to see a difference in the neighborhood," Merry Lovern, People

of Northern Apopka corridor chief, said. "I think that's the biggest takeaway is the improvement just in that small, little run of road there. We had neighbors coming out whom we met by happenstance and helped clean up and took a really active role."





# Lake Apopka Natural Gas District finishes 7 of 8 pipeline projects

The Lake Apopka Natural Gas District (LANGD) has completed seven of its eight pipeline projects and they are operating as intended, including many in Apopka neighborhoods, according to information presented at the district's regular board meeting Mon-

All eight projects are to address natural gas distribution pipelines in several neighborhoods, including those in Apopka. Project eight, which is Fullers Cross Road located between Winter Garden and Ocoee, began construction on Nov. 12 with an anticipated wrap-up by the first quarter of 2026.

The U.S. Department of Transportation Pipeline and Hazardous Materials Safety Administration (PHMSA) is funding all of LANGD's eight pipeline projects through the

Natural Gas Distribution Infrastructure Safety and Modernization (NGDISM) grant pro-

NGDISM aims to increase public safety, preserve public health and cut down methane emissions from natural gas distribution equipment, per a past LANGD press release.

LANGD is currently working on its fiscal year 2025 PHMSA NGDISM grant application requesting \$14 million. Its status update has been delayed due to the federal government shutdown, which lasted from Oct. 1 to Nov. 12 because Congress failed to pass appropriations legislations for the 2026 fiscal year, Brent Haywood, LANGD CEO/general manager told the board Monday at the district's Winter Garden office.

"Obviously, with the government shutdown, [there are] a lot of things that stand still," he said.

In two years, PHMSA bestowed grant money twice to the district for the reconstruction, overhaul, and/or substitution of natural gas distribution pipeline systems.

In May 2023, PHMSA awarded the gas district \$3.1 million in initial funding. In November 2024, PHMSA awarded the gas district a second check for \$132,470.80.

### **Customer increase**

From October 2024 to October 2025, LANGD is almost 1,400 customers "to the positive," Haywood said. Previously, LANGD was predicting between 1,000 and 1,200 customers.

"We feel like that's just showing the positive impact that natural gas has had in this past year," Haywood said.

In May, LANGD announced it reached 30,000-customer milestone in its 65th year of existence, reflecting 15-year growth.

## Scholarships and internships

The LANGD has been promoting its scholarship and internship programs for local schools, including Wekiva High School, thus encouraging students to pursue a trade school.

LANGD has met with West Orange and Ocoee high school staffs, with positive re-

"The reception has been off the charts. All of the staff there at schools are so excited about us recognizing the fact that skilled trades are an important thing and that we're not pushing necessarily the college route," Haywood said. "I think Ocoee and a couple other schools are really looking at making harder pushes LANGD also met with

towards skilled trade as well."

Wekiva High School and Acceleration Academy West about the scholarship and internship programs. These schools were also very receptive, due to understanding the scholarships' purposes, not just that LANGD announced the resources.

Haywood credits LANGD's public relations team, LANGD staff and himself for communicating that skills trades are "the next generation of generational wealth."

"You're going to make money based on what you can do with your hands, and not necessarily just what you can do with your mind," Haywood said. "We've spent a whole generation teaching people that your mind is the most powerful tool, and now that we've got AI, it's really the hands that are going to be the most powerful tool."

# 5 Rock Springs Elementary students receive sensory support packages

Orange Lodge No. 36, I Gave a Duck donate packages

I Gave a Duck, a nonprofit supporting families affected by autism, partnered with the Free and Accepted Masons at Orange Lodge No. 36 to deliver five sensorysupport packages Nov. 21 to five Rock Springs Elementary students with autism.

"The whole thing behind I Gave a Duck — or just IGAD — was getting mon-

ey to the actual victims — the people who need it the most," IGAD founding board member and Orange Lodge treasurer Gerald "Jerry" Rooks said in an interview with The Apopka Chief. "I wanted to bring that same concept into this and say, 'I just don't want to drop a check off at some office. Let's find a way to get whatever it is directly to the families."

The children received tactile sensory pads, calming tools and fine-motor fidgets tailored to their individual sensory profiles, according to a Nov. 23 press release. Each device is designed with the goals of improving focus,

enhancing participation in the classroom and reducing anxi"It's sensory devices that

the kids can actually take

home, because in some fam-

ilies, they only get it while they're at school, and they always want to take things home, and they're just not allowed to," Rooks said.

Rooks decided to let the teachers at Rock Springs Elementary select students who would most need the support.


"I have a full-time day job, so I can't be driving all over central Florida trying to find a family," Rooks said. "I think the best program is we work through the lodges, through the schools, through the teachers who can identify those children who need what sensory devices most."

Rooks said his goal is

to establish the program throughout the 16th Masonic district in Florida and then expand to other districts. According to the I Gave a Duck website, an initial investment of approximately \$18 million is required to implement the donation program across the

"This isn't about me," Rooks said. "This is about a great way to help. I think that autism is just growing, growing, growing — and it shouldn't be, but it is. Let's do something to help."

## **HOLIDAY HISTORY**

# St. Augustine hosted Thanksgiving in 1565

The scene is familiar, matching the historic description of the first Thanksgiving: a group of grateful European settlers share a Thanksgiving feast with a local native tribe.

If that date seems a little early, that's because it is. But history shows there was a Thanksgiving in what became the United States 56 years before the traditional first Thanksgiving, which was a three-day feast in 1621 with the Wampanoags, and the Puritan group better known as the Pilgrims.

The location is St. Augustine, Florida, and the date is Sept. 8, 1565.

This is how the National Park Service describes the earlier event, in wording used at the Castillo de San Marcos National Monument.

"On September 8, 1565, Pedro Menéndez de Avilés and 800 Spanish settlers founded the city of St. Augustine in Spanish La Florida.

As soon as they were ashore, the landing party celebrated a mass of Thanksgiving. Afterward, Menéndez laid out a meal to which he invited as guests the native Seloy tribe who occupied the site."

The treatment of Native Americans since the early days of contact with Europeans has led many to diminish the story of the first Thanksgiving. Certainly, the realities of that feast are much more complicated than the construction paper turkeys and Pilgrim hats some of us cut out when we were in elementary school.

Some have even questioned the presence of the Wampanoags at the feast. There are two primary sources for their attendance, though: Edward Winslow and William Bradford, both of whom were there.

Tisquantum, or Squanto, the Patuxet hero of the story, was a real person. After being captured and taken to Europe, he was able to escape and return to North America, making him present when the Pilgrims arrived. He really did show the Pilgrims where to catch fish and eels, and how to plant their corn, which led to their survival and their successful year.

President Abraham Lincoln made Thanksgiving an annual holiday beginning in November 1863, in the midst of the Civil War. Here is how he began his proclamation;

"The year that is drawing towards its close, has been filled with the blessings of fruitful fields and healthful skies. To these bounties, which are so constantly enjoyed that we are prone to forget the source from which they come, others have been added, which are of so extraordinary a nature, that they cannot fail to penetrate and soften even the heart which is habitually insensible to the ever watchful providence of Almighty God."

Lincoln then made remarks about the war. To put the timing into context, Lincoln delivered his famous Gettysburg Address on Nov. 19. The Thanksgiving holiday he proclaimed was just one week later, on Nov. 26.

In his way, Lincoln was echoing the words of George Washington, who in his very first year as president called for a one-time Thanksgiving celebration. That observance was also on the fourth Thursday of November—which fell on the same date as Lincoln's proclaimed holiday in 1863.

History shows that progress is not always linear. Initial good relations between European settlers and Native Americans faltered, often with catastrophic results. Divisions already apparent at the time of George Washington's presidency led to the Civil War in Lincoln's.

Gratitude, though, is always available. Though we may spend much of the day binge eating, watching football, or trying to avoid arguing about politics, this is a day set aside to be thankful.

said via email on Monday. "This discussion was purely informational in nature. No decisions were made, and no votes were taken. The intent of the conversation was simply to ensure that municipal leaders were aware of the potential options under consideration.'

To make either tax proposal more appealing, Orange County should "treat the cities like we're equal partners," Nelson said in a Monday interview with The county voters rejected the Apopka Chief. "Right now, we're not."



From Paths of Sunshine Cookbook, we found Royal Wild Rice Casserole. You use canned mushrooms if you don't have any fresh.



They add a tip that "A lettuce leaf added to canned vegetables when heating will add fresh vegetable taste."

We bet your family has never had a pizza like this one before. It will take around 15 minutes to bake in a 450-degree oven. I think I'll have my pizza for breakfast, but then again, I love breakfast at any time of the day!

Emily Meggett, author of Gullah Geechee Home Cooking, Recipes from the Matriarch of Edisto Island, has instructions for cooking oven bacon for us that are so very simple. She wrote these instructions in her book, and here they are for you!

I have a small paperback cookbook titled The Original Country Cookbook published in 1976 by Paragon Products, Inc., in Pompano Beach. A friend gave me this little gem wherein I found a recipe for making Scrapple, which may have some interest among our readers. I can remember my mother cooking Scrapple for breakfast when I was a child. I've heard people on the radio sneering at Scrapple, but the ingredients for this breakfast item are made from the finest pork cuts and seasonings.

Layers of sugary crunch are in each and every bite, and the sweet and woody cinnamon flavor shines throughout the dish. The flavors of this dish represent fall and winter to me, so I bake this dish when I want a little spoonful of comfort during the cooler months. Serve this dish with vanilla ice cream or whipped cream for a real treat."

**ROYAL WILD RICE CASSEROLE** 

Recipe from Florida Federation of Garden Clubs

Paths of Sunshine Cookbook

1/2 cup butter

- 1 pint fresh mushrooms\*
- 1 onion, chopped
- 1 clove garlic, minced
- 2 tablespoons chopped green pepper
- 1 cup chopped pecans 1 cup wild rice
- 3 cups chicken broth
- Salt

Heat butter; add mushrooms, onion, garlic, and green pepper. Cook for 5 minutes. Add pecans and cook 1 minute. Wash rice well and drain. Mix with other ingredients, add broth and seasonings to taste. Turn into a well greased 2-quart casserole. Cover and bake at 350 degrees for 1 hour. Holds well in a warm oven. May be frozen. Delicious!

\*If fresh mushrooms are not available, use two 4-ounce cans of mushrooms sliced in butter sauce.

Cornmeal, for baking sheet Flour, for surface during shaping pizza

- 1 pound pizza dough, thawed if frozen
- 1 tablespoon Dijon mustard
- 2 ounces Gruyère cheese, coarsely grated (about 1/2 cup), divided
- 2 ounces thinly sliced deli ham
- 1 bunch spinach, thick stems
- discarded
- 4 large eggs

1) Heat oven to 450°F. Lightly dust baking sheet with cornmeal. On floured surface, shape dough into 16-inch circle. Place on prepared sheet. 2) Spread

mustard over dough, then sprinkle with three-fourths of the Gruyère. Top with ham, spinach, and remaining Gruyère. 3) Working with 1 egg at a time, crack eggs into small bowl, then slide onto pizza. Bake until egg whites are set and crust is golden brown, approximately 15 to 17 minutes. Serve with salad if desired.

## **EMILY MEGGETT'S OVEN BACON**

Recipe from *Gullah Geechee Home* Cooking by Emily Meggett

## 12 slices thick-cut bacon

1) Preheat your oven's broiler to 500 degrees Fahrenheit, or its highest setting. 2) Arrange the bacon in a single layer in a rimmed baking pan and place it on the highest rack in your oven. Broil until browned on one side, about 2 minutes. 3) Turn the bacon and brown the other side. Watch the bacon closely. It will cook quickly, about 5 minutes total. 4) Remove from the oven and place the bacon on a paper towel to absorb the excess grease.

## **SCRAPPLE**

Recipe from Paragon Products, Inc., The Original Country Cookbook

1/4 lb pork liver

- 1-1/2 pounds pork shoulder 1 qt water for cooking
- 2 teaspoons salt
- 1 cup water
- 2 cups broth from cooking
- 1 cup corn meal
- 1/4 cup chopped onion
- Dash ground cloves
- 1/4 teaspoon dried thyme
- 1 teaspoon dried sage
- 1 teaspoon dried marjoram 1/2 teaspoon pepper

Combine liver and pork shoulder in a saucepan with 1 quart water and cook slowly for 1 hour. Drain, reserving broth. Discard bones and chop meat fine. Blend salt, 1 cup water, 2 cups broth, and corn meal in pan. Cook, stirring constantly until thick. Stir in finely chopped meat, onions, along with spices and herbs. Cover and simmer 1 hour. Pour into loaf pan and cool until firm. Cut into slices, dust with flour, and fry in a small bit of fat until crisp.

## **EMILY MEGGETT'S APPLE BROWN BETTY**

6 slices white or whole-wheat bread 7 apples (2-1/2 pounds) preferably **Granny Smith** 

1 tablespoon ground cinnamon 3/4 cup raisins

1/4 cup unsalted butter, cut into pieces

1/3 to 1/2 cup packed brown sugar, plus more to taste

1 tablespoon cornstarch 1/4 cup fresh orange juice (from 1

orange) 1) Preheat your oven's broiler to 500 degrees Fahrenheit, or its highest setting. On your oven's highest rack, broil the bread on both sides, about 7 minutes total. Remove the bread from the oven and let it dry out until crunchy. 2) Cut the bread into squares, and place one half of the bread squares in the bottom of a greased 9- by 13-inch baking dish. 3) Set the oven temperature to 350 degrees Fahrenheit. 4) Wash, peel, core, and slice the apples. 5) In a large mixing bowl, combine the cinnamon, raisins, butter, brown sugar, and cornstarch. Add the apple slices and toss to coat. Spread half of the apple mixture over the bread in the baking dish and repeat the layering until the dish is full. Sprinkle the orange juice over the entire dish. Cover with foil and bake for 25 to 30 minutes, until the apples are cooked. Remove the foil and bake, uncovered, for 10 minutes until brown.



# Look out for manatees movin' to warmer waters

Hello Folks,

I hope everyone had a great Thanksgiving and you got to eat all of your favorite foods and then some. There is nothin' better than Thanksgiving with family and friends.

If you are fishin' on the Harris Chain or any waters in our state, you need to be on the lookout for manatees! They are movin' to warmer waters in both fresh and salt water. You need to abide by all manatee protection zones.

Durin' the cooler months, seasonal manatee zones require boaters and person-

al watercraft users to reduce speed in certain areas or to avoid those areas altogether to prevent collisions that can injure or kill manatees.

If you see injured, distressed, sick, or dead manatees, please report it to the FWC's Wildlife Alert Hotline. The number is 1-888-404-3922.

Believe me when I say that you can find 'em in the Harris Chain, because just last year I had one swim right by my boat while I was fishin' in Lake Beauclair. I used to fish a lot in the St. Johns River, and I have had 'em come right up beside my boat and bump it and scare the heck out of me. So please be

Up on the St. Johns River, folks are still gettin' limits of specks in Lake Woodruff. Folks are havin' a blast catchin 'em... and eatin' 'em! You can catch specks on jigs and jigs tipped with a minner.

Kyle at Bitter's B&T reports the specks are still bitin' in Lake Monroe and Lake Jesup. Most of the specks are bein' caught in deeper water driftin' with a minner fished naked — which means no bobber or weight is bein' used; just put the minner on the hook and let it sink to the depth you want to fish. If it's windy, you might have to add a little weight to the line to keep the minner down to the depth you want it. Most folks just drift usin' this technique, and they are catchin 'em!

The bass fishin' has started to pick up in most of our lakes this past week. It may take some time to figure 'em out, but once you find 'em, you should be able to catch 'em. Look for the bass to be feedin' on or around the shell beds, submerged hydrilla, and eelgrass beds. You need to fish a variety of lures to see which one works the best for you. You can also fish with shiners over the submerged

hydrilla and eelgrass beds. The fishin' is also startin' to pick back up in the Butler Chain. Folks are seein' some schoolin' action on the chain. Make sure you have a lipless crankbait tied on to one of your rods in case the bass come up and start thrashin' the water while they're feedin' on bait fish. They may only feed for a short time and you want to be ready for 'em. You won't have time to tie on another lure before the bass auit feedin'.

Well, that's it for this week. Now that Thanksgiving is over, I hope you're ready to go catch some fish!

# Mustang boys soccer on fire to start season

Wekiva starts the season 4–1–1 after comeback win

The Wekiva boys soccer team headed into Thanksgiving break with momentum and an identity built on defensive grit, late-game belief and the hunger to bury last year's 3-13 record deep in the past.

Eight minutes into the second half, the momentum changed. Off a corner, Omar Roman rose above the Vipers' back line and headed



In week two, the Mustangs exploded offensively in a 5-0 rout of Evans, followed by a 2-1 win over Colonial. Their lone loss came against Oak Ridge, 2–1, but they responded two nights later with

the comeback thriller over Lake Buena Vista.

James believes their newfound resilience is no accident.

"The key has been our dedication in winning," James said. "We talked about it from last year, about just getting better from our 3–13 record... We're just trying to improve in small ways."

Offensively, Jimenez-Hernandez has led the charge with eight goals, while Roman has three goals and an assist. Playmaker Kevin Fuentes-Ortega has recorded four assists, slicing apart defenses from the midfield, while Bohdert, William Lucas and Fuentes-Ortega have also netted goals.

James said the hot start has been a team effort.

"So many players are standing out in their own ways," he said. "Everyone touched the ball against Buena Vista. It was the perfect win."
