City Council races begin to take shape

Velazquez, Smith file for re-election

Vice Mayor Diane Velazquez filed to run for reelection Monday, one of several recent filings for City Council seats up for grabs in the March municipal elec-

Velazquez, who holds Seat 2, is a familiar face in the community, not just as a public figure but as someone who frequents community

events and sits on several organization boards.

"I just think it's really important that our commissioners be very involved, very visible and accessible, not just to the residents, to the businesses, to the schools," Velazquez said in a Tuesday interview with The Apopka

Velazquez's priorities for her campaign are to keep serving and supporting the community, one way being in educating people about land development issues.

"A lot of those developments aren't going to become a reality for another three to 10 years," Velazquez said. "I think that's one of the things that's important,

to kind of assure our community, is that a lot of these developments that we are approving because housing is a necessity right now. We have such a shortage of housing. It's just that when people hear these developments coming, in their mind, they think they're coming within next year or the year after, but when I speak to the developers, I've always asked for a timeframe."

Velazquez was first elected to the Apopka City Council in 2014 and has held it since that year, except for 2018 to 2020, when she was

appointed planning and zoning commissioner for Orange County District 2. She was elected to Apopka City Council Seat 2 again in 2020.

On Dec. 3, former City Commissioner Sam Ruth announced his campaign for City Council Seat 1, currently held by Alexander H. Smith.

In a Facebook post, Ruth said his campaign will focus on three priorities he believes Apopka currently needs: infrastructure before expansion, restoring profession-

The Winn-Dixie grocery store in Errol Plaza is set to close in early March, according to a statement from parent company Southeastern Grocers.

"We can confirm the Winn-Dixie grocery store located at 1565 W. Orange Blossom Trail in Apopka will close in early March to convert to ALDI," said Meredith Hurley, senior director of communications and community for Southeastern Grocers. "The adjacent Winn-Dixie Beer, Wine & Spirits store will remain open."

Rock Springs Ridge HOA acquires golf course for \$7.3M

Contract ensures land won't be sold for development

After years of uncertainty and debate over the future of a defunct golf course, the Rock Springs Ridge homeowners association (HOA) has inked a deal to acquire the land, ensuring it will not be sold to developers.

The HOA and the golf course's current owner, known as the Golf Group, signed a 15-year lease-toown contract at a Tuesday night HOA meeting, which finalizes one of three options the HOA had presented to residents during a July town hall.

"We now have an interest in the land, so it can't be

developed," HOA president Simon McKenna said in a Wednesday phone interview. "When the final payment is made, we, the Rock Springs Ridge Homeowners Association, will own the land. So it won't be developed."

Unlike the initial options of a municipal bond — which McKenna said the city was unfavorable toward — or a land swap deal with Florida Fish and Wildlife Commission (FWC), the HOA opted for a direct 15-year lease-purchase agreement with the Golf Group.

The total cost of the purchase, including interest payments, is set at \$7.3 million. The original purchase price was \$5.5 million. This deal will be financed entirely through a roughly \$370

Traffic is top concern about Paulucci Acres at meeting

Developer to fund infrastructure without impact fees credit, attorney says

The 1,034-unit Paulucci Acres development continues to move forward, but not without city discussion centered on its potential impact on the surrounding area, including traffic and roadway capacity.

At the Tuesday Planning Commission meeting, the board voted to recommend approval of Paulucci Acres' rezoning and the planned development master plan. The City Council will review these in a first reading at its Dec. 17 meeting, with a second reading to follow Jan. 7.

City traffic coordinator Bill Wharton said the city's traffic analysis shows nearby roads "continue to operate

at a satisfactory level of service" with the Paulucci Acres project, with safety supported by new turn lanes and multiple access points.

Paulucci Acres is a 618acre property proposed for construction east of Vick Road and north of Ponkan Road. The Pulte Homes development proposal includes 1,034 residential units, two non-residential lots, and an estimated 146-acres dedicated to parkland.

This summer, the Apop-

ka City Council approved the annexation of 39 acres of land for Paulucci Acres.

Mike Woodward, the city's consultant from Kimley-Horn, said that Ponkan Road would carry about 10,000 vehicles a day once Paulucci Acres is fully built, still well below the roughly 15,000-vehicle threshold where the road would be considered at capacity.

6 ways to improve local infrastructure

I wrote in last week's column about Orange County government's job of maintaining more than 3,000 miles of roadway. And, as we know, that's enough mileage to cover a trip to California.

Resurfacing, with only twolane roads, while many roadways are four and five lanes, requires \$1.5 billion every 12-15 years. The county public works budget is only \$250 million annually. Thus, the county is behind over \$5 billion dollars.

To reiterate, before providing solutions, consider that the county resurfaced West Ponkan Road from US 441 to Plymouth Sorrento with a price tag of \$2 million. A wise former county CFO, Randy Singh, told me upon my election to the County Commission in 2019, that the public works budget must allocate sufficient funds to maintain roadways before contemplating any additional capacity. It costs around \$5.5 million per "lane mile" to expand road-

What are the solutions for addressing lagging infrastruc-

ture improvements? Lobby the Florida Legislature effectively so they pass **County Commissioner** District 2



fewer developer-friendly, lastminute laws. The Legislature does not allow developers to be forced to expand roadway ca-

Stop building suburban sprawl neighborhoods; keep things compact, protecting rural areas. For this I borrow from Charles Marohn, founder and president of Strong Towns, an organization I have studied with and benefitted from in policymaking decisions.

In an essay published last May, Marohn writes: "When you sprawl outward, every new house adds more to the public obligation to maintain. More pipes, more roads, more services. But there's no corresponding bump in tax productivity. Instead, you create... a place where every new resident consumes more than they contribute. It may start out exciting, but eventually the community is stretched too thin."

Work with CFX on contributing toward improvements near major highway entrance-

Continue to seek federal money through membership in MetroPlan. I will serve as Chairperson of MetroPlan beginning February 2026. While on the MetroPlan board, I secured \$5 million for Rock Springs and Welch roads improvements. Design begins in

Seek additional state and federal grant funding.

Strike better road deals with developers who cause the increased need for capacity.

(For example, I lobbied for \$5 million for Ponkan Road improvements on the Paulucci project over and above the regular transportation impact

I hope this column and last week's give you a better idea of the challenges local governments face in maintaining and funding new roadway infrastructure. Let's solve our infrastructure woes together.

That leaves school board members and administrators on a steep learning curve for the opportunities it can provide, as well as the challenges that need to be addressed.

What was impressed upon me most was that this is not something to be afraid of. For generations, teachers have worked miracles with limited time and wide-ranging student needs. As a board member, I often hear from teachers that they have so much on their plates

AI can give teachers the gift they need most — time. Teachers today juggle instruction with grading, paperwork, reports, lesson planning and data analysis. AI can help handle routine tasks such as generating practice activities, organizing student feedback, and identifying learning

When teachers regain those hours, they reinvest them where they matter most: building relationships, supporting students emotionally, and designing engaging lessons.

AI also holds a powerful

promise for students who need extra support. From translation and speech-to-text tools to reading support tools, there are many ways it can be used.

Used well, AI does not replace teachers — it extends their reach to students who need more attention than the traditional system can always

None of this potential happens without responsibility. Schools must lead with clear expectations about ethical use, privacy protection and academic integrity. Students must be taught not just how to use AI, but how to question it, verify information, and understand its

AI should never replace thinking — it should strength-

As we move into the new frontier of learning for this generation, I am grateful I had the opportunity to learn so much at the conference. It has inspired me to research more and learn more so I can help ensure that our district is on the right path moving into this.

The best way to ruin a song is to live through it. Old Bing wouldn't sing so sentimentally about a White Christmas if he'd ever spent 10 hours of one in a Toyota with no heater, a dying battery and a disappointed wom-

I was working in Georgia in the mid-1970s, and it looked like I might be spending the second Christmas of my life away from home. The first had been overseas in the Army. Somehow, Tennessee seemed less accessible this time, even though I didn't have a Pacific Ocean and North America to cross.

This is when Carole, a young reporter, dropped by

my desk and said she was going to drive through Knoxville on the way to her home in Kentucky and invited me to ride along and share the

Well, she was much more the stuff of dreams than any snowy holiday would ever be, so the deal was sealed. She would pick me up after my shift ended at 2 a. m. and I would drive through

the night while she rested up. My arrival would be a surprise gift for my parents. Carole would drive on, all rested up, have her holiday and then pick me up two days later to reverse the trip. In my version, I would charm her, and we would return a couple.

It was all visions of sugar plums and tidings of good joy — until I got behind the wheel. I didn't know she had a stick shift, and she didn't know I couldn't drive one. That poor little car died at least a thousand deaths as we went grinding off into the

It was not a well-rested, cheerful woman who dropped me off the next morning. The surprise visit wasn't so cheerful either. I arrived to find my parents walking toward their car with packed suitcases, heading off to Nashville to spend Christmas with my older brother's family.

My younger brother picked me up to spend the holiday at his house with half a dozen fellow bartenders and three or four cocktail waitresses and former and current girlfriends. That could have been festive except that White Christmas everybody dreams about arrived.

This wasn't fluffy Bing Crosby flakes, either. It was good old Northern Southern icy slush. Everybody went to work at various nightclubs and got weathered in. Nobody could come get me, so I was stuck playing backgammon with an Amy Winehouse look-alike who asked me about once every 15 minutes if I was sure I hadn't brought any whiskey.

The song "(There's No Place Like) Home for the Holidays" still makes me wince.

The weather got better just in time for me to rendezvous with my ride home. We met at a service station near the interstate, and I found her bundled up and shivering. The heater was out and the battery was so close to dead that she didn't dare turn the car off. None of the accesso-

The windshield was like frosted glass, and I could see her breath when she said, "Dad told me it was probably because we had to restart so many times." She didn't mention that this was due to me stalling it out so much. She didn't have to. The glare said it all.

We pulled out onto the highway just as the snow started again. The trip takes less than five hours these days. We did it in a little over 10 with no radio and hardly a word exchanged.

It was a silent night. And, yeah, that song is pretty much ruined for me, too.



City Council greenlights Kelly Park Road agreement

Agreement budgets \$15 million so far to finance project

The Apopka City Council approved on Dec. 3 a second amendment to the Kelly Park Road funding agreement, officially adding RCS Construction Company of Central Florida to the list of approved contractors for the interchange's construc-

Also known as the pioneering agreement, the roadway funding agreement leverages contributions of developers known as pioneers, who put money into work on Kelly Park Road Interchange.

"We've been asked to add to the list of approved contractors a company called RCS because apparently, there's been some good experiences with the company," city attorney Cliff Shepard told the City Council. "They've been low bidder in a number of jobs, and they do quality work."

The current pool of funds is at an estimated \$15 million, with

the agreement allowing for the total to climb up to \$20 million if more properties are added.

The city and co-developers executed the pioneering agreement in June 2023 and amended it in early 2025.

Commissioner Nick Nesta asked about the acquisition of rights-of-way, specifically bringing up the privatelyowned "RJR parcel." Shepard explained that the RJR already closed, while another will soon close with final title work wrapping up.

A third parcel, which Shepard said all parties involved call "the dentists," remains unresolved due to concerns about road configuration.

On Dec. 4, Shepard met with one of the property owners, who operates under an entity called "Kelly Park Self Storage," whose land is needed for the Kelly Park Road expansion. No building exists on the property, but a storage facility is planned for it.

No outcome came from that meeting, and further meetings would be required between the property owners and their representatives, and the road designers, contractors and engineers, according to Shepard.

"The outcome is still up in the air because there will be more meetings required with the people who are designing the road and the property owners' representatives to determine whether they can come to an adequate solution that satisfies the property owners' concerns," Shepard said in a Monday interview.

Only after a design-related agreement is reached could Shepard prepare a contract to acquire the portion of the property needed for the road, including the payment amount. Shepard said the parties were trying to schedule a follow-up meeting to resolve that matter, but he does not have a timeline for when an agreement may be reached.

"I hope it's soon, because we obviously need to get this done one way or the other," Shepard said.

During the council meeting, Nesta also asked about the provision in the pioneering agreement regarding more funding if costs go past expectations of the project.

Shepard said that the \$9.7 million in impact fees collected may be used to cover any shortfalls, but only if the pioneers agree to it. He added that he, Mayor Bryan Nelson and city staff met with the pioneers several weeks ago about the impact fees used for this purpose. Afterward, Shepard said, the pioneers separately dispatched their own written communication to the city saying they're okay with the usage of impact fees if necessary.

The Kelly Park Road Interchange is a major road construction project around Kelly Park Road, meant to improve traffic movement, support continuing development in the area, and satisfy future transportation needs.

Joseph Beninati, developer and founder of the Wyld Oaks development, said at the City Council meeting that the Kelly Park Road Interchange project is now fully funded, a fixedprice contract with RCS has been proposed, and the bidding process was thorough and competitive. The project has a \$1.8 million contingency fund, according to Beninati.

Wyld Oaks is a 215-acre mixed-use development currently under construction, located off the 429 Beltway and the West Kelly Park Road Interchange.

"We have to amend this agreement, because when we signed the pioneering agreement, there were other pre-approved vendors that had also earned a solid track record in Apopka for site work," Beninati said. "So, we wanted to give them [RCS] the opportunity to bid on this project."

During public comment, resident Albert McKimmie pointed to what he observes as the city's lack of transparency and the likelihood that delays and increasing costs on Kelly Park Road will take away funds from Golden Gem Road and other infrastructure projects. McKimmie said the city must address Golden Gem Road as a whole infrastructure, not just in sections.

"They've not been forthcoming with information, and there's a lot of questions that I have that remain unanswered," he said.

Resident Rod Olsen pointed out how per the first pioneering agreement no certificates of occupancy would be issued until Kelly Park Road was brought up to standard, yet certificates of occupancy have been given to new developments despite the lack of Kelly Park Road improvements.

tioned several aspects of Paulucci Acres, including access to Rogers Road, the possible vacation of Pittman Road, wetland maintenance, the relocation of gopher tortoises, and the development's impact on existing residents.

Planning Commissioner Eric Mock asked city staff for clear, printed before-and-after traffic counts related to Paulucci Acres.

"The average person's not going to go through that process. They'll just basically come up and say, 'This is a traffic nightmare," Mock said. "I think those of us in positions of responsibility, we need to step that game up and have that information available."

Commissioner Howard Washington was skeptical of another roundabout, comparing it to a "horror story" circle on Binion Road and urging the designer to ensure drivers can slow down without having to nearly stop in moving traffic.

meetings Community for Paulucci Acres were held four times this year: January, March, August and most recently, Dec. 2.

At the August community meeting, residents expressed concerns about what they saw as significant traffic and safety issues related to West Ponkan Road. They also sought additional information about the proposed roundabout and detailed plans for the 145-acre city park, such as its access,

fencing and trail system, according to the meeting summary notes. Attendees also questioned Paulucci Acres' impact on surrounding communities, commercial parcel restrictions and the pricing and nature of the new homes.

The development is envisioned to take about a decade to build out and involves seven different phases, according to Mohammed Abdullah, the developer's traffic consultant for Paulucci Acres. He also

said that major Ponkan Road work will come before the neighborhood fills in, noting that no homes north of Ponkan can be sold until the road upgrades are built under conditions written into the planned development.

Attorney Elesa Sowell, representing the developer, said the Paulucci Acres project would not only bring new housing but also "enable a solution" to existing safety problems on Ponkan Road, with Pulte Homes

Orange County approves \$787K sleeper bus program for homeless

Matthew's Hope created initiative as temporary shelters

By Teresa Sargeant Reporter

The Orange County Board of County Commissioners (BCC) unanimously approved on Dec. 2 a oneyear contract totaling more than \$787,000 for a nonprofit to set up a sleeper bus program to help people who are experiencing homelessness get back on their feet.

The sleeper bus program is organized by Matthew's Hope, a nonprofit outreach organization located in Orange and Brevard counties.

District 1 Commissioner Nicole Wilson introduced pastor Scott Billue, Matthew's Hope founder and CEO, to the BCC. Wilson said she visited Matthew's Hope emergency shelter buses in September in Brevard County, where the facilities currently operate. She encouraged people to visit the buses since "these shelters are already changing lives."

The BCC's vote to approve the sleeper buses is a "meaningful" day for Billue, Wilson told the board.

residents all over west Orange County in an effort many have worked tirelessly to bring today," Wilson said. "I am so thrilled to support him in the homeless outreach efforts of Matthew's Hope and the unbelievable dedication he has to improving people's lives."

Billue launched Matthew's Hope in 2010 as a way of temporarily housing the homeless population from the cold weather.

Matthew's Hope mobile teams are assisting home-"It [the buses] will serve less men, women and children throughout the county, from I-4 west into Clermont "before the sun rises" and as the cold weather approaches. Billue said state legislation has caused anxiety and tension among the homeless, motivating them to "do desperate things."

"Don't buy into the false narrative [of] what homelessness looks like," Billue said. "The truth is that many are elderly, some very ill, while others are physically and or mentally disabled. And then there are those young families with children with no

understanding how they are supposed to survive on our streets due to the increased law enforcement of new laws coming out of Tallahassee, basically making it illegal to sleep outside — illegal to be homeless."

In 2024, Gov. Ron De-Santis signed House Bill 1365 into law, which requires counties to make sure that homeless people get the necessary drug addiction and mental health services while staying in a designated location off public streets.

According to a March

20, 2024, press statement from the governor's office, this law is aimed at prioritizing public safety.

"Florida will not allow homeless encampments to intrude on its citizens or undermine their quality of life like we see in states like New York and California," De-Santis said in the statement. "[This] legislation upholds our commitment to law and order while also ensuring homeless individuals have the resources they need to get back on their feet."

A sleeper bus is a refurbished bus used as a mobile temporary homeless shelter. Each bus can accommodate up to 20 people overnight for up to three days. These vehicles serve as a way of providing sleep and comfort, security, and connection to resources, including medical support and mental health

Orange County anticipates that the sleeper bus program will serve about 2,000 people every year, Mayor Jerry L. Demings said.

After voting, Demings highlighted other consent agenda items the board had passed that will serve communities throughout Orange County including the sleeper bus program.

"Almost all those issues that you bring to us require some type of financial solution," Demings said. "This is where, within our budget, where we have flexibility to address these myriad issues, this is how we do it. So keep that in mind as you hear some other narratives that sometimes come out, or other reasons."

In June, the Apopka City Council approved the Matthew's Hope sleeper bus pro-

At the Dec. 3 City Council meeting, Mayor Bryan Nelson said Billue contacted him about news of Orange County's approval of the sleeper buses.

Nelson said he will reach out to some of the area churches to provide a parking area for the vehicles, and that electricity can be provided to run the sleeper buses.

"It might be six months before we get the sleeper bus, but it's on its way and so we just want to make sure we've got the location," Nelson said during his report. "If you've got any locations that people would [think] make sense, feel free to give us a call because we've got to get with Duke Energy to make sure we've got the power needed to run the sleeper bus."

increase in HOA annual dues per household, with no city funding or external borrowing involved, McKenna said.

number of Winn-Dixie and Harveys Supermarkets will convert to the ALDI format over the next several years," a March 7, 2024, ALDI press release said. "ALDI anticipates that approximately 50 stores will begin the conversion process during the latter half of 2024, with the majority of these stores reopening as ALDI in 2025."

Even after private investors announced their purchase of Southeastern Grocers from ALDI in February, ALDI still intended to complete its conversion plans, which included reopening an estimated 220 Winn-Dixie and Harvey Su-

permarket stores as ALDI's by the end of 2027.

"ALDI and SEG leadership will continue to work together closely to ensure a smooth transition, with dedicated leaders overseeing the store conversion and hiring process," a Feb. 7 press release from Southeastern Grocers said. "SEG will continue to operate the remaining stores identified for conversion in the normal course of business, with the same level of care and focus on quality and service, up to and until each respective store is closed for conversion."





Mustangs top Boone, improve to 8-1-1

Wekiva boys soccer walked into Boone on Tuesday night, riding a four-game win streak, and walked out with a statement victory that not only extended their streak but rewrote program history.

Wekiva girls make tournament final

Mustangs defeat Horizon, Dr. Phillips, lose to Ocoee

For two games in the Metro West Tournament, Wekiva looked every bit like a team built for a championship moment. But when the moment finally arrived in the Friday night final, the Mustang offense that had overpowered Horizon and Dr. Phillips fell silent under Ocoee's relentless pressure.

The Knights smothered Wekiva from the second quarter on, using wave after wave of full-court pressure and a barrage of 3s to hand the Mustangs a 55–26 loss in the title game. It was a stark turn from the dominant form Wekiva showed earlier in the week, and a reminder of the "road-warrior mentality" head coach Jerry Middleton has been preaching to his group.

Ocoee opened the night with back-to-back 3s before Alexis Hill answered from the top of the key, settling Wekiva into the fast, physical pace. Both defenses swarmed passing lanes and cut off drives, keeping the first quarter tight. With under a minute left, tension spilled over when players leaped for a loose ball, sparking a brief round of pushing between both sides. Ocoee carried a 12–8 lead into the second.

That's when the game shifted for good.

The Knights' press turned suffocating, creating turnovers. Rushed passes and transition layups helped Ocoee rip off a 10–0 run to force a Mustang timeout. Ocoee took a commanding 26-8 lead into halftime after blanking the Mustangs for the entire frame.

Hill finally broke the drought early in the third, but Ocoee immediately countered with a flurry of 3s — including two from Dakara Merthie — that pushed the lead near 30. Every time Wekiva tried to settle into its sets, the Knights sped up the game, turning miscues into points.

A second-chance finish from Hill gave Wekiva a brief spark, but Ocoee's energy and pace overwhelmed the Mustangs as the Knights closed the third quarter up 46-14.

Bell controlled the tempo with 10 points, five assists and four steals.

Hill and Poole combined for 17 points and 11 boards, giving Wekiva control inside and out.

Wekiva boys basketball gets back on track against Hagerty

Mustangs beat up Huskies to break two-game skid

After dropping two straight to Windermere and undefeated North Marion last weekend, Wekiva needed a response. The Mustangs delivered one Wednesday night against Hagerty (6–3), riding a dominant defensive start and steady scoring from their strong trio to win 61-44 on the road.

Head coach Gersino Lubin said he was pleased with how his team reestablished its identity.

"After losing Friday and Saturday, we lost our identity defensively because we

gave up a lot of points," Lubin said. "I thought tonight we made the defense the primary part of what we do, and I think that was the turning point. Yes, we can shoot, we know what we can do offensively, but if we don't play defense, it almost doesn't matter."

Wekiva controlled the opening eight minutes with suffocating pressure that forced multiple turnovers and limited Hagerty to just four points. He powered the Huskies back into contention almost singlehandedly, hitting shots from inside and out and scoring 16 of the team's 20 first-half points.

Kohn's buzzer-beating 3-pointer cut what was once a double-digit deficit to 32-24 at halftime and gave the Huskies a burst of momentum heading into the locker room. Kohn finished with a game-high 24 points — more than the rest of his team com-

Wekiva quickly snatched the momentum back to start the third. Saint Pierre and Francillon opened the half with mid-range jumpers, and despite a few answers from Hagerty, Wekiva thrived in the chaotic, up-and-down pace the game developed. Loose balls, long rebounds and fast possessions favored the Mustangs, allowing them to extend the margin back to double digits.

Cool weather gets the specks to bitin'

We've been waitin' on some cooler days, and now we have 'em. This latest cool front will get the specks to bitin', and folks're already catchin'em pretty good. The specks're still bitin' real good up at Highlands Fish Camp on the St. Johns River.

The guides are takin' folks out for a day of speck fishin', and they're gettin' 30 to 35 specks each trip. Folks're catchin'em on jigs tipped with a minner, and some folks're catchin'em by usin' brightly colored jigs.

The specks're bitin' in Lake Kissimmee, too. Folks're driftin' open water with minners and doin' re-

ally good. You need to drift with the wind until you locate a bunch of specks and keep driftin" back and forth until they quit bitin'.

Kyle at Bitter's B&T reports that folks're startin' to catch some specks in Lake Monroe and Lake Jesup. You'll have to troll or let the wind push you across the lake. Most of the specks're

bein' caught on bright-colored jigs tipped with a minner. You can fish minners naked, as well.

You may wonder what fishin' a minner naked is. Well, it's when you put your minner on a gold #2 or #4 hook and drift the open water lettin' the minner do its thing. If it's kinda windy, some folks'll put a small split shot on their line just above the hook to keep the minner down. The cool temperatures we've been havin' will cool the water down, and when that happens, the specks'll begin to really bite.

Some folks are startin' to catch some specks in Lake Eustis, too. You need to drift the open water until you find'em, la, eelgrass, and Kissimmee and then keep driftin' over the area until they quit bitin'.

The bass fishin' is still very good at the Headwaters Lake near Melbourne. The guides're takin' folks out, and they're catchin' 30 to 40 bass per trip. Most of the bass're bein' caught on shiners. Some big bass are startin' to show up, as well. One group ran out of shiners, and they started catchin' bass on chatter-baits!

The bass fishin' on West Lake Toho is gettin' better each week. The guides down there are takin' folks out on four-hour trips and doin' really good. Shiners fished around the vegetation such as hydrilgrass will get you a bite.

If the weather keeps gettin' cooler, the bass will start movin' to the shallow water to spawn. They'll be feedin' really good before they go on the beds, so now through spring will be a good time to catch a big bass.

Lake Fairview is still producin' some nice stringers of bass. My buddy who lives in my neighborhood fishes Lake Fairview regularly, and he reports that he and his buddy are still catchin' 20 to 25 bass

It's a little early, but please save this date because on January 28th, 2026, the FWC will be hosting a meeting at The Venetian Center in Leesburg, and it's open to the public. The event will allow the public to view all the projects and interact with the local biologists for the Harris Chain. Sally Benton's Vegetable Medley is delicious (as I can attest)! Sally says she just throws stuff in the pot and is guessing at the amounts, so you should use your own best judgment. Sally graduated



from Apopka Memorial High School in 1968, married and moved to Melbourne and raised a family, still lives there and loves coddling her grandkids even though she still stays busy with a parttime job "at the pharmacy." And, she subscribes to The Apopka Chief newspaper to keep up with her hometown's activities! I personally don't use cooking spray as she does, I simply apply a thin coating of EVOO to inner surface of pot.

The Chalupa Dinner Bowl from Southern Living's 2009 All Time Favorites will be a winner in your house. This is cooked in a slow cooker, and it may take all day... but it will be wonderful at the table.

We have Melinda Stokes Allanson's Greek Chicken Salad for you. It looks wonderfully refreshing and change of pace. This is from our friends in Punta Gorda's book, A Taste of Heaven. A couple of rotisserie chickens would really come in handy with this recipe!

From OceanSpray.com, here is their basic three-ingredient recipe I've used for years. I add two more ingredients to it, but basically it is cranberries, sugar, and water brought to a boil and boiled for 10 minutes. I add a fresh sweet orange sectioned with membranes removed and pecans after the cranberries cook, but that's it. It is very good with the navel orange to sweeten up the tangy cranberries plus the pecans (because I love pecans) to put a little body and crunch to the relish.

I adore Magic Cookie Bars. The recipe is printed on the Aldi company's Baker's Corner Sweetened Condensed Milk can. This is one of those recipes kids (and adults) love that they can do in the kitchen together. Kids are great at making crumbs from graham crackers. And they can measure ingredients. They may need a little help, but it can be fun to do together.

Paths of Sunshine Cookbook provides our dessert recipe, Key Lime Pie. This is wonderful for this time of year. It is beautiful, festive, simple, and delicious. This recipe yields two pies.

SALLY THOMAS BENTON'S **VEGETABLE MEDLEY**

Recipe from Reader of The Apopka Chief newspaper

2 or 3 each zucchini and yellow squash 2 fresh vine-ripe tomatoes, diced... OR... 1 pint of grape tomatoes, whole OR... a can of diced tomatoes 3 slivered garlic cloves Thinly sliced onion Bell pepper Broccoli Cauliflower

2 teaspoons basil 1 teaspoon tarragon

1/3 to 1/2 cup lemon juice

1/2 teaspoon sugar (optional, to awaken the flavor)

1/2 teaspoon salt (to taste) Pam Spray (or other cooking spray)

Any other spices you prefer in addition to or as a replacement for the ones suggested here. For instance, some Mexican spices like cilantro, cumin, chili powder, etc., might be fantastic... OR... Italian spices... OR... Asian

spices such as Oriental 5-spice, soy sauce,

If you like, add whatever YOU enjoy: green beans, edamame, celery, baby raw spinach, mushrooms, and water chestnuts. Get wild with it!

Sliver the garlic, onion, and bell pepper. Spray them lightly with Pam Spray. Spray a frying pan lightly. Heat pan. Sauté. While they are sautéing, cut squash into small chunks. Squash will cook faster than more solid veggies, so if you're adding broccoli or raw cauliflower, thin-slice them as well and toss in at the end of sauteing.

Turn down heat. Add a tablespoon or two of water to deglaze the bottom of pan and to steam the veggies. Add the herbs and any spices you might want. Add a little salt and sugar to taste, if desired. Add lemon juice. Cover with lid. When the steaming veggies are to your desired tenderness, throw in tomatoes. They don't have to cook.

Preparation time is 30 to 45 minutes.
