

## With help of friends, man enjoys 97th birthday with a parade

Retired colonel Dr. Sanford L. Graves of Apopka celebrated his 97th birthday on Saturday, August 29, with family and friends rolling out a birthday caravan in front of his house off Wekiwa Springs Road.

"Indescribable," he said in a phone interview about the celebration. "I don't know how you'd describe anything like that. It was very, very nice to have people recognize you and see friends I hadn't seen for some time."

According to his daughter Candace DeVore, the August 29 drive-through continued non-stop for one hour.

"People of all ages came by to honor Sandy for his military service and his continual service to the community through his profession as a psychologist," she said in an email.

Graves does have a lifelong history being of service to his community on the local, national, and international scale. He served 37 years in the Air Force before retiring in 1979. He earned three college degrees and worked for more than 30 years as a clinical psychologist for the Florida Hospital Psychiatric Center and the Seminole Community Mental Health Center. After that, he was employed 20 years at the counseling ministry he created for For-

est Lake Seventh-day Adventist Church counseling ministry. He retired in 2019.

Graves was born on August 29, 1923, in Nashville, Tenn., where at the time his father, a preacher, was traveling for his ministry. The family then returned to Clearwater, where their church was located.

Growing up fascinated by airplanes, Graves would eventually realize his dream. As a high school senior, he was spurred to join the

military after the 1941 attack on Pearl Harbor but had to wait until he was old enough to do so. Graves graduated from Fletcher Academy in Fletcher, N.C., in 1942.

"There was an enormous flash of patriotism that swept the country, and you almost could not join," he said.

Graves said he faced two of his biggest challenges: becoming a pilot, and then becoming a psychologist later in life.

"I wanted to do that so badly," he said about pursuing an aviation career. "That was a challenge. I guess also at my age it was a challenge to become a doctor of psychology. So those are probably the two biggest challenges I've had."

Once Graves got accepted for flight school to become an aviation cadet, he underwent a year of intense training before joining a wartime unit and flying 65 combat missions over France and Germany.

Graves recorded his experiences as a combat veteran in letters that were sent home to his parents, and then a diary. These writings were used when he penned his book "The Surly Bonds of Earth: A Pilot's Remembrances of a World at War," first published in 2005 as a hardcover then in 2011 as an e-book. His son Sanford Jr. was the book editor.

"The book was written using my dad's

journals and his letters home to his mother, so they're very accurate portrayals of what he went through at that time," DeVore said in a phone interview.

Graves's motivation to transition from the military to psychology came from helping a married couple overcome their issues.

"It had to do with conditions that I ran into in the last part of my service: a young married couple over in Europe with a lot of financial and personal difficulty because they were so far from their home and (had) very little money," Graves said.

"I became quite interested in their problems because they would bring them to me to solve. I decided that I would do something about learning those kinds of things. And I became interested in psychology from that."

After retiring from the military, Graves received his bachelor's degree from Washington Missionary College in the Washington, D.C., area, his master's from the University of Central Florida, and his doctorate from the Florida Institute of Technology at Melbourne.

Graves has been married to his wife Bedi Cruze Graves of Orlando for 73 years. They have three children Candace, Sanford Jr., and Randy, seven grandchildren, eight great-grandchildren, and three great-great-grandchildren.

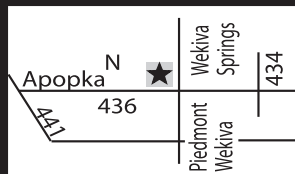

## Specks are bitin' like crazy in Lake Jesup

**Hello Folks,**

I can't believe it, but September is here and that means cooler weather and great fishin' is just around the corner. The fishin' right now isn't too bad and I don't know what's goin' on over in Lake Jesup but the specks are bitin' like crazy again.

Kyle at Bitter's Bait and Tackle reports that the specks started bitin' this week and folks are gettin' buckets of minners and goin' to catch 'em. You need to fish under the State Road 417 bridge with minners and you should be able to catch a limit. The limit in Florida is 25 specks per person. Kyle reports that limits are bein' caught just about each day for the folks that have been goin' over to Lake Jesup.

I asked Kyle why the speck fishin' has been so good over the summer be-

cause it's usually better in the winter. Kyle thinks the specks have been bitin' due to all the rain we have been gettin'. The rain has kept the water cooler this summer, and Lake Jesup is part of the St. Johns River system and clean water has been flowin' through the lake, which helps keep the water cleaner and cooler. I don't know how true his assumption is, but it makes sense to me. Anyway, get a bucket of minners and go catch some specks.

The bluegills and shell-crackers have definitely quit

bitin' for the summer. We had a great summer for pan-fish, but the bite has really died off since earlier this summer. Kyle reports that the red worm and cricket sales have slowed down a lot as of late.

The bass fishin' has been a little slow but if you fish with shiners you should be able to catch 'em. Folks are still freelinin' shiners out the back of the boat in Lake Maitland and the Butler Chain. You need to fish the shiners over the submerged hydrilla and eel-grass beds throughout the chains. You need to get on the water early or go late in the afternoon if the rain doesn't run you off the lakes.

The fishin' on Lake Toho is still an early or late bite. Folks have been catchin' most of their bass around the hydrilla clumps on the south end of the lake. Also check out the flowin' water that's

comin' into the lake from the afternoon rains. Usually you will find some bass hangin' around those types of areas where the water is flowin' into the lake. The bass will be feedin' on bait-fish that's comin' from the canals. Also, look for bass anywhere you see runnin' water that's feedin' into the lakes from runoffs and feeder creeks.

The St. Johns River is a good place to look for those types of areas to catch some bass as well. A noisy top-water bait, lipless crank-baits, and Carolina-rigged plastic worms all work in those areas.

Well, that's it for this week. You have a lot of choices to fish this weekend. I hope you get a chance to do some fishin' real soon. See ya next week.

Tip of the week: specks are bitin'. Save a few and good luck!

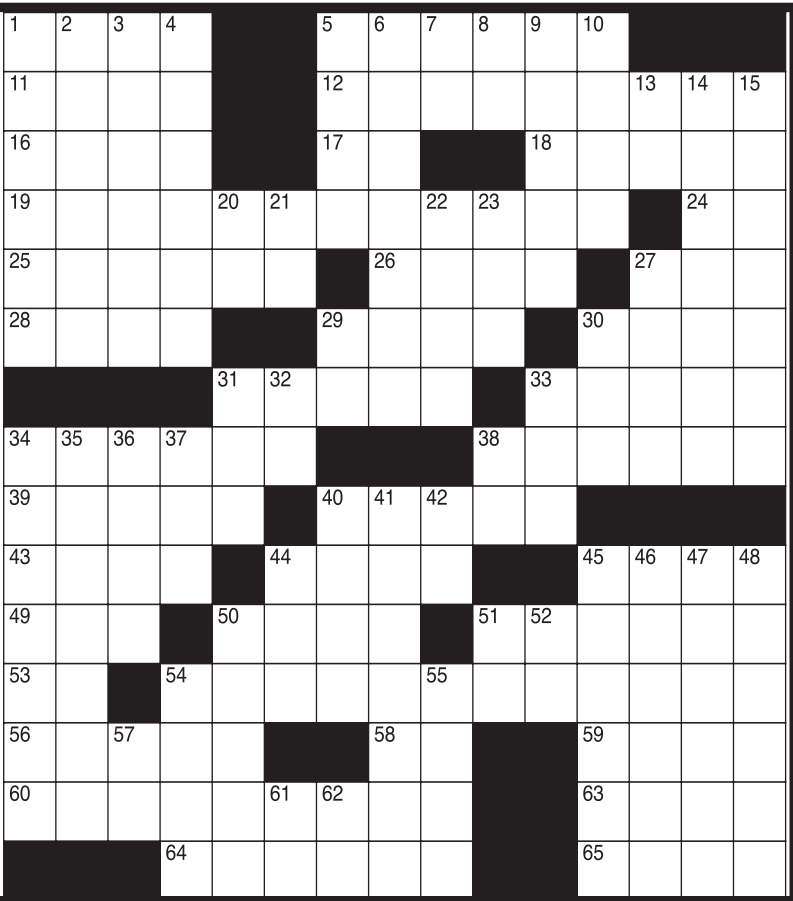

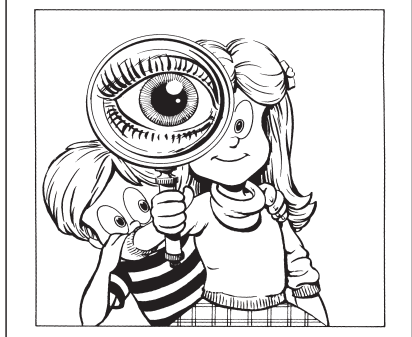

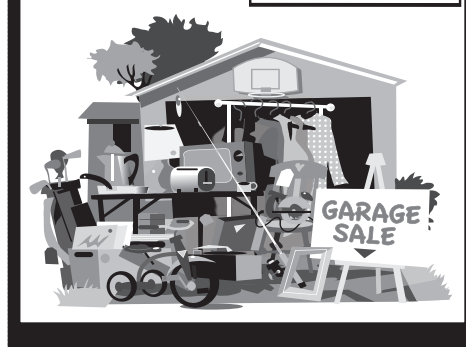
